1	AN ACT
2	relating to electronic voter registration and electronic
3	submission of an application for an early voting ballot by mail.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter A, Chapter 13, Election Code, is
6	amended by adding Section 13.009 to read as follows:
7	Sec. 13.009. ELECTRONIC VOTER REGISTRATION. (a) The
8	secretary of state shall implement a program to allow a person to
9	complete a voter registration application over the Internet from
10	the official website of this state. The websites of the secretary
11	of state and the Department of Public Safety must also provide a
12	link to the location of the application on the official website of
13	this state.
14	(b) An applicant for electronic voter registration who has a
15	driver's license or personal identification card issued in this
16	state, regardless of whether the license or card is unexpired,
17	<u>must:</u>
18	(1) attest to the truth of the information provided on
19	the application by affirmatively accepting the information as true;
20	and
21	(2) affirmatively consent to the use of the signature
22	on the applicant's driver's license or personal identification card
23	for voter registration purposes.
24	(c) An applicant for electronic voter registration who does

1	not have a driver's license or personal identification card issued
2	in this state must:
3	(1) attest to the truth of the information provided on
4	the application by affirmatively accepting the information as true;
5	and
6	(2) print a registration application from the website
7	the applicant is using to register, sign the application, and mail
8	it to the registrar.
9	(d) For each application submitted under Subsection (b),
10	the program must require that a digital copy of the applicant's
11	signature be obtained from the Department of Public Safety.
12	(e) For each application submitted under Subsection (c),
13	the program must provide the applicant with:
14	(1) a registration application that the applicant can
15	print from the registration website, sign, and mail to the
16	registrar as required under Subsection (c)(2); and
17	(2) information about how the applicant can obtain a
18	driver's license or personal identification card from the
19	Department of Public Safety.
20	(f) An application submitted under this section is
21	considered for all purposes an application submitted by mail under
22	this title.
23	(g) The secretary of state shall adopt rules as necessary to
24	implement this section, including rules to provide for additional
25	security measures necessary to ensure the accuracy and integrity of
26	applications submitted electronically.
27	(h) The rules adopted under Subsection (g) must require

1 that:

2 (1) the Internet website through which a person may 3 complete a voter registration application include a description of 4 the offense described by Section 13.007 in a conspicuous location 5 on the website near the place where the person begins or submits the 6 application; and

7 (2) the state electronic Internet portal project be 8 used to authenticate the identity of a person who submits an 9 application electronically under this section.

10 SECTION 2. Sections 84.001(b) and (d), Election Code, are 11 amended to read as follows:

12 (b) An application must be in writing and signed by the 13 applicant. <u>Except as provided by Section 84.0091, an</u> [An] 14 electronic signature is not permitted.

15 (d) An application must be submitted [by mail] to the early 16 voting clerk for the election who serves the election precinct of 17 the applicant's residence.

18 SECTION 3. Section 84.007(a), Election Code, is amended to 19 read as follows:

(a) Except as provided by Sections 84.008, [and] 84.009, and
<u>84.0091</u>, an application for a ballot to be voted by mail must be
submitted as provided by this section.

SECTION 4. Subchapter A, Chapter 84, Election Code, is
 amended by adding Section 84.0091 to read as follows:

25 <u>Sec. 84.0091.</u> SUBMITTING APPLICATION FOR BALLOT VOTED BY 26 MAIL: ELECTRONIC SUBMISSION. The secretary of state shall 27 implement a program to allow a person to complete an application for

an early voting ballot by mail over the Internet from the official 1 2 website of this state. The program must: 3 (1) permit an applicant to electronically sign the 4 application; 5 (2) deliver a completed application to the early 6 voting clerk for the election who serves the election precinct of 7 the applicant's residence; and 8 (3) permit an applicant to check the status of the applicant's application. 9 10 SECTION 5. This Act takes effect on the 91st day after the last day of the legislative session. 11
