A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to making supplemental appropriations relating to border
- 3 security and giving direction regarding those appropriations.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. OFFICE OF COURT ADMINISTRATION, TEXAS JUDICIAL
- 6 COUNCIL. (a) The amount of \$32,486,125 is appropriated from the
- 7 general revenue fund to the Office of Court Administration, Texas
- 8 Judicial Council for the purpose of providing funding for indigent
- 9 legal representation, foreign language interpreters for courts,
- 10 increased staff functions, equipment purchases, and program
- 11 administration costs during the two-year period beginning on the
- 12 effective date of this Act.
- 13 (b) During the two-year period beginning on the effective
- 14 date of this Act, in addition to the number of full-time equivalent
- 15 (FTE) employees other law authorizes the office to employ during
- 16 that period, the Office of Court Administration, Texas Judicial
- 17 Council may employ out of money appropriated by Subsection (a) of
- 18 this section six full-time equivalent (FTE) employees.
- 19 SECTION 2. MILITARY DEPARTMENT. The amount of \$301,007,231
- 20 is appropriated from the general revenue fund to the Military
- 21 Department for the purpose of providing funding for additional
- 22 personnel to support border security operations during the two-year
- 23 period beginning on the effective date of this Act.
- SECTION 3. DEPARTMENT OF PUBLIC SAFETY. (a) The amount of

- 1 \$133,506,725 is appropriated from the general revenue fund to the
- 2 Department of Public Safety for the purpose of providing funding
- 3 for 52 weeks of Operation Lone Star surge costs incurred during the
- 4 two-year period beginning on the effective date of this Act.
- 5 (b) The amount of \$3,411,000 is appropriated from the
- 6 general revenue fund to the Department of Public Safety for the
- 7 purpose of providing funding to purchase tactical marine unit
- 8 vessels during the two-year period beginning on the effective date
- 9 of this Act.
- 10 (c) The amount of \$17,872,349 is appropriated from the
- 11 general revenue fund to the Department of Public Safety for the
- 12 purpose of providing funding for additional full-time equivalent
- 13 (FTE) employees during the two-year period beginning on the
- 14 effective date of this Act.
- 15 (d) During the two-year period beginning on the effective
- 16 date of this Act, in addition to the number of full-time equivalent
- 17 (FTE) employees other law authorizes the department to employ
- 18 during that period, the Department of Public Safety may employ out
- 19 of money appropriated by Subsection (c) of this section 79
- 20 full-time equivalent (FTE) employees.
- 21 SECTION 4. DEPARTMENT OF CRIMINAL JUSTICE. The amount of
- 22 \$273,700,000 is appropriated from the general revenue fund to the
- 23 Department of Criminal Justice for the purpose of providing funding
- 24 for correctional security operations during the two-year period
- 25 beginning on the effective date of this Act.
- SECTION 5. COMMISSION ON JAIL STANDARDS. (a) The amount of
- 27 \$214,785 is appropriated from the general revenue fund to the

- 1 Commission on Jail Standards for the purpose of providing funding
- 2 to pay additional full-time equivalent (FTE) employees, increased
- 3 employee overtime compensation costs, and increased travel
- 4 expenses during the two-year period beginning on the effective date
- 5 of this Act.
- 6 (b) During the two-year period beginning on the effective
- 7 date of this Act, in addition to the number of full-time equivalent
- 8 (FTE) employees other law authorizes the commission to employ
- 9 during that period, the Commission on Jail Standards may employ out
- 10 of money appropriated by Subsection (a) of this section three
- 11 full-time equivalent (FTE) employees.
- 12 SECTION 6. TRUSTEED PROGRAMS WITHIN THE OFFICE OF THE
- 13 GOVERNOR. (a) The amount of \$1,020,290,860 is appropriated from
- 14 the general revenue fund to the Trusteed Programs within the Office
- 15 of the Governor for the purpose of providing funding for border
- 16 security operations through the making of border security grants
- 17 during the two-year period beginning on the effective date of this
- 18 Act.
- 19 (b) The amount of \$3,765,000 is appropriated from the
- 20 general revenue fund to the Trusteed Programs within the Office of
- 21 the Governor for the purpose of providing funding for additional
- 22 full-time equivalent (FTE) employees and for additional training
- 23 regarding the handling of misdemeanor crimes for district and
- 24 county attorneys during the two-year period beginning on the
- 25 effective date of this Act.
- 26 (c) During the two-year period beginning on the effective
- 27 date of this Act, in addition to the number of full-time equivalent

- 1 (FTE) employees other law authorizes the office to employ during
- 2 that period, the Trusteed Programs within the Office of the
- 3 Governor may employ out of money appropriated by Subsection (b) of
- 4 this section 27 full-time equivalent (FTE) employees.
- 5 SECTION 7. DEPARTMENT OF STATE HEALTH SERVICES. (a) The
- 6 amount of \$5,450,976 is appropriated from the general revenue fund
- 7 to the Department of State Health Services for the purpose of
- 8 purchasing two ambulances during the two-year period beginning on
- 9 the effective date of this Act.
- 10 (b) The amount of \$10,901,952 is appropriated from the
- 11 general revenue fund to the Department of State Health Services for
- 12 the purpose of purchasing ambulances for use at two border security
- 13 processing centers during the two-year period beginning on the
- 14 effective date of this Act.
- 15 SECTION 8. EFFECTIVE DATE. This Act takes effect
- 16 immediately.
