Subchapter A, Chapter 408, Labor Code, amended by adding Section 408.009 to read as follows: 6 Sec. 408.009. PRESUMPTION OF COMPENSABILITY FOR INJURY 7 CAUSED BY EMPLOYER-REQUIRED COVID-19 VACCINE. (a) In this 8 section, "COVID-19" means the 2019 novel coronavirus disease. 9 (b) An employee who suffers an injury caused by an adverse 10 reaction to a COVID-19 vaccine resulting in disability or death is 11 presumed to have suffered the injury during the course and scope of 12 employment if the employee was required to receive the vaccine as a 13 14 condition of employment. SECTION 2. Section 409.021(a-3), Labor Code, is amended to

read as follows: (a-3) An insurance carrier is not required to comply with 17 Subsection (a) if the claim results from an employee's disability 18 or death for which a presumption is claimed to be applicable under 19 Section 408.009 of this code or Subchapter B, Chapter 607, 20 Government Code, and, not later than the 15th day after the date on 21 which the insurance carrier received written notice of the injury, 22 23 the insurance carrier has provided the employee and the division with a notice that describes all steps taken by the insurance 2.4

- 1 carrier to investigate the injury before the notice was given and
- 2 the evidence the carrier reasonably believes is necessary to
- 3 complete its investigation of the compensability of the
- 4 injury. The commissioner shall adopt rules as necessary to
- 5 implement this subsection.
- 6 SECTION 3. Section 415.021(c-2), Labor Code, is amended to
- 7 read as follows:
- 8 (c-2) In determining whether to assess an administrative
- 9 penalty involving a claim in which the insurance carrier provided
- 10 notice under Section 409.021(a-3), the commissioner shall consider
- 11 whether:
- 12 (1) the employee cooperated with the insurance
- 13 carrier's investigation of the claim;
- 14 (2) the employee timely authorized access to the
- 15 applicable medical records before the insurance carrier's deadline
- 16 to:
- 17 (A) begin payment of benefits; or
- 18 (B) notify the division and the employee of the
- 19 insurance carrier's refusal to pay benefits; and
- 20 (3) the insurance carrier conducted an investigation
- 21 of the claim, applied the statutory presumptions under <u>Section</u>
- 22 408.009 of this code or Subchapter B, Chapter 607, Government Code,
- 23 and expedited medical benefits under Section 504.055.
- SECTION 4. Section 408.009, Labor Code, as added by this
- 25 Act, applies only to a claim for workers' compensation benefits
- 26 filed on or after the effective date of this Act. A claim filed
- 27 before that date is governed by the law as it existed on the date the

- 1 claim was filed, and the former law is continued in effect for that
- 2 purpose.
- 3 SECTION 5. This Act takes effect immediately if it receives
- 4 a vote of two-thirds of all the members elected to each house, as
- 5 provided by Section 39, Article III, Texas Constitution. If this
- 6 Act does not receive the vote necessary for immediate effect, this
- 7 Act takes effect on the 91st day after the last day of the
- 8 legislative session.
