CONCURRENT RESOLUTION

- 1 WHEREAS, Requiring universal background checks for all
- 2 firearm sales will help keep guns out of the hands of illegal buyers
- 3 and traffickers, without causing an undue burden on law-abiding
- 4 American citizens; and
- 5 WHEREAS, Currently, federal law requires licensed firearm
- 6 dealers to perform background checks on prospective purchasers, but
- 7 it does not require the same of unlicensed sellers; since this
- 8 exception applies broadly to all unlicensed dealers, it has created
- 9 a dangerous and far-reaching loophole that dramatically increases
- 10 the likelihood of gun murders and suicides; and
- 11 WHEREAS, According to the U.S. Department of Justice,
- 12 "individuals prohibited by law from possessing guns can easily
- 13 obtain them from private sellers and do so without any federal
- 14 records of the transactions"; and
- 15 WHEREAS, Properly enforced background checks help to keep
- 16 guns out of dangerous hands; since the adoption of the Brady Handgun
- 17 Violence Prevention Act in 1994, more than three million people
- 18 legally prohibited from possessing a gun--mainly convicted felons,
- 19 domestic abusers, and the severely mentally ill--have been denied a
- 20 firearm transfer or permit; and
- 21 WHEREAS, Far from being a partisan issue, polling data shows
- 22 that more than 90 percent of the American public supports
- 23 background checks for all gun sales; that includes the vast
- 24 majority of Republicans, Democrats, law enforcement groups, and NRA

- 1 members alike; and
- 2 WHEREAS, Background checks impose virtually no burden on
- 3 law-abiding gun purchasers, as results are returned instantly and
- 4 accurately in most circumstances; and
- 5 WHEREAS, By enforcing a universal background check system on
- 6 all gun sales, firearms will only be kept out of the hands of those
- 7 legally prohibited from possessing them, and the United States will
- 8 be a safer place for all Americans; now, therefore, be it
- 9 RESOLVED, That the 87th Legislature of the State of Texas,
- 10 3rd Called Session, hereby respectfully urge the United States
- 11 Congress to pass a federal law requiring universal background
- 12 checks for all firearm sales; and, be it further
- 13 RESOLVED, That the Texas secretary of state forward official
- 14 copies of this resolution to the president of the United States, to
- 15 the president of the Senate and the speaker of the House of
- 16 Representatives of the United States Congress, and to all the
- 17 members of the Texas delegation to Congress with the request that
- 18 this resolution be entered in the Congressional Record as a
- 19 memorial to the Congress of the United States of America.
