CONCURRENT RESOLUTION

1 WHEREAS, Federal law sets the federal minimum wage at \$7.25
2 an hour; and

3 WHEREAS, The last time Congress raised the federal minimum
4 wage was in 2007; that year, the Fair Minimum Wage Act of 2007 was
5 passed to gradually raise the federal minimum wage from \$5.15 an
6 hour to \$7.25 an hour in 2009; the Act included small business tax
7 relief provisions and was signed into law by President George
8 W. Bush; and

9 WHEREAS, Speaking at a 2006 news conference, President Bush
10 said that he supported increasing the federal minimum wage, adding
11 that to achieve this and other goals, Congress needed to put aside
12 partisan differences and work constructively to address the vital
13 issues confronting our nation; and

14 WHEREAS, In the 14 years since President Bush signed the last
15 federal minimum wage increase into law, the desire for Congress to
16 raise the federal minimum wage has grown stronger in the states; and

17 WHEREAS, To account for cost of living increases, 29 states
18 have set their minimum wage higher than the federal minimum wage,
19 though not at the level of a living wage; 14 states, including
20 Texas, have set their minimum wage in line with the federal minimum
21 wage; and

22 WHEREAS, Supporters of a living wage emphasize that
23 increasing the federal minimum wage to \$15 an hour would reduce
24 poverty and grow the economy; their review of previous minimum wage

1 increases found little or no evidence that raising the minimum wage
2 reduces employment; and

3 WHEREAS, Demonstrating that paying workers more reduces
4 turnover, several companies, including Amazon, Walmart, and
5 Target, are now paying many hourly workers at least \$15 an hour; a
6 2017 Quinnipiac University poll found that a majority of Americans
7 would support a minimum wage of \$15 an hour; and

8 WHEREAS, Offering a Texas perspective, noted American
9 economist Dr. James K. Galbraith, a professor at The University of
10 Texas at Austin, wrote that states such as Texas would benefit from
11 raising the federal minimum wage to \$15 an hour because such states
12 have too many low-wage workers, too much poverty, and too many
13 people who are getting food stamps and other welfare because they
14 aren't getting paid enough; and

15 WHEREAS, The well-being of this nation depends on a strong
16 and vibrant economy, and Congress should heed the advice of experts
17 such as Dr. Galbraith and raise the minimum wage; now, therefore,
18 be it

19 RESOLVED, That the 87th Legislature of the State of Texas,
20 3rd Called Session, hereby respectfully urge the Congress of the
21 United States to raise the federal minimum wage to \$15 an hour; and,
22 be it further

23 RESOLVED, That the Texas secretary of state forward official
24 copies of this resolution to the president of the United States, to
25 the president of the Senate and the speaker of the House of
26 Representatives of the United States Congress, and to all the
27 members of the Texas delegation to Congress with the request that

1 this resolution be entered in the Congressional Record as a
2 memorial to the Congress of the United States of America.
