- WHEREAS, Established in 1968, the Santa Rita Award is the
- 5 highest honor bestowed by the UT System Board of Regents; the award
- 6 is given to individuals or organizations whose philanthropy and
- 7 service have greatly furthered the mission of UT institutions and
- 8 the cause of higher education; and
- 9 WHEREAS, Kenny Jastrow is the former chair and CEO of
- 10 Temple-Inland, Inc.; he has served his alma mater, UT Austin,
- 11 through leadership roles on a number of boards, commissions, and
- 12 committees, including as chair of the historic Commission of 125,
- 13 which was created to commemorate the campus's 125th anniversary,
- 14 and as chair of the \$3 billion Campaign for Texas in 2013; he
- 15 recently led the Special Advisory Committee for UT Austin's
- 16 presidential search that resulted in the appointment of President
- 17 Jay Hartzell; and

- 19 such accolades as the Distinguished Alumnus Award, the Presidential

- 24 educator, is the founder of the Nutrition Education Program within
