

R E S O L U T I O N

1           WHEREAS, Command Sergeant Major Charles R. Turbeville of  
2 Copperas Cove is retiring from the Texas State Guard in October  
3 2021, drawing to a close nearly three decades of dedicated service  
4 to his country; and

5           WHEREAS, Charles Turbeville joined the Texas State Guard in  
6 November 2013 and has served at the Camp Mabry headquarters since  
7 2019; he was previously battalion command sergeant major of the 1st  
8 Battalion, 2nd Regiment, and brigade command sergeant major of the  
9 TXSG Medical Brigade; furthermore, he is a former task force  
10 command sergeant major with Operation Lone Star; among his many  
11 awards, he has received three Texas Outstanding Service Medals,  
12 five Texas Medals of Merit, the Superior Unit Citation Ribbon, and  
13 the Texas Faithful Service Medal; and

14           WHEREAS, After enlisting in the U.S. Army in 1975, Command  
15 Sergeant Major Turbeville was assigned to the 4th Battalion, 68th  
16 Armor, 82nd Airborne Division at Fort Bragg, North Carolina; he  
17 went on to serve at duty stations in Alabama, Kentucky, South Korea,  
18 Texas, and Germany, and he provided air traffic control support  
19 during Operation Desert Shield and Operation Desert Storm; his  
20 final assignment was as first sergeant of Headquarters Troop, 3rd  
21 Squadron, 6th Cavalry, 6th Cavalry Brigade, at Fort Hood; he  
22 ultimately retired from federal service in 1995; and

23           WHEREAS, Over the course of his army tenure, Command Sergeant  
24 Major Turbeville was honored with numerous accolades, including

1 three Meritorious Service Medals, two Army Commendation Medals, two  
2 Army Achievement Medals, the National Defense Service Medal, and  
3 the Kuwait Liberation Medal; he holds a bachelor of science degree  
4 from Embry-Riddle Aeronautical University and a master's degree in  
5 education from the University of Phoenix; and

6 WHEREAS, In all his endeavors, Command Sergeant Major  
7 Turbeville enjoys the love and support of his wife, Brenda, his  
8 children, Megan and Adam, and his daughter-in-law, Heather; and

9 WHEREAS, Charles Turbeville's dedication, professionalism,  
10 and devotion to duty have greatly benefited his fellow Americans,  
11 and he may indeed reflect with pride on his outstanding record of  
12 military service as he embarks on the next exciting chapter of his  
13 life; now, therefore, be it

14 RESOLVED, That the House of Representatives of the 87th Texas  
15 Legislature, 3rd Called Session, hereby congratulate Command  
16 Sergeant Major Charles R. Turbeville on his retirement from the  
17 Texas State Guard and extend to him sincere best wishes for the  
18 future; and, be it further
