WHEREAS, Highly engaged in civic life, Mr. Arrington was active in the Republican Party; he was a member of the Canadian City Ocuncil for four years, and he served as mayor of Canadian for six years; moreover, he was appointed to the Governor's Committee on Aging and to the Red River Authority of Texas board, which he further served as president; he also led the Panhandle-Plains Historical Society in Canyon as president; and
