ARTICLE III

1

2 SECTION 1. In this Act, "tract," "block group," and "block" 3 mean the geographic areas identified by those terms on the 2020 4 Census TIGER/Line Shapefiles, prepared by the federal Bureau of the 5 Census for the Twenty-fourth Decennial Census of the United States, 6 enumerated as of April 1, 2020.

7 SECTION 2. It is the intent of the legislature that if any county, tract, block group, block, or other geographic area has 8 9 erroneously been left out of this Act, a court reviewing this Act 10 should include that area in the appropriate district in accordance 11 with the intent of the legislature, using any available evidence of that intent, including evidence such as that used by the Supreme 12 Court of Texas in Smith v. Patterson, 111 Tex. 535, 242 S.W. 749 13 (1922).14

15 SECTION 3. (a) This Act supersedes all previous enactments 16 or orders adopting districts for the State Board of Education. All 17 previous acts of the legislature adopting districts for the State 18 Board of Education are repealed.

(b) Chapter 72 (H.B. 600), Acts of the 82nd Legislature,Regular Session, 2011, is repealed.

SECTION 4. The districts set out in Article II of this Act apply to the election of the members of the State Board of Education beginning with the primary and general elections in 2022 for members of the board in 2023. This Act does not affect the membership or districts of the board before January 1, 2023.

26 SECTION 5. This Act takes effect immediately if it receives 27 a vote of two-thirds of all the members elected to each house, as

1 provided by Section 39, Article III, Texas Constitution. If this 2 Act does not receive the vote necessary for immediate effect, this 3 Act takes effect on the 91st day after the last day of the 4 legislative session.
