## A BILL TO BE ENTITLED

1 AN ACT

2 relating to making appropriations of certain federal coronavirus

3 relief money.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. COMPTROLLER OF PUBLIC ACCOUNTS: UNEMPLOYMENT

6 COMPENSATION FUND. The amount of \$7,245,419,946 is appropriated to

7 the comptroller of public accounts from money received by this

8 state from the Coronavirus State Fiscal Recovery Fund (42 U.S.C.

9 Section 802) established under the American Rescue Plan Act of 2021

10 (Pub. L. No. 117-2) and deposited to the credit of the Coronavirus

11 Relief Fund No. 325 for use during the state fiscal year beginning

12 September 1, 2021, for the purpose of immediately depositing that

13 amount to the credit of the unemployment compensation fund under

14 Section 203.021, Labor Code, to pay back outstanding advances

15 received by this state under Section 1201, Social Security Act (42

16 U.S.C. Section 1321), and to return the unemployment compensation

17 fund to the statutory floor computed under Section 204.061, Labor

18 Code, on October 1, 2021, as reimbursement for payments made as a

19 result of the coronavirus disease pandemic.

20 SECTION 2. DEPARTMENT OF STATE HEALTH SERVICES: COVID-19

21 SERVICES. (a) The amount of \$3,000,000,000 is appropriated to the

22 Department of State Health Services from money received by this

23 state from the Coronavirus State Fiscal Recovery Fund (42 U.S.C.

24 Section 802) established under the American Rescue Plan Act of 2021

- 1 (Pub. L. No. 117-2) and deposited to the credit of the Coronavirus
- 2 Relief Fund No. 325 for the following purposes related to the
- 3 coronavirus disease pandemic during the period beginning on the
- 4 effective date of this Act and ending December 31, 2021:
- 5 (1) providing funding for state and local hospital
- 6 surge staffing;
- 7 (2) purchasing therapeutic drugs; and
- 8 (3) providing funding for the operation of regional
- 9 infusion centers.
- 10 (b) It is the intent of the legislature that any
- 11 reimbursement received by the Department of State Health Services
- 12 from the Federal Emergency Management Agency related to
- 13 expenditures paid from money appropriated under Subsection (a) of
- 14 this section be deposited to the general revenue fund and not
- 15 expended until appropriated by the 88th Legislature.
- 16 Appropriations made under Subsection (a) of this section that
- 17 remain unobligated on January 1, 2022, lapse to the general revenue
- 18 fund.
- 19 SECTION 3. COMPTROLLER OF PUBLIC ACCOUNTS: BROADBAND
- 20 INFRASTRUCTURE. (a) The amount of \$500,475,163 is appropriated to
- 21 the comptroller of public accounts from money received by this
- 22 state from the Coronavirus Capital Projects Fund (42 U.S.C. Section
- 23 804) established under the American Rescue Plan Act of 2021 (Pub. L.
- 24 No. 117-2) and deposited to the credit of the Coronavirus Relief
- 25 Fund No. 325 for the purpose of providing funding for broadband
- 26 infrastructure in accordance with Section 490I.0108, Government
- 27 Code, and other applicable state or federal law during the two-year

- 1 period beginning on the effective date of this Act.
- 2 (b) Out of money appropriated by Subsection (a) of this
- 3 section, \$75,000,000 may be used only for the Texas broadband pole
- 4 replacement program.
- 5 SECTION 4. OFFICE OF THE GOVERNOR: VICTIMS OF CRIME. The
- 6 amount of \$160,000,000 is appropriated to the Office of the
- 7 Governor from money received by this state from the Coronavirus
- 8 State Fiscal Recovery Fund (42 U.S.C. Section 802) established
- 9 under the American Rescue Plan Act of 2021 (Pub. L. No. 117-2) and
- 10 deposited to the credit of the Coronavirus Relief Fund No. 325 for
- 11 the purpose of providing funding for grants for victims of crime
- 12 during the two-year period beginning on the effective date of this
- 13 Act.
- 14 SECTION 5. PUBLIC SAFETY AGENCY SALARY COMPENSATION. (a)
- 15 From money received by this state from the Coronavirus State Fiscal
- 16 Recovery Fund (42 U.S.C. Section 802) established under the
- 17 American Rescue Plan Act of 2021 (Pub. L. No. 117-2) and deposited
- 18 to the credit of the Coronavirus Relief Fund No. 325, the following
- 19 agencies are appropriated the following amounts for the purpose of
- 20 providing compensation for agency employees for the state fiscal
- 21 biennium beginning September 1, 2021:
- 22 (1) Department of Criminal Justice: \$2,729,912,000;
- 23 and
- 24 (2) Department of Public Safety: \$941,836,021.
- 25 (b) The agencies listed in Subsection (a) of this section
- 26 shall:
- 27 (1) in consultation with the comptroller of public

- 1 accounts and the Legislative Budget Board, determine the proper
- 2 allocation of benefits included in the appropriations made under
- 3 Subsection (a) of this section; and
- 4 (2) identify the strategies and objectives for which
- 5 the appropriations made under Subsection (a) of this section are
- 6 directed.
- 7 (c) It is the intent of the legislature that the agencies
- 8 receiving appropriations under Subsection (a) of this section
- 9 consider the appropriations as a change in the method of finance of
- 10 the compensation to be paid to agency employees and not as an
- 11 increase in total appropriations to the agencies.
- 12 SECTION 6. TEACHER RETIREMENT SYSTEM: TRS-CARE AND
- 13 TRS-ACTIVECARE. (a) The amount of \$286,337,761 is appropriated to
- 14 the Teacher Retirement System from money received by this state
- 15 from the Coronavirus State Fiscal Recovery Fund (42 U.S.C. Section
- 16 802) established under the American Rescue Plan Act of 2021 (Pub. L.
- 17 No. 117-2) and deposited to the credit of the Coronavirus Relief
- 18 Fund No. 325 for the purpose of providing funding for
- 19 coronavirus-related claims in TRS-Care and TRS-ActiveCare incurred
- 20 before September 1, 2021, during the two-year period beginning on
- 21 the effective date of this Act.
- (b) It is the intent of the legislature that premiums for
- 23 TRS-Care and TRS-ActiveCare insurance policies not increase as a
- 24 result of coronavirus-related claims incurred before September 1,
- 25 2021.
- 26 SECTION 7. DEPARTMENT OF AGRICULTURE: FOOD BANKS. The
- 27 amount of \$100,000,000 is appropriated to the Department of

- 1 Agriculture from money received by this state from the Coronavirus
- 2 State Fiscal Recovery Fund (42 U.S.C. Section 802) established
- 3 under the American Rescue Plan Act of 2021 (Pub. L. No. 117-2) and
- 4 deposited to the credit of the Coronavirus Relief Fund No. 325 for
- 5 the purpose of providing supplemental funding to food banks in
- 6 response to the coronavirus pandemic during the two-year period
- 7 beginning on the effective date of this Act.
- 8 SECTION 8. HIGHER EDUCATION COORDINATING BOARD: TEXAS CHILD
- 9 MENTAL HEALTH CARE CONSORTIUM. (a) The amount of \$113,082,887 is
- 10 appropriated to the Higher Education Coordinating Board from money
- 11 received by this state from the Coronavirus State Fiscal Recovery
- 12 Fund (42 U.S.C. Section 802) established under the American Rescue
- 13 Plan Act of 2021 (Pub. L. No. 117-2) and deposited to the credit of
- 14 the Coronavirus Relief Fund No. 325 for the purpose of supporting
- 15 the operations and expansion of the Texas Child Mental Health Care
- 16 Consortium to expand mental health initiatives for children during
- 17 the two-year period beginning on the effective date of this Act. At
- 18 the direction of the Texas Child Mental Health Care Consortium, the
- 19 Higher Education Coordinating Board shall transfer appropriations
- 20 through interagency contracts with health-related institutions of
- 21 higher education for the following purposes:
- (1) \$20,578,442 for enhancements and expansion of the
- 23 Child Psychiatry Access Network;
- 24 (2) \$56,218,976 for enhancements and expansion of the
- 25 Texas Child Access Through Telemedicine program;
- 26 (3) \$32,991,791 for expansion of the child and
- 27 adolescent mental health workforce; and

- 1 (4) \$3,293,676 for administrative expenses.
- 2 (b) later than December 1, 2021, out Not 3 appropriated by Subsection (a) of this section, the Higher Education Coordinating Board shall transfer \$3,293,676 to an 4 5 institution of higher education designated by the Texas Child Mental Health Care Consortium for oversight and evaluation of the 6 outlined initiatives by means of interagency agreements or any 7 8 other necessary contracts.
- 9 The Texas Child Mental Health Care Consortium may 10 transfer up to 10 percent of money appropriated for the purposes described by Subsection (a)(1), (2), or (3) of this section to any 11 12 of the other purposes described by those provisions. The Texas Child Mental Health Care Consortium may transfer more than 10 13 14 percent of funds for those purposes only with the prior approval for 15 the transfer and expenditure from the Legislative Budget Board. A request for approval of the transfer and expenditure by the 16 17 consortium is considered approved unless the Legislative Budget Board issues a written disapproval within 10 business days of the 18 19 receipt and review of the request by the Legislative Budget Board.
- SECTION 9. TEXAS DIVISION OF EMERGENCY MANAGEMENT: STATE 20 OPERATIONS CENTER. The amount of \$300,000,000 is appropriated to 21 the Texas Division of Emergency Management from money received by 22 this state from the Coronavirus State Fiscal Recovery Fund (42 23 24 U.S.C. Section 802) established under the American Rescue Plan Act of 2021 (Pub. L. No. 117-2) and deposited to the credit of the 25 26 Coronavirus Relief Fund No. 325 for the purpose of the acquisition 27 of land for, and construction of, a state operations center during

- 1 the two-year period beginning on the effective date of this Act.
- 2 SECTION 10. DEPARTMENT OF INFORMATION RESOURCES:
- 3 CYBERSECURITY PROJECTS. The amount of \$200,000,000 is appropriated
- 4 to the Department of Information Resources for deposit into the
- 5 Technology Improvement and Modernization Fund No. 187 and for use
- 6 during the two-year period beginning on the effective date of this
- 7 Act for the purpose of cybersecurity projects from money received
- 8 by this state from the Coronavirus State Fiscal Recovery Fund (42
- 9 U.S.C. Section 802) established under the American Rescue Plan Act
- 10 of 2021 (Pub. L. No. 117-2) and deposited to the credit of the
- 11 Coronavirus Relief Fund No. 325.
- 12 SECTION 11. HIGHER EDUCATION COORDINATING BOARD:
- 13 UNIVERSITY CONSTRUCTION. Contingent on S.B. \_\_\_ or similar
- 14 legislation by the 87th Legislature, 3rd Called Session, 2021,
- 15 relating to the issuance of tuition revenue bonds, becoming law,
- 16 the amount of \$500,000,000 is appropriated to the Higher Education
- 17 Coordinating Board from money received by this state from the
- 18 Coronavirus State Fiscal Recovery Fund (42 U.S.C. Section 802)
- 19 established under the American Rescue Plan Act of 2021 (Pub. L.
- 20 No. 117-2) and deposited to the credit of the Coronavirus Relief
- 21 Fund No. 325 for the purpose of university construction during the
- 22 two-year period beginning on the effective date of this Act.
- 23 SECTION 12. HEALTH AND HUMAN SERVICES COMMISSION: DALLAS
- 24 STATE HOSPITAL. The amount of \$237,800,000 is appropriated to the
- 25 Health and Human Services Commission from money received by this
- 26 state from the Coronavirus State Fiscal Recovery Fund (42 U.S.C.
- 27 Section 802) established under the American Rescue Plan Act of 2021

- 1 (Pub. L. No. 117-2) and deposited to the credit of the Coronavirus
- 2 Relief Fund No. 325 for the purpose of completing construction of a
- 3 state hospital in Dallas during the two-year period beginning on
- 4 the effective date of this Act.
- 5 SECTION 13. LEGISLATIVE INTENT REGARDING APPROPRIATIONS.
- 6 It is the intent of the legislature that the appropriations made by
- 7 this Act are one-time appropriations made for the purpose of
- 8 addressing the needs of this state for the two-year period
- 9 beginning on the effective date of this Act.
- 10 SECTION 14. APPROPRIATION AUTHORITY UNDER FEDERAL LAW. The
- 11 appropriations made under Sections 4, 7, 8, 9, 10, 11, and 12 of
- 12 this Act using money received by this state from the Coronavirus
- 13 State Fiscal Recovery Fund (42 U.S.C. Section 802) established
- 14 under the American Rescue Plan Act of 2021 (Pub. L. No. 117-2) are
- 15 made in accordance with 42 U.S.C. Section 802(c)(1)(C), which
- 16 allows money from the Coronavirus State Fiscal Recovery Fund to be
- 17 used to provide government services to the extent of a reduction in
- 18 the revenue of a state government caused by the COVID-19 public
- 19 health emergency relative to revenues collected in the most recent
- 20 full fiscal year of the state government that ended before that
- 21 emergency.
- 22 SECTION 15. APPLICABILITY OF TRANSFER PROVISIONS OF OTHER
- 23 LAW. The transfer provisions of Part 14, Article IX, Chapter 1053
- 24 (S.B. 1), Acts of the 87th Legislature, Regular Session, 2021 (the
- 25 General Appropriations Act), and the transfer provisions of Section
- 26 65, Chapter 995 (H.B. 2), Acts of the 87th Legislature, Regular
- 27 Session, 2021 (the Supplemental Appropriations Act), apply to the

- 1 appropriations made by this Act to allow appropriate transfer of
- 2 appropriations made by this Act as if the appropriations made by the
- 3 General Appropriations Act, the Supplemental Appropriations Act,
- 4 and this Act were all a part of the same Act, to the extent permitted
- 5 by federal law.
- 6 SECTION 16. EFFECTIVE DATE. This Act takes effect
- 7 immediately.
