A JOINT RESOLUTION

- 1 proposing a constitutional amendment establishing an independent
- 2 redistricting commission to establish districts for the election of
- 3 the members of the United States House of Representatives elected
- 4 from this state, the Texas Senate, and the Texas House of
- 5 Representatives.
- 6 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Article III, Texas Constitution, is amended by
- 8 adding Section 28a to read as follows:
- 9 <u>Sec. 28a. The independent redistricting commission under</u>
- 10 Article XVIII of this constitution exercises the legislative
- 11 authority of this state to adopt redistricting plans for the
- 12 <u>election of members of the United States House of Representatives</u>
- 13 <u>elected from this state</u>, the Texas House of Representatives, and
- 14 the Texas Senate. Districts for those legislative bodies may not be
- 15 established or changed except as provided by that article.
- SECTION 2. Sections 7a(e) and (i), Article V, Texas
- 17 Constitution, are amended to read as follows:
- 18 (e) Unless the legislature enacts a statewide
- 19 reapportionment of the judicial districts following each federal
- 20 decennial census, the board shall convene not later than the first
- 21 Monday of June of the third year following the year in which the
- 22 federal decennial census is taken to make a statewide
- 23 reapportionment of the districts. The board shall complete its
- 24 work on the reapportionment and file its order with the secretary of

S.J.R. No. 8 1 state not later than August 31 of the same year. If the Judicial Districts Board fails to make a statewide apportionment by that 2 date, the <u>independent redistricting commission</u> [Legislative 3 Redistricting Board established by Article XVIII [III, Section 4 5 $\frac{28_{T}}{1}$ of this constitution shall convene on September 1 of the same year to make a statewide reapportionment of the judicial districts 6 not later than the 90th [150th] day after the final day for the 7 Judicial Districts Board to make the reapportionment. 8 9 The legislature, the Judicial Districts Board, or the independent redistricting commission [Legislative Redistricting 10 Board | may not redistrict the judicial districts to provide for any 11 judicial district smaller in size than an entire county except as 12 provided by this section. Judicial districts smaller in size than 13 14 the entire county may be created subsequent to a general election 15 where a majority of the persons voting on the proposition adopt the proposition "to allow the division of _____ County into 16 17 judicial districts composed of parts of _____ County." No redistricting plan may be proposed or adopted by the legislature, 18 19 the Judicial Districts Board, or the <u>independent redistricting</u> commission [Legislative Redistricting Board] in anticipation of a 20 future action by the voters of any county. 21 SECTION 3. The Texas Constitution is amended by adding 22 Article XVIII to read as follows: 23 24 ARTICLE XVIII. INDEPENDENT REDISTRICTING COMMISSION

SUBCHAPTER A. GENERAL PROVISIONS

(1) "Commission" means the independent redistricting

15	SUBCHAPTER B. COMMISSION
16	PART 1. APPOINTMENT OF MEMBERS
17	Sec. 2. APPOINTMENT. (a) The nonpartisan agency shall
18	establish an independent redistricting commission for this state
19	consisting of 15 members appointed under this section.
20	(b) Not later than October 1 of a year ending in the numeral
21	zero, the nonpartisan agency shall, at a public meeting held at
22	least 15 days after notice of the meeting is given to the public,
23	appoint the following six commission members:
24	(1) two members chosen at random from the majority
25	category of the selection pool;

(2) two members chosen at random from the minority

- 1 (3) two members chosen at random from the independent
- 2 category of the selection pool.
- 3 (c) Not later than November 15 of a year ending in the
- 4 numeral zero, the commission members appointed under Subsection (b)
- 5 of this section shall, at a public meeting held at least 15 days
- 6 after notice of the meeting is given to the public, appoint the
- 7 following nine commission members:
- 8 <u>(1) three members selected from the majority category</u>
- 9 of the selection pool;
- 10 (2) three members selected from the minority category
- 11 of the selection pool; and
- 12 (3) three members selected from the independent
- 13 category of the selection pool.
- 14 Sec. 3. RULES FOR APPOINTMENT OF CERTAIN MEMBERS. (a) The
- 15 appointment of a commission member under Section 2(c) or 5(b) of
- 16 this article and the selection of an alternate member under Section
- 17 4(b) of this article requires the affirmative vote of at least four
- 18 of the members appointed under Section 2(b) of this article,
- 19 including at least one member chosen from each category of the
- 20 selection pool.
- 21 (b) In appointing commission members under Section 2(c) or
- 22 5(b) of this article and selecting alternate members under Section
- 23 4(b) of this article, the commission members appointed under
- 24 Section 2(b) of this article shall ensure that the membership of the
- 25 commission:
- 26 (1) is representative of the demographic groups,
- 27 including racial, ethnic, economic, and gender groups, and

- 1 geographic regions of this state; and
- 2 (2) provides racial, ethnic, and language minorities
- 3 protected under the Voting Rights Act of 1965 (52 U.S.C. Section
- 4 10301 et seq.) with a meaningful opportunity to participate in the
- 5 development of this state's redistricting plans.
- 6 Sec. 4. DESIGNATION OF ALTERNATE MEMBERS. (a) When the
- 7 nonpartisan agency appoints commission members under Section 2(b)
- 8 of this article, the agency shall choose at random two other
- 9 <u>individuals from each category of the selection pool to serve as</u>
- 10 <u>alternate members</u>.
- 11 (b) When the commission members appointed under Section
- 12 2(b) of this article appoint the remaining commission members under
- 13 Section 2(c) of this article, the members appointed under Section
- 14 2(b) shall select two other individuals from each category of the
- 15 <u>selection pool to serve as alternate members.</u>
- 16 Sec. 5. APPOINTMENT OF ALTERNATE MEMBERS TO FILL VACANCIES.
- 17 (a) If a commission member appointed under Section 2(b) of this
- 18 article vacates the member's position, the nonpartisan agency shall
- 19 choose at random one of the alternate members under Section 4(a) of
- 20 this article to fill the vacancy from the same category of the
- 21 <u>selection pool as the vacating member. The agency shall also choose</u>
- 22 at random another individual from the same category of the
- 23 <u>selection pool to replace the alternate member.</u>
- (b) If a member appointed under Section 2(c) of this article
- 25 vacates the member's position, the members appointed under Section
- 26 2(b) of this article shall select one of the alternate members under
- 27 Section 4(b) of this article to fill the vacancy from the same

- 1 category of the selection pool as the vacating member. The members
- 2 appointed under Section 2(b) shall also select another individual
- 3 from the same category of the selection pool to replace the
- 4 alternate member.
- 5 Sec. 6. REMOVAL OF COMMISSION MEMBER. A commission member
- 6 may be removed by a majority vote of the remaining commission
- 7 members if it is shown by a preponderance of the evidence that the
- 8 person is not eligible to serve on the commission under Part 1,
- 9 Subchapter C, of this article.
- 10 PART 2. PROCEDURES FOR CONDUCTING COMMISSION BUSINESS
- 11 Sec. 7. CHAIR. The commission members shall select by
- 12 majority vote one member who was appointed from the independent
- 13 category of the selection pool to serve as chair of the commission.
- 14 The commission may not take any action to develop a redistricting
- 15 plan for this state under Subchapter D of this article before the
- 16 appointment of the chair.
- 17 Sec. 8. VOTE REQUIRED FOR CERTAIN ACTIONS. The commission
- 18 may not publish and disseminate any draft or final redistricting
- 19 plan, or take any other action, without the approval of at least:
- 20 (1) a majority of the members of the commission; and
- 21 (2) one commission member from each category of the
- 22 selection pool.
- Sec. 9. QUORUM. A majority of the members of the commission
- 24 constitutes a quorum.
- 25 PART 3. STAFF; CONTRACTORS
- Sec. 10. COMMISSION STAFF. The commission shall appoint
- 27 and set the pay of technical experts, legal counsel, consultants,

- 1 and other staff the commission considers appropriate, subject to
- 2 general law. The application process must be public and all
- 3 application materials must be made available for public inspection.
- 4 Sec. 11. CONTRACTORS. The commission may enter into
- 5 contracts with vendors as the commission considers appropriate,
- 6 subject to general law. A contract must be approved by a majority
- 7 vote of the commission members, including at least one member from
- 8 each category of the selection pool.
- 9 Sec. 12. REPORTS REGARDING POLITICAL EXPENDITURES. (a)
- 10 Each individual who applies for a position as an employee of the
- 11 commission and each vendor who applies for a contract with the
- 12 commission shall, at the time of application, file with the
- 13 commission a report summarizing:
- 14 (1) any expenditure for political activity made by the
- 15 individual or vendor during the 10 most recent calendar years; and
- 16 (2) any income received by the individual or vendor
- 17 during the 10 most recent calendar years that is attributable to an
- 18 expenditure for political activity.
- 19 (b) Each employee or vendor of the commission shall, not
- 20 later than the first anniversary of becoming an employee or vendor,
- 21 file with the commission a report summarizing the expenditures and
- 22 income described by Subsection (a) of this section during the 10
- 23 most recent calendar years. The employee or vendor shall file a
- 24 subsequent report for each year during any part of which the person
- 25 serves as an employee or a vendor.
- 26 <u>(c) In this section, "expenditure for political activity"</u>
- 27 means a disbursement for:

- 1 (1) an independent expenditure, as defined by Section
- 2 301(17) of the Federal Election Campaign Act of 1971 (52 U.S.C.
- 3 Section 30101(17));
- 4 (2) an electioneering communication, as defined by
- 5 Section 304(f)(3) of the Federal Election Campaign Act of 1971 (52
- 6 U.S.C. Section 30104(f)(3)), or any other public communication, as
- 7 defined by Section 301(22) of that Act (52 U.S.C. Section
- 8 30101(22)), that would be an electioneering communication if it
- 9 were a broadcast, cable, or satellite communication; or
- 10 (3) any dues or other payments to a trade association
- 11 or organization exempt from tax under Section 501(a) of the
- 12 Internal Revenue Code of 1986 by reason of being listed under
- 13 Section 501(c) of that code that are, or could reasonably be
- 14 anticipated to be, used or transferred to another association or
- organization for a use described by Section 501(c)(1), (2), or (3)
- 16 of that code.
- 17 Sec. 13. GOAL OF IMPARTIALITY. The commission shall take
- 18 appropriate steps to ensure that any staff appointed under this
- 19 part and any vendor with whom the commission enters into a contract
- 20 under this part will work in an impartial manner. The commission
- 21 may require an applicant for a staff position or contract to provide
- 22 information on the person's history of political activity beyond
- 23 the information required in the reports under Section 12 of this
- 24 article, including donations to candidates, political committees,
- 25 and political parties.
- Sec. 14. DISQUALIFICATION; WAIVER. (a) The commission may
- 27 not appoint an individual as an employee or enter into a contract

- 1 with a vendor if the individual or vendor would be disqualified from
- 2 serving as a commission member under Section 18 of this article.
- 3 (b) The commission may by unanimous vote of its members
- 4 waive the application of Subsection (a) of this section to an
- 5 individual or a vendor after receiving and reviewing the person's
- 6 report under Section 12 of this article.
- 7 PART 4. TERMINATION OF COMMISSION
- 8 Sec. 15. TERMINATION. The terms of commission members
- 9 expire on the earlier of:
- 10 (1) June 14 of the year ending in the numeral zero
- 11 following appointment; or
- 12 (2) the day on which the nonpartisan agency submits a
- 13 selection pool to the select committee under Section 21 of this
- 14 article.
- Sec. 16. PRESERVATION OF RECORDS. The legislature shall
- 16 ensure that the records of the commission are retained in an
- 17 appropriate state archive that allows this state to respond to any
- 18 civil action brought with respect to congressional redistricting in
- 19 this state.
- 20 SUBCHAPTER C. ESTABLISHMENT OF SELECTION POOL
- 21 PART 1. CRITERIA FOR ELIGIBILITY
- Sec. 17. ELIGIBILITY. An individual is eligible to serve as
- 23 a commission member if:
- 24 (1) on the date of appointment, the individual is
- 25 registered to vote in elections for federal office held in this
- 26 state;
- 27 (2) during the three years preceding the date of

- 1 appointment, the individual has been a member of only one political
- 2 party or has not been a member of any political party; and
- 3 (3) the individual submits to the nonpartisan agency,
- 4 at a time and in a form required by the agency, an application for
- 5 inclusion in the selection pool under this subchapter and includes
- 6 with the application a written statement, with an attestation under
- 7 penalty of perjury, containing the following information and
- 8 assurances:
- 9 (A) the individual's full current name, all of
- 10 the individual's former names, and the individual's contact
- 11 information including electronic mail address, residence address,
- 12 mailing address, and telephone numbers;
- 13 (B) the individual's race, ethnicity, gender,
- 14 age, date of birth, and household income for the most recent taxable
- 15 <u>year;</u>
- 16 (C) the political party with which the individual
- 17 is affiliated, if any;
- (D) the reasons the individual desires to serve
- 19 as a member of the commission, the individual's qualifications, and
- 20 information relevant to the individual's ability to be fair and
- 21 <u>impartial including:</u>
- (i) any involvement with, or financial
- 23 support of, a professional, social, political, religious, or
- 24 community organization or cause; and
- 25 (ii) the individual's employment and
- 26 educational history;
- 27 (E) an assurance that the individual will commit

- 1 to carrying out the individual's duties under this article in an
- 2 honest, independent, and impartial fashion and upholding public
- 3 confidence in the integrity of the redistricting process; and
- 4 (F) an assurance that, during the covered periods
- 5 described by Section 19 of this article, the individual has not
- 6 taken and will not take any action that would disqualify the
- 7 <u>individual from serving as a commission member under Section 18 of</u>
- 8 this article.
- 9 Sec. 18. DISQUALIFICATIONS. An individual is not eligible
- 10 to serve as a commission member if, during any of the covered
- 11 periods described by Section 19 of this article:
- 12 (1) the individual or, in the case of the covered
- 13 periods described by Sections 19(1) and (2) of this article, an
- 14 immediate family member of the individual holds public office or is
- 15 <u>a candidate for election to public office;</u>
- 16 (2) the individual or, in the case of the covered
- 17 periods described by Sections 19(1) and (2) of this article, an
- 18 immediate family member of the individual, serves as an officer of a
- 19 political party or as an officer, employee, or paid consultant of a
- 20 campaign committee of a candidate for public office or of any
- 21 political action committee, as determined under general law;
- 22 (3) the individual or, in the case of the covered
- 23 periods described by Sections 19(1) and (2) of this article, an
- 24 immediate family member of the individual, holds a position as a
- 25 registered lobbyist under the Lobbying Disclosure Act of 1995 (2
- 26 U.S.C. Section 1601 et seq.) or an equivalent state or local law;
- 27 (4) the individual or, in the case of the covered

- 1 periods described by Sections 19(1) and (2) of this article, an
- 2 immediate family member of the individual, is an employee of an
- 3 elected public official, a contractor with this state, or a donor to
- 4 the campaign of any candidate for public office or to any political
- 5 action committee, other than a donor who, during any of the covered
- 6 periods, gives an aggregate amount of \$1,000 or less to the
- 7 campaigns of all candidates for all public offices and to all
- 8 political action committees;
- 9 (5) the individual paid a civil penalty or criminal
- 10 fine or was sentenced to a term of imprisonment for violating any
- 11 provision of the Federal Election Campaign Act of 1971 (52 U.S.C.
- 12 Section 30101 et seq.); or
- 13 (6) the individual or, in the case of the covered
- 14 periods described by Sections 19(1) and (2) of this article, an
- 15 <u>immediate family member of the individual, is an agent of a foreign</u>
- 16 principal under the Foreign Agents Registration Act of 1938 (22
- 17 U.S.C. Section 611 et seq.).
- 18 Sec. 19. COVERED PERIODS. In this part, "covered period"
- 19 means, with respect to the appointment of a commission member:
- 20 (1) the 10-year period preceding the date of the
- 21 member's appointment;
- (2) the period beginning on the date of the
- 23 individual's appointment and ending on August 14 of the next year
- 24 ending in the numeral one; and
- 25 (3) the 10-year period beginning on the day after the
- 26 last day of the period described by Subdivision (2) of this section.
- Sec. 20. IMMEDIATE FAMILY MEMBER. In this part, "immediate

- 1 family member" means, with respect to an individual, a father,
- 2 stepfather, mother, stepmother, son, stepson, daughter,
- 3 stepdaughter, brother, stepbrother, sister, stepsister, husband,
- 4 wife, father-in-law, or mother-in-law.
- 5 PART 2. DEVELOPMENT AND SUBMISSION OF SELECTION POOL
- 6 Sec. 21. SELECTION POOL. Not later than June 15 of each
- 7 year ending in the numeral zero, the nonpartisan agency shall
- 8 develop and submit to the select committee a selection pool of 36
- 9 individuals who are eligible to serve as commission members. The
- 10 selection pool must include:
- 11 (1) a majority category with 12 individuals who are
- 12 affiliated with the political party whose candidate received the
- 13 most votes in the most recent statewide election for federal office
- 14 held in this state;
- 15 (2) a minority category with 12 individuals who are
- 16 affiliated with the political party whose candidate received the
- 17 second most votes in the most recent statewide election for federal
- 18 office held in this state; and
- 19 (3) an independent category with 12 individuals who
- 20 are not affiliated with either political party described by
- 21 Subdivisions (1) and (2) of this section.
- 22 <u>Sec. 22. FACTORS CONSIDERED IN DEVELOPING POOL. In</u>
- 23 selecting individuals for the selection pool under this part, the
- 24 nonpartisan agency shall:
- 25 (1) ensure that the pool:
- 26 (A) is representative of the demographic groups,
- 27 including racial, ethnic, economic, and gender groups, and

- 1 geographic regions of this state; and
- 2 (B) includes applicants who would allow racial,
- 3 ethnic, and language minorities protected under the Voting Rights
- 4 Act of 1965 (52 U.S.C. Section 10301 et seq.) a meaningful
- 5 opportunity to participate in the development of this state's
- 6 redistricting plans; and
- 7 (2) take into consideration the analytical skills of
- 8 the individuals selected in relevant fields, including mapping,
- 9 data management, law, community outreach, demography, and the
- 10 geography of this state, and their ability to work on an impartial
- 11 basis.
- 12 Sec. 23. INTERVIEWS OF APPLICANTS. To assist the
- 13 nonpartisan agency in developing the selection pool under this
- 14 part, the nonpartisan agency shall conduct interviews of applicants
- 15 under oath. If an individual is included in a selection pool
- 16 developed under this subchapter, all of the interviews of the
- 17 individual shall be transcribed and the transcriptions made
- 18 available on the nonpartisan agency's public Internet website at
- 19 the same time the report under Section 26 of this article is
- 20 released.
- 21 Sec. 24. POLITICAL PARTY AFFILIATION OF SELECTION POOL
- 22 MEMBERS. For purposes of this subchapter, an individual is
- 23 considered to be affiliated with a political party only if the
- 24 nonpartisan agency is able to verify, to the greatest extent
- 25 possible, the information the individual provides in the
- 26 application submitted under Section 17(3) of this article,
- 27 including by considering additional information provided by other

- 1 persons with knowledge of the individual's history of political
- 2 activity.
- 3 Sec. 25. ENCOURAGING APPLICATIONS FOR POOL. The
- 4 nonpartisan agency shall take steps necessary to ensure that
- 5 residents of the state across various geographic regions and
- 6 demographic groups are aware of the opportunity to serve as
- 7 commission members, including publicizing the role of the
- 8 commission and using newspapers, broadcast media, online sources,
- 9 and ethnic media, to encourage individuals to apply for inclusion
- 10 in the selection pool developed under this part.
- 11 Sec. 26. REPORT ON ESTABLISHMENT OF POOL. At the time the
- 12 nonpartisan agency submits the selection pool to the select
- 13 committee under Section 21 of this article, the nonpartisan agency
- 14 shall publish and post on the agency's public Internet website a
- 15 report describing the process by which the pool was developed,
- 16 including a description of how the individuals in the pool meet the
- 17 eligibility criteria of Part 1 of this subchapter and how the pool
- 18 reflects the factors the agency is required to take into
- 19 consideration under Section 22 of this article.
- Sec. 27. PUBLIC COMMENT ON POOL. During the 14 days after
- 21 the nonpartisan agency publishes the report under Section 26 of
- 22 this article, the agency shall accept comments from the public on
- 23 the individuals included in the selection pool. The agency shall
- 24 post all comments on the agency's public Internet website as soon as
- 25 practicable after receipt and shall transmit them to the select
- 26 committee at the end of the comment period.
- Sec. 28. ACTION BY SELECT COMMITTEE. (a) The select

- 1 committee shall, 15 to 21 days after receiving the selection pool
- 2 from the nonpartisan agency under Section 21 of this article:
- 3 (1) approve the pool as submitted by the nonpartisan
- 4 agency, in which case the pool becomes the approved selection pool
- 5 for purposes of Section 2 of this article; or
- 6 (2) reject the pool, in which case the nonpartisan
- 7 agency shall develop and submit a new selection pool as provided by
- 8 Part 3 of this subchapter.
- 9 (b) If the select committee fails to approve or reject the
- 10 pool by the deadline provided by Subsection (a) of this section, the
- 11 pool is considered rejected under Subsection (a)(2) of this
- 12 section.

PART 3. REPLACEMENT SELECTION POOL

- Sec. 29. REPLACEMENT POOL. If the select committee rejects
- 15 the selection pool submitted by the nonpartisan agency under Part 2
- of this subchapter, the nonpartisan agency shall, not later than 14
- 17 days after the rejection, develop and submit to the select
- 18 committee a replacement selection pool in the same manner provided
- 19 for the development and submission of the selection pool under
- 20 Sections 21 through 27 of this article. The replacement pool
- 21 submitted under this section may include individuals who were
- 22 included in the rejected selection pool submitted under Part 2 of
- 23 this subchapter if at least one individual in the replacement pool
- 24 was not included in the rejected pool.
- Sec. 30. ACTION BY SELECT COMMITTEE. (a) Not later than 21
- 26 days after receiving the replacement selection pool from the
- 27 nonpartisan agency under Section 29 of this article, the select

- 1 committee shall:
- 2 (1) approve the pool as submitted by the nonpartisan
- 3 agency, in which case the pool becomes the approved selection pool
- 4 for purposes of Section 2 of this article; or
- 5 (2) reject the pool, in which case the nonpartisan
- 6 agency shall develop and submit a second replacement selection pool
- 7 <u>as provided by Part 4 of this subchapter.</u>
- 8 (b) If the select committee fails to approve or reject the
- 9 pool by the deadline provided by Subsection (a) of this section, the
- 10 pool is considered rejected under Subsection (a)(2) of this
- 11 section.

PART 4. SECOND REPLACEMENT SELECTION POOL

- Sec. 31. SECOND REPLACEMENT POOL. If the select committee
- 14 rejects the replacement selection pool submitted by the nonpartisan
- 15 agency under Part 3 of this subchapter, the nonpartisan agency
- 16 shall, not later than 14 days after the rejection, develop and
- 17 submit to the select committee a second replacement selection pool,
- 18 in the same manner provided for the development and submission of
- 19 the selection pool under Sections 21 through 27 of this article.
- 20 The second replacement selection pool submitted under this section
- 21 may include individuals who were included in the rejected selection
- 22 pool under Part 2 of this subchapter or the rejected replacement
- 23 <u>selection pool under Part 3 of this subchapter if at least one</u>
- 24 individual in the second replacement pool was not included in
- 25 either rejected pool.
- Sec. 32. ACTION BY SELECT COMMITTEE. (a) On the 14th or
- 27 15th day after receiving the second replacement selection pool from

- 1 the nonpartisan agency under Section 31 of this article, the select
- 2 committee shall:
- 3 (1) approve the pool as submitted by the nonpartisan
- 4 agency, in which case the pool becomes the approved selection pool
- 5 for purposes of Section 2 of this article; or
- 6 (2) reject the pool.
- 7 (b) If the select committee fails to approve or reject the
- 8 pool by the deadline provided by Subsection (a) of this section, the

- 27 (4) one <u>member of the house of representatives</u>

- 1 appointed by the most senior member of the house who belongs to the
- 2 political party with the second greatest number of members in the
- 3 house.
- 4 Sec. 63. DEADLINE. The legislature shall meet the
- 5 requirements of this part not later than January 15 of each year
- 6 ending in the numeral zero.
- 7 SECTION 4. Section 28, Article III, Texas Constitution, is
- 8 repealed.
- 9 SECTION 5. The following temporary provision is added to
- 10 the Texas Constitution:
- 11 TEMPORARY PROVISION. (a) This temporary provision applies
- 12 to the constitutional amendment proposed by the 87th Legislature,
- 13 3rd Called Session, 2021, establishing an independent
- 14 redistricting commission to establish districts for the election of
- 15 the members of the United States House of Representatives elected
- 16 from this state, the Texas Senate, and the Texas House of
- 17 Representatives.
- 18 (b) On January 1, 2029:
- 19 (1) the amendments to Sections 7a(e) and (i), Article
- 20 V, of this constitution take effect;
- 21 (2) the repeal of Section 28, Article III, of this
