- 2 (1) Strike SECTION 1 of the bill (page 1, lines 6-10), and
- 3 substitute the following:
- 4 SECTION 1. (a) Section 12.052, Utilities Code, is amended
- 5 to read as follows:
- 6 Sec. 12.052. PRESIDING OFFICER. The commissioners shall
- 7 elect one commissioner [(a) The governor shall designate a
- 8 commissioner] as the presiding officer.
- 9 [(b) The presiding officer serves in that capacity at the
- 10 pleasure of the governor.]
- 11 (b) This section takes effect September 1, 2021.
- 12 (2) Add the following appropriately numbered SECTIONS to
- 13 the bill and renumber subsequent SECTIONS of the bill accordingly:
- 14 SECTION ____. (a) The heading to Subchapter B, Chapter 12,
- 15 Utilities Code, is amended to read as follows:
- 16 SUBCHAPTER B. COMMISSION <u>ELECTION</u> [APPOINTMENT] AND FUNCTIONS
- 17 (b) This section takes effect September 1, 2021.
- 18 SECTION _____. (a) Section 12.051, Utilities Code, is
- 19 amended to read as follows:
- Sec. 12.051. ELECTION [APPOINTMENT]; TERM. (a) The
- 21 commission is composed of five [three] commissioners elected to
- 22 numbered positions at the general election for state officers
- 23 [appointed by the governor with the advice and consent of the
- 24 senate].
- 25 (b) [An appointment to the commission shall be made without
- 26 regard to the race, color, disability, sex, religion, age, or
- 27 national origin of the appointee.
- 28 [(c)] Commissioners serve staggered, six-year terms.
- 29 (b) This section takes effect September 1, 2021.

- 1 SECTION _____. (a) Section 12.053, Utilities Code, is
- 2 amended to read as follows:
- 3 Sec. 12.053. MEMBERSHIP QUALIFICATIONS. (a) To be
- 4 eligible for <u>election or</u> appointment, a <u>person</u> [commissioner] must:
- 5 (1) be a qualified voter; and
- 6 (2) be a citizen of the United States[+
- 7 [(3) be a competent and experienced administrator;
- 8 [(4) be well informed and qualified in the field of
- 9 public utilities and utility regulation; and
- 10 [(5) have at least five years of experience in the
- 11 administration of business or government or as a practicing
- 12 attorney or certified public accountant].
- 13 (b) A person is not eligible for <u>election or</u> appointment <u>to</u>
- 14 <u>a commissioner's office</u> [as a commissioner] if the person:
- 15 (1) at any time during the two years preceding the date
- 16 of the person's election or the date of the person's appointment:
- 17 (A) personally served as an officer, director,
- 18 owner, employee, partner, or legal representative of a public
- 19 utility regulated by the commission or of an affiliate or direct
- 20 competitor of a public utility regulated by the commission; or
- 21 (B) owned or controlled, directly or indirectly,
- 22 more than a 10 percent interest in a public utility regulated by the
- 23 commission or in an affiliate or direct competitor of a public
- 24 utility regulated by the commission; or
- 25 (2) is not qualified to serve under Section 12.151,
- 26 12.152, or 12.153.
- 27 (b) This section takes effect September 1, 2021.
- 28 SECTION ____. (a) Section 12.054(a), Utilities Code, is
- 29 amended to read as follows:
- 30 (a) It is a ground for removal from the commission if a
- 31 commissioner:

- 1 (1) does not have at the time of <u>election or</u>
- 2 appointment or <u>does not</u> maintain during service on the commission
- 3 the qualifications required by Section 12.053;
- 4 (2) violates a prohibition provided by Section 12.053
- 5 or by Subchapter D;
- 6 (3) cannot discharge the commissioner's duties for a
- 7 substantial part of the term for which the commissioner is elected
- 8 or appointed because of illness or disability; or
- 9 (4) is absent from more than half of the regularly
- 10 scheduled commission meetings that the commissioner is eligible to
- 11 attend during a calendar year unless the absence is excused by
- 12 majority vote of the commission.
- 13 (b) This section takes effect September 1, 2021.
- 14 SECTION _____. (a) Section 12.055, Utilities Code, is
- 15 amended to read as follows:
- 16 Sec. 12.055. PROHIBITION ON SEEKING ANOTHER OFFICE. A
- 17 person may not seek nomination or election to another civil office
- 18 of this state or of the United States while serving as a
- 19 commissioner. If a commissioner files for nomination or election
- 20 to another civil office of this state or of the United States, the
- 21 person's office as commissioner immediately becomes vacant, and the
- 22 governor shall order a special election or appoint a successor as
- 23 provided by Section 12.056.
- 24 (b) This section takes effect September 1, 2021.
- 25 SECTION ____. (a) Section 12.056, Utilities Code, is
- 26 amended to read as follows:
- Sec. 12.056. [EFFECT OF] VACANCY. (a) A vacancy or
- 28 disqualification does not prevent \underline{a} [the] remaining commissioner
- 29 [er commissioners] from exercising the powers of the commission.
- 30 (b) If the office of a commissioner becomes vacant and more
- 31 than one year remains in the term of the office vacated, the

- 1 governor shall order a special election in which a successor shall
- 2 <u>be elected.</u>
- 3 (c) If the office of a commissioner becomes vacant and less
- 4 than one year remains in the term of the office vacated, the
- 5 governor shall appoint a successor to serve for the unexpired term.
- 6 (b) This section takes effect September 1, 2021.
- 7 SECTION _____. (a) Section 12.059, Utilities Code, is
- 8 amended to read as follows:
- 9 Sec. 12.059. TRAINING PROGRAM FOR COMMISSIONERS. (a)
- 10 Before a commissioner may assume the commissioner's duties [and
- 11 before the commissioner may be confirmed by the senate], the
- 12 commissioner must complete at least one course of the training
- 13 program established under this section.
- (b) A training program established under this section shall
- 15 provide information to the commissioner regarding:
- 16 (1) the enabling legislation that created the
- 17 commission and its policymaking body to which the commissioner is
- 18 elected or appointed to serve;
- 19 (2) the programs operated by the commission;
- 20 (3) the role and functions of the commission;
- 21 (4) the rules of the commission with an emphasis on the
- 22 rules that relate to disciplinary and investigatory authority;
- 23 (5) the current budget for the commission;
- 24 (6) the results of the most recent formal audit of the
- 25 commission:
- 26 (7) the requirements of Chapters 551, 552, and 2001,
- 27 Government Code;
- 28 (8) the requirements of the conflict of interest laws
- 29 and other laws relating to public officials; and
- 30 (9) any applicable ethics policies adopted by the
- 31 commission or the Texas Ethics Commission.

- 1 (c) A person who is <u>elected or</u> appointed to the commission
- 2 is entitled to reimbursement, as provided by the General
- 3 Appropriations Act, for the travel expenses incurred in attending
- 4 the training program regardless of whether the attendance at the
- 5 program occurs before or after the person qualifies for office.
- 6 (b) This section takes effect September 1, 2021.
- 7 SECTION ____. (a) Section 12.152, Utilities Code, is
- 8 amended to read as follows:
- 9 Sec. 12.152. CONFLICT OF INTEREST. (a) A person is not
- 10 eligible for <u>election or</u> appointment as a commissioner or executive
- 11 director of the commission if:
- 12 (1) the person serves on the board of directors of a
- 13 company that supplies fuel, utility-related services, or
- 14 utility-related products to regulated or unregulated electric or
- 15 telecommunications utilities; or
- 16 (2) the person or the person's spouse:
- 17 (A) is employed by or participates in the
- 18 management of a business entity or other organization that is
- 19 regulated by or receives funds from the commission;
- 20 (B) directly or indirectly owns or controls more
- 21 than a 10 percent interest in:
- 22 (i) a business entity or other organization
- 23 that is regulated by or receives funds from the commission; or
- 24 (ii) a utility competitor, utility
- 25 supplier, or other entity affected by a commission decision in a
- 26 manner other than by the setting of rates for that class of
- 27 customer;
- (C) uses or receives a substantial amount of
- 29 tangible goods, services, or funds from the commission, other than
- 30 compensation or reimbursement authorized by law for commission
- 31 membership, attendance, or expenses; or

- 6 commissioner of the Public Utility Commission of Texas who is 7 serving on September 1, 2021, expires on that date, but a 8 commissioner serving on that date may continue to serve in that 9 office until a successor is appointed or elected and qualifies. As

- 10 soon as practicable after September 1, 2021, the governor shall
- 11 appoint a qualified individual to serve in each of the five numbered
- 12 commissioner positions on the Public Utility Commission of Texas to
- 13 staggered terms so that the commissioner in position number one
- 14 serves until a successor elected in 2022 qualifies and takes
- 15 office, the terms of the commissioners in position numbers two and
- 16 three each serve until a successor elected in 2024 qualifies and
- 17 takes office, and the terms of the commissioners in position
- 18 numbers four and five each serve until a successor elected in 2026
- 19 qualifies and takes office.
