13	(g) Except as provided by Subsections (a), (e), and (f), all
14	legal interests of a state agency abolished in an odd-numbered year
15	are transferred to the comptroller on the date the state agency is

17	(h) On the date a state agency that is abolished in an
18	odd-numbered year is terminated under Subsection (a), the chief
19	executive officer of this state is responsible for administering
20	any law previously administered by the abolished state agency and a
21	reference in any law to the abolished state agency means the chief
22	executive officer of this state.

- 3 Sec. 325.052. PUBLIC MEMBERSHIP ON STATE AGENCY
- 4 POLICYMAKING BODY. (a) A person may not be a public member of the
- 5 policymaking body of a state agency if the person or the person's
- 6 spouse:
- 7 (1) is registered, certified, or licensed by a
- 8 regulatory agency in a field regulated by the state agency;
- 9 (2) is employed by or participates in the management
- 10 of a business entity or other organization regulated by or
- 11 receiving money from the state agency;
- 12 (3) owns or controls, directly or indirectly, more
- 13 than a 10 percent interest in a business entity or other
- 14 organization regulated by or receiving money from the state agency;
- 15 or
- 16 (4) uses or receives a substantial amount of tangible
- 17 goods, services, or money from the state agency other than
- 18 compensation or reimbursement authorized by law for the state
- 19 agency's policymaking body membership, attendance, or expenses.
- 20 (b) In addition to the restrictions provided by Subsection
- 21 (a), a person may not be a public member of the policymaking body of

- 25 <u>Sec. 325.053. PROVISIONS RELATING TO CONFLICTS OF INTEREST.</u>
- 26 (a) In this section, "Texas trade association" means a cooperative
- 27 and voluntarily joined statewide association of business or
- 28 professional competitors in this state designed to assist its
- 29 members and its industry or profession in dealing with mutual
- 30 business or professional problems and in promoting their common
- 31 <u>interest.</u>

- 1 (b) A person may not be a member of the policymaking body of
- 2 a state agency and may not be an employee of the state agency
- 3 employed in a "bona fide executive, administrative, or professional
- 4 capacity," as that phrase is used for purposes of establishing an
- 5 exemption to the overtime provisions of the federal Fair Labor
- 6 Standards Act of 1938 (29 U.S.C. Section 201 et seq.) if:
- 7 (1) the person is an officer, employee, or paid
- 8 consultant of a Texas trade association in a field regulated by the

- 25 Sec. 325.054. GOVERNOR DESIGNATES PRESIDING OFFICER. If
- 26 the governor appoints all members of a state agency's policymaking
- 27 body, the governor shall designate a member of the policymaking
- 28 body as the presiding officer of the policymaking body to serve in
- 29 that capacity at the pleasure of the governor.
- 30 Sec. 325.055. GROUNDS FOR REMOVAL OF MEMBERS FROM
- 31 POLICYMAKING BODIES. (a) It is a ground for removal from a state

- 1 agency's policymaking body that a member:
- 2 <u>(1) does not have at the time of taking office the</u>
- 3 qualifications required by law to be a member of the policymaking
- 4 body;
- 5 (2) does not maintain during service on the
- 6 policymaking body the qualifications required by law to be a member
- 7 of the policymaking body;
- 8 (3) is ineligible for membership on the policymaking
- 9 body under law, including provisions relating to public membership,
- 10 conflicts of interest, and lobbying;
- 11 (4) cannot, because of illness or disability,
- 12 <u>discharge the member's duties for a substantial part of the member's</u>
- 13 term; or
- 14 (5) is absent from more than half of the regularly
- 15 scheduled meetings of the policymaking body that the member is
- 16 eligible to attend during a calendar year without an excuse
- 17 approved by a majority vote of the policymaking body.
- 18 (b) The validity of an action of a state agency's
- 19 policymaking body is not affected by the fact that it is taken when
- 20 a ground for removal of a member of the policymaking body exists.
- 21 (c) If the executive head of a state agency has knowledge
- 22 that a potential ground for removal exists, the executive head
- 23 shall notify the presiding officer of the state agency's
- 24 policymaking body of the potential ground. The presiding officer
- 25 shall then notify the governor and the attorney general that a
- 26 potential ground for removal exists. If the potential ground for
- 27 removal involves the presiding officer, the executive head shall
- 28 notify the next highest ranking officer of the policymaking body,
- 29 who shall then notify the governor and the attorney general that a
- 30 potential ground for removal exists.
- 31 Sec. 325.056. TRAINING FOR MEMBERS OF POLICYMAKING BODIES.

- 1 (a) A person who is appointed to and qualifies for office as a
- 2 member of the policymaking body of a state agency may not vote,
- 3 deliberate, or be counted as a member in attendance at a meeting of
- 4 the policymaking body until the person completes a training program
- 5 that complies with this section.
- 6 (b) The training program must provide the person with
- 7 information regarding:
- 8 (1) the law governing the state agency's operations;
- 9 (2) the programs, functions, rules, and budget of the
- 10 state agency;
- 11 (3) the scope of and limitations on the rulemaking
- 12 <u>authority of the policymaking body;</u>
- 13 (4) the results of the most recent formal audit of the
- 14 state agency;
- 15 <u>(5)</u> the requirements of:
- 16 (A) laws relating to open meetings, public
- 17 information, administrative procedure, and disclosure of conflicts
- 18 of interest; and
- 19 <u>(B) other laws applicable to members of a state</u>
- 20 agency policymaking body in performing their duties; and
- 21 (6) any applicable ethics policies adopted by the
- 22 state agency or the Texas Ethics Commission.
- (c) A person appointed to the state agency's policymaking
- 24 body is entitled to reimbursement, as provided by the General
- 25 Appropriations Act, for the travel expenses incurred in attending
- 26 the training program regardless of whether the attendance at the
- 27 program occurs before or after the person qualifies for office.
- 28 (d) The executive head of the state agency shall create a
- 29 training manual that includes the information required by
- 30 Subsection (b). The executive head shall distribute a copy of the
- 31 training manual annually to each member of the policymaking body.

- 1 Each member of the policymaking body shall sign and submit to the
- 2 executive head a statement acknowledging that the member received
- 3 and reviewed the training manual.
- 4 Sec. 325.057. POLICIES TO SEPARATE POLICYMAKING AND STAFF
- 5 FUNCTIONS. The policymaking body of a state agency shall develop
- 6 and implement policies that clearly separate the policymaking
- 7 responsibilities of the policymaking body and the management
- 8 responsibilities of the executive head and the staff of the state
- 9 agency.
- 10 Sec. 325.058. PUBLIC TESTIMONY AT MEETINGS OF POLICYMAKING
- 11 BODIES. The policymaking body of a state agency shall develop and
- 12 implement policies that provide the public with a reasonable
- 13 opportunity to appear before the policymaking body and to speak on
- 14 any issue under the jurisdiction of the state agency.
- 15 Sec. 325.059. COMPLAINT INFORMATION REQUIREMENTS. (a) A
- 16 state agency shall maintain a system to promptly and efficiently
- 17 act on complaints filed with the state agency. The state agency
- 18 shall maintain information about parties to and the subject matter
- 19 of the complaint and a summary of the results of the review or
- 20 investigation of the complaint and the disposition of the
- 21 complaint.
- 22 (b) The state agency shall make information available
- 23 describing its procedures for complaint investigation and
- 24 resolution.
- 25 <u>(c) The state agency shall periodically notify the</u>
- 26 complaint parties of the status of the complaint until final
- 27 disposition unless the notice would jeopardize the investigation,
- 28 including an undercover investigation.
