1 (a)(2) may not adopt rules relating to the use of fireworks.

(c) A person <u>who</u> [commits an offense if the person] violates
a rule approved by the commissioners court under Subsection (b) <u>is</u>
<u>liable to the county for a civil penalty of not more than \$100 per</u>
<u>violation</u>. <u>A county may bring suit in a district court or county</u>
<u>court to recover a civil penalty authorized by this subsection</u> [An
<u>offense under this subsection is a Class C misdemeanor</u>].

8 SECTION 3. The changes in law made by this Act do not affect the pending prosecution of an offense under Section 320.0455, Local 9 Government Code, as that section existed immediately before the 10 effective date of this Act. An offense committed before the 11 effective date of this Act is governed by the law in effect on the 12 date the offense was committed, and the former law is continued in 13 14 effect for that purpose. For purposes of this section, an offense 15 was committed before the effective date of this Act if any element of the offense was committed before that date. 16
