FEDERAL AUTHORIZATION FOR MEDICAID 13 14 EXPANSION IN CERTAIN COUNTIES. (a) On the request of a county and notwithstanding any other law, the executive commissioner shall, on 15 16 behalf of the county, seek a waiver under Section 1115 of the Social Security Act (42 U.S.C. Section 1315) to the state Medicaid plan to 17 expand the categories of persons eligible for Medicaid benefits by 18 allowing the county to provide Medicaid benefits to any resident of 19 the county: 20 21 (1) who is not otherwise eligible to receive Medicaid benefits under the program established under Chapter 32, Human 22 23 Resources Code, and operated by the state, including through a

waiver, other than a waiver sought under this section, to the

2	(2) who applies to receive Medicaid benefits; and
3	(3) for whom federal matching funds are available
4	under the Patient Protection and Affordable Care Act (Pub. L. No.
5	111-148) as amended by the Health Care and Education Reconciliation
6	Act of 2010 (Pub. L. No. 111-152) to provide Medicaid benefits.
7	(b) The terms of a waiver under this section must:
8	(1) specify how, and with the assistance of what
9	entities, the county will implement and operate a delivery system
10	for the provision of Medicaid benefits to persons described by
11	Subsection (a);
12	(2) specify the role of the commission in facilitating
13	the provision of those Medicaid benefits;
14	(3) identify the sources of funds to be used to pay the
15	state's share of the cost of Medicaid benefits provided by the
16	<pre>county;</pre>
17	(4) establish qualifications for a person to be
18	considered a resident of the county for purposes of receiving
19	Medicaid benefits from the county; and
20	(5) if appropriate, prescribe changes to the
21	commission's eligibility determination process for Medicaid
22	benefits to accommodate the expanded categories of persons eligible
23	to receive Medicaid benefits from the county.
24	(c) The executive commissioner shall adopt rules necessary
25	to implement this section.
26	SECTION 2. Not later than December 1, 2021, the executive
27	commissioner of the Health and Human Services Commission shall

1 adopt rules necessary to implement Section 540.0002, Government 2 Code, as added by this Act, including rules that specify procedures 3 by which a county may request that the executive commissioner seek a 4 waiver under that section.

5 SECTION 3. This Act takes effect immediately if it receives 6 a vote of two-thirds of all the members elected to each house, as 7 provided by Section 39, Article III, Texas Constitution. If this 8 Act does not receive the vote necessary for immediate effect, this 9 Act takes effect September 1, 2021.
