- 11 is not required to produce or permit the inspection of the remaining
- 12 portion that is not subject to discovery and may withhold or redact
- 13 that portion. The state shall inform the accused or suspected
- 14 person that a portion of the document, item, or information has been
- 15 <u>withheld or redacted.</u>
- 16 (h) The accused or suspected person, the attorney
- 17 representing the accused or suspected person, or an investigator,
- 18 expert, consulting legal counsel, or other agent of the attorney
- 19 representing the accused or suspected person may not disclose to a
- 20 third party any documents, evidence, materials, or witness
- 21 statements received under this article unless:
- 22 (1) a court orders the disclosure after notice and
- 23 hearing, on a showing of good cause and after considering the
- 24 security and privacy interests of any victim or witness; or
- 25 (2) the documents, evidence, materials, or witness
- 26 statements have already been publicly disclosed.
- (i) Notwithstanding any other provision of this article,

- 1 information identifying any victim or witness, including the name
- 2 of a victim or witness and including the address, telephone number,
- 3 driver's license number, social security number, date of birth, or
- 4 bank account information or any other information that by reference
- 5 would make it possible to identify a victim or witness, is
- 6 confidential and may not be disclosed unless the disclosure is
- 7 ordered by the court under Subsection (h) or otherwise required by
- 8 Subsection (j).
- 9 (j) Notwithstanding any other provision of this article,
- 10 the state shall disclose to the accused or suspected person any
- 11 exculpatory, impeachment, or mitigating document, item, or
- 12 information that is in the possession, custody, or control of the
- 13 state or any person under contract with the state that tends to
- 14 negate the guilt of the accused or suspected person or would tend to
- 15 reduce the punishment for the offense being investigated.
- 16 <u>(k) The state shall electronically record or otherwise</u>
- 17 document any document, item, or other information provided to the
- 18 accused or suspected person under this article.
- 19 (1) A court may order the accused or suspected person to pay
- 20 costs related to discovery under this article, not to exceed the
- 21 amounts authorized to be charged by Subchapter F, Chapter 552,
- 22 Government Code, for providing public information.
- 23 (m) Except as provided by Subsection (i), this article does
- 24 not prohibit the attorney representing the state from providing
- 25 discovery and documentation beyond that required by this article.
- 26 (n) This article applies only to discovery for a grand jury
- 27 investigation. This article does not limit an accused or suspected

- 1 person's right to discovery authorized by other law.
- 2 (o) [The defendant may petition a court to order the
- 3 disclosure of information made secret by Article 20A.202,
- 4 $\frac{20 \text{A.203(a)}}{\text{or}}$ or $\frac{20 \text{A.204}}{\text{or}}$ including a recording or typewritten
- 5 transcription under Article 20A.201, as a matter preliminary to or
- 6 in connection with a judicial proceeding. The court may order
- 7 disclosure of the information if the defendant shows a
- 8 particularized need.
- 9 [(b) A petition for disclosure under Subsection (a) must be
- 10 filed in the district court in which the case is pending. The
- 11 defendant must also file a copy of the petition with the attorney
- 12 representing the state, the parties to the judicial proceeding, and
- 13 any other person the court requires. Each person who receives a copy
- 14 of the petition under this subsection is entitled to appear before
- 15 the court. The court shall provide interested parties with an
- 16 opportunity to appear and present arguments for or against the
- 17 requested disclosure.
- 18 $\left[\frac{(c)}{c}\right]$ A person who receives information under this article
- 19 and discloses that information in a manner not authorized by this
- 20 article may be punished for contempt in the same manner as a person
- 21 who violates Article 20A.203(a).
- 22 SECTION 10. Article 20A.257, Code of Criminal Procedure, is
- 23 amended to read as follows:
- 24 Art. 20A.257. EXAMINATION OF WITNESSES. (a) A person who
- 25 is subpoenaed to appear as a witness before a grand jury shall be
- 26 given a reasonable opportunity to retain counsel and to consult
- 27 with counsel before the person's appearance.

- 1 <u>(b)</u> Only a grand juror or the attorney representing the
- 2 state may examine a witness before the grand jury.
- 3 $\underline{\text{(c)}}$ [\(\frac{\((\b)\)}{\((\b)\)}\)] The attorney representing the state shall advise
- 4 the grand jury regarding the proper mode of examining a witness.
- 5 (d) Before the grand jury may question the witness, a
- 6 witness appearing before a grand jury shall be orally given the
- 7 following warning:
- 8 "Your testimony before this grand jury is under oath. Any
- 9 material question that is answered falsely before this grand jury
- 10 subjects you to being prosecuted for aggravated perjury. You have
- 11 the right to refuse to make answers to any question, the answer to
- 12 which would incriminate you in any manner. During questioning, you
- 13 have the right to have an attorney present to advise you before
- 14 making answers to questions you feel might incriminate you. Any
- 15 testimony you give may be used against you at any subsequent
- 16 proceeding."
- (e) [(c)] If a felony has been committed in any county in
- 18 the grand jury's jurisdiction, and the name of the offender is known
- 19 or unknown or if it is uncertain when or how the felony was
- 20 committed, the grand jury shall first state the subject matter
- 21 under investigation to a witness called before the grand jury and
- 22 may then ask questions relevant to the transaction in general terms
- 23 and in a manner that enables a determination as to whether the
- 24 witness has knowledge of the violation of any particular law by any
- 25 person, and if so, by what person.
- SECTION 11. Article 20A.258(b), Code of Criminal Procedure,
- 27 is amended to read as follows:

1 (b) The warnings required under Subsection (a)(1) must 2 consist of the following: "Your testimony before this grand jury is under oath. Any 3 material question that is answered falsely before this grand jury 4 5 subjects you to being prosecuted for aggravated perjury. You have the right to refuse to make answers to any question, the answer to 6 which would incriminate you in any manner. During questioning, you 7 8 [You] have the right to have an attorney [a lawyer] present [outside this chamber] to advise you before making answers to questions you 9 10 feel might incriminate you. Any testimony you give may be used against you at any subsequent proceeding. If you are unable to 11 employ an attorney [a lawyer], you have the right to have an 12 attorney [a lawyer] appointed to advise you before making an answer 13 14 to a question, the answer to which you feel might incriminate you." 15 SECTION 12. Subtitle A, Title 2, Civil Practice and Remedies Code, is amended by adding Chapter 14A to read as follows: 16 17 CHAPTER 14A. GRAND JURY LITIGATION Sec. 14A.001. RECOVERY OF ATTORNEY'S FEES AND RELATED 18 EXPENSES; WAIVER OF IMMUNITY. (a) Not later than the 30th day 19 after the date of the grand jury vote under Article 20A.301, Code of 20 Criminal Procedure, the accused or suspected person may submit to 21 the court an application to recover attorney's fees and other 22 related expenses. The application must: 23 (1) allege that the position of 24 the attorney representing the state was: 25 26 (A) not substantially justified; and

(B) vexatious, frivolous, or in bad faith; and

27

- 1 (2) show the amount of attorney's fees and other
- 2 related expenses incurred by the accused or suspected person during
- 3 the grand jury investigation, including an itemized statement
- 4 submitted by any attorney representing the accused or suspected
- 5 person or any expert witness testifying on behalf of the accused or
- 6 suspected person and showing:
- 7 (A) the time actually expended; and
- 8 (B) the rate at which the fees and other expenses
- 9 were calculated.
- 10 (b) The court may award reasonable attorney's fees and other
- 11 related expenses to the accused or suspected person if the court:
- 12 (1) finds that the position of the attorney
- 13 representing the state was not substantially justified, based on
- 14 the record made in the grand jury investigation for which
- 15 attorney's fees and other related expenses are requested;
- 16 (2) finds that the position of the attorney
- 17 representing the state was vexatious, frivolous, or in bad faith;
- 18 and
- 19 (3) does not find that special circumstances make the
- 20 award unjust.
- 21 (c) To determine whether the position of the attorney
- 22 representing the state was vexatious, frivolous, or in bad faith,
- 23 the court, for good cause shown, may receive evidence ex parte and
- 24 in camera, including evidence that reveals or might reveal the
- 25 identity of an informant or undercover agent or matters occurring
- 26 before a grand jury. The court shall keep evidence received under
- 27 this subsection under seal.

- 1 (d) The attorney representing the state shall pay
- 2 attorney's fees and other related expenses awarded under this
- 3 <u>section</u>.
- 4 (e) Governmental immunity is waived and abolished to the
- 5 <u>extent of liability for attorney's fees and other related</u> expenses
- 6 <u>under this section.</u>
- 7 SECTION 13. The changes in law made by this Act apply only
- 8 to a grand jury proceeding that begins on or after the effective
- 9 date of this Act. A grand jury proceeding that begins before the
- 10 effective date of this Act is governed by the law in effect on the
- 11 date the proceeding began, and the former law is continued in effect
- 12 for that purpose.
- 13 SECTION 14. This Act takes effect September 1, 2021.
