H.B. No. 196

A BILL TO BE ENTITLED

AN ACT

relating to the use of deadly force in defense of a person or property.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Sections 9.32(a) and (c), Penal Code, are amended to read as follows:

(a) A person is justified in using deadly force against another if the actor:

(1) is [~~if the actor would be~~] justified in using force against the other under Section 9.31; [~~and~~]

(2) is unable to safely retreat; and

(3) [~~when and to the degree the actor~~] reasonably believes the deadly force is immediately necessary:

(A) to protect the actor against the other's use or attempted use of unlawful deadly force; or

(B) to prevent the other's imminent commission of aggravated kidnapping, murder, sexual assault, or aggravated sexual assault [~~, robbery, or aggravated robbery~~].

(c) Notwithstanding Subsection (a)(2), a [A] person who is in the person's own habitation [~~has a right to be present at the location where the deadly force is used~~], who has not provoked the person against whom the deadly force is used, and who is not engaged in criminal activity at the time the deadly force is used is not required to retreat before using deadly force as described by this

2 SECTION 2. Section 9.41, Penal Code, is amended to read as
3 follows:

4 Sec. 9.41. PROTECTION OF ONE'S OWN PROPERTY. (a) A person
5 in lawful possession of land, including a habitation on the land, or
6 tangible, movable property is justified in using force against
7 another when and to the degree the actor reasonably believes the
8 force is immediately necessary to prevent or terminate the other's
9 trespass on the land or unlawful interference with the property.

10 (b) A person unlawfully dispossessed of land, including a
11 habitation on the land, or tangible, movable property by another is
12 justified in using force against the other when and to the degree
13 the actor reasonably believes the force is immediately necessary to
14 reenter the land or recover the property if the actor uses the force
15 immediately or in fresh pursuit after the dispossession and:

16 (1) the actor reasonably believes the other had no
17 claim of right when he dispossessed the actor; or

18 (2) the other accomplished the dispossession by using
19 force, threat, or fraud against the actor.

20 SECTION 3. Section 9.42, Penal Code, is amended to read as
21 follows:

22 Sec. 9.42. DEADLY FORCE TO PROTECT PROPERTY. A person is
23 justified in using deadly force against another to protect land,
24 including a habitation on the land, or tangible, movable property
25 if the actor:

26 (1) is [~~if he would be~~] justified in using force
27 against the other under Section 9.41; [~~and~~]

1 (2) [~~when and to the degree he~~] reasonably believes
2 the deadly force is immediately necessary:

3 (A) to prevent the other's imminent commission of
4 arson, burglary, robbery, aggravated robbery, theft during the
5 nighttime, or criminal mischief during the nighttime; or

6 (B) to prevent the other who is fleeing
7 immediately after committing burglary, robbery, aggravated
8 robbery, or theft during the nighttime from escaping with the
9 property; and

10 (3) [~~he~~] reasonably believes that:

11 (A) the land or property cannot be protected or
12 recovered by any other means; or

13 (B) the use of force other than deadly force to
14 protect or recover the land or property would expose the actor or
15 another to a substantial risk of death or serious bodily injury.

16 SECTION 4. Sections [9.32\(b\)](#) and (d), Penal Code, are
17 repealed.

18 SECTION 5. The change in law made by this Act applies only
19 to an offense committed on or after the effective date of this Act.
20 An offense committed before the effective date of this Act is
21 governed by the law in effect on the date the offense was committed,
22 and the former law is continued in effect for that purpose. For
23 purposes of this section, an offense was committed before the
24 effective date of this Act if any element of the offense occurred
25 before that date.

26 SECTION 6. This Act takes effect September 1, 2021.
