- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 6
- 7 SECTION 1. Subchapter J, Chapter 21, Education Code, is
- 8 amended by adding Section 21.466 to read as follows:
- Sec. 21.466. COMPUTER SCIENCE AND TECHNOLOGY APPLICATIONS 9
- PROFESSIONAL DEVELOPMENT GRANT PROGRAM. (a) In this section, 10
- 11 "institution of higher education" has the meaning assigned by
- Section 61.003. 12
- (b) The commissioner shall establish a competitive 13
- 14 professional development grant program to encourage teachers to:
- 15 (1) obtain computer science certification; and
- (2) continue professional development in coding, 16
- computational thinking, and computer science education. 17
- 18 (c) From money appropriated for the purpose, the
- commissioner shall make grants to eligible providers that offer: 19
- (1) professional development for elementary school 20
- 21 and middle and junior high school teachers to ensure teachers
- maintain a working knowledge of current computer industry standard 22
- 23 tools and resources; and
- 24 (2) training for computer science certification for

- 1 teachers in accordance with certification requirements adopted by
- 2 the State Board for Educator Certification.
- 3 (d) To be eligible to receive a grant under this section, a
- 4 provider must:
- 5 (1) be an institution of higher education, regional
- 6 education service center, or school district or partnership of
- 7 multiple school districts or a nonprofit entity approved by the
- 8 commissioner that has demonstrated experience in providing
- 9 professional development through a statewide network; and
- 10 (2) meet eligibility standards established by
- 11 commissioner rule.
- 12 (e) An eligible provider receiving a grant under this
- 13 <u>section</u> must:
- 14 (1) provide the training or professional development
- 15 <u>described by Subsection (c) and establish professional dev</u>elopment
- 16 <u>hubs in each education service center region;</u>
- 17 (2) serve high-need campuses;
- 18 (3) have established partnerships with institution of
- 19 higher education faculty with expertise in computing and computer
- 20 <u>science</u> education; and
- 21 (4) develop partnerships with computer industry
- 22 professionals.
- 23 <u>(f) The total amount of grants awarded under this section</u>
- 24 for a state fiscal biennium may not exceed \$4 million.
- 25 (g) The commissioner may adopt rules as necessary to
- 26 implement this section.
- SECTION 2. Not later than December 31, 2021, the

- 1 commissioner of education shall establish the grant program
- 2 required under Section 21.466, Education Code, as added by this
- 3 Act.
- 4 SECTION 3. This Act takes effect immediately if it receives
- 5 a vote of two-thirds of all the members elected to each house, as
- 6 provided by Section 39, Article III, Texas Constitution. If this
- 7 Act does not receive the vote necessary for immediate effect, this
- 8 Act takes effect September 1, 2021.
