2	relating to the payment of certain costs associated with certain
3	assignments of a statutory probate court judge.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter B, Chapter 352, Estates Code, is
6	amended by adding Section 352.054 to read as follows:
7	Sec. 352.054. REIMBURSEMENT FOR CERTAIN COSTS FOR ASSIGNED
8	JUDGE. A statutory probate court judge assigned to hear a contested
9	matter on the motion under Section 32.003 of a party to the
10	proceeding may order the estate to reimburse a county for any
11	amounts the county paid as compensation and expenses in accordance
12	with Section 25.0022(o-1), Government Code.
13	SECTION 2. Section 25.0022, Government Code, is amended by
14	adding Subsection (o-1) and amending Subsection (p) to read as
15	follows:
16	(o-1) If a party to a probate proceeding files a motion for
17	the assignment of a statutory probate court judge to hear a
18	contested matter in the proceeding under Section 32.003, Estates
19	Code, and the motion is granted, the assigned statutory probate
20	<pre>court judge shall:</pre>
21	(1) to the extent possible, order that the county be

reimbursed for any amounts the county paid as compensation and

expenses under Subsections (o) and (p) from the estate under

Section 352.054, Estates Code, and from the parties to the

1 proceeding; and

- 2 (2) prescribe the amount and manner by which the
- 3 compensation and expenses described by Subdivision (1) are to be
- 4 equitably apportioned among the estate and parties, as applicable.
- 5 (p) In addition to all compensation and expenses authorized
- 6 by this section and other law, a judge who is assigned to a court
- 7 outside the county of the judge's residence is entitled to receive
- 8 \$25 for each day or fraction of a day served. Subject to Subsection
- 9 (o-1), the [The] county in which the judge served shall pay the
- 10 additional compensation from the county's general fund on
- 11 certification by the presiding judge.
- 12 SECTION 3. Section 25.0022, Government Code, as amended by
- 13 this Act, applies only to a motion for the assignment of a statutory
- 14 probate court judge under Section 32.003, Estates Code, that is
- 15 filed on or after the effective date of this Act. A motion filed
- 16 before the effective date of this Act is governed by the law in
- 17 effect on the date the motion was filed, and the former law is
- 18 continued in effect for that purpose.
- 19 SECTION 4. This Act takes effect September 1, 2021.
