(18) any offense under Section 16.02; or

2 (19) any offense classified as a felony under the Tax3 Code.

4 SECTION 2. The change in law made by this Act applies only to an offense committed on or after the effective date of this Act. 5 An offense committed before the effective date of this Act is 6 governed by the law in effect on the date the offense was committed, 7 and the former law is continued in effect for that purpose. 8 For purposes of this section, an offense was committed before the 9 effective date of this Act if any element of the offense was 10 committed before that date. 11

SECTION 3. This Act takes effect September 1, 2021.
