5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Section 521.1211, Transportation Code, is
7	amended to read as follows:
8	Sec. 521.1211. DRIVER'S LICENSE FOR PEACE OFFICERS, STATE
9	LEGISLATORS, AND PROSECUTORS [OFFICER]. (a) In this section:
10	(1) "Peace [, "peace] officer" has the meaning
11	assigned by Article 2.12, Code of Criminal Procedure, except that
12	the term includes a special investigator as defined by Article
13	2.122, Code of Criminal Procedure.
14	(2) "Prosecutor" means a county attorney, district
15	attorney, criminal district attorney, assistant county attorney,
16	assistant district attorney, or assistant criminal district
17	attorney.
18	(a-1) This section applies only to:
19	(1) a peace officer;
20	(2) a state legislator; and
21	(3) a prosecutor.
22	(b) Notwithstanding Section $521.121(a)$, the department by
23	rule shall adopt procedures for the issuance of a driver's license

- 1 actual residence address and includes, as an alternative, an
- 2 address described under Subsection (f) [that is acceptable to the
- 3 department and is in the:
- 4 [(1) municipality or county of the peace officer's
- 5 residence; or
- 6 [(2) county of the peace officer's place of
- 7 employment].
- 8 (c) To be issued a driver's license under this section, an
- 9 applicant [a peace officer] must apply to the department and
- 10 provide sufficient evidence acceptable to the department to
- 11 establish the applicant's status as a person described under
- 12 Subsection (a-1) [peace officer]. On issuance of the license, the
- 13 license holder shall surrender any other driver's license issued to
- 14 the holder by the department.
- 15 (d) If the holder of a driver's license that includes an
- 16 alternative address moves to a new residence, or, for a state
- 17 legislator or prosecutor, to a new office address, or if the name of
- 18 the person is changed by marriage or otherwise, the license holder
- 19 shall, not later than the 30th day after the date of the address or
- 20 name change, notify the department and provide the department with
- 21 the number of the person's driver's license and, as applicable, the
- 22 person's:
- 23 (1) former and new addresses; or
- 24 (2) former and new names.
- 25 (e) If the holder of a driver's license that includes an
- 26 alternative address ceases to be a person described by Subsection
- 27 (a-1) [peace officer], the license holder shall, not later than the

- 1 30th day after the date of the status change, apply to the
- 2 department for issuance of a duplicate license. The duplicate
- 3 license must include the person's actual current residence address.
- 4 (f) The department shall accept as an alternative address:
- 5 (1) for a peace officer, an address that is in the:
- 6 (A) municipality or county of the peace officer's
- 7 residence; or
- 8 (B) county of the peace officer's place of
- 9 employment;
- 10 (2) for a state legislator, the address of an office of
- 11 the legislator; and
- 12 (3) for a prosecutor, the address of an office of the
- 13 prosecutor.
- 14 SECTION 2. This Act takes effect September 1, 2021.
