## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the establishment of a limitation on the total amount of
- 3 ad valorem taxes that taxing units may impose on the residence
- 4 homesteads of individuals who are disabled or elderly and their
- 5 surviving spouses.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. The heading to Section 11.26, Tax Code, is
- 8 amended to read as follows:
- 9 Sec. 11.26. LIMITATION OF TAXES [SCHOOL TAX] ON HOMESTEADS
- 10 OF INDIVIDUALS WHO ARE ELDERLY OR DISABLED.
- 11 SECTION 2. Sections 11.26(a), (a-1), (a-2), (a-3), (b),
- 12 (c), (e), (g), (h), (i), (i-1), (j), (k), and (o), Tax Code, are
- 13 amended to read as follows:
- 14 (a) The tax officials shall appraise [the] property to which
- 15 this section applies and calculate taxes as on other property, but
- 16 if the tax [so] calculated exceeds the limitation imposed by this
- 17 section, the tax imposed is the amount of the tax as limited by this
- 18 section, except as otherwise provided by this section. A taxing
- 19 <u>unit</u> [school district] may not increase the total annual amount of
- 20 ad valorem tax it imposes on the residence homestead of an
- 21 individual 65 years of age or older or on the residence homestead of
- 22 an individual who is disabled, as defined by Section 11.13, above
- 23 the amount of the tax it imposed in the first tax year in which the
- 24 individual qualified that residence homestead for the applicable

1 exemption provided by Section 11.13(c) for an individual who is 65 years of age or older or is disabled. If the individual qualified 2 3 that residence homestead for the exemption after the beginning of that first year and the residence homestead remains eligible for 4 5 the same exemption for the next year, and if the [school district] taxes imposed by a taxing unit on the residence homestead in the 6 next year are less than the amount of those taxes imposed in that 7 8 first year, the taxing unit [a school district] may subsequently increase the total annual amount of ad valorem taxes 9 it imposes on the residence homestead above the amount it imposed in 10 the year immediately following the first year for which the 11 individual qualified that residence homestead for 12 the same exemption, except as provided by Subsection (b). [If the first tax 13 14 year the individual qualified the residence homestead for the 15 exemption provided by Section 11.13(c) for individuals 65 years of age or older or disabled was a tax year before the 2015 tax year, the 16 17 amount of the limitation provided by this section is the amount of tax the school district imposed for the 2014 tax year less an amount 18 19 equal to the amount determined by multiplying \$10,000 times the tax 20 rate of the school district for the 2015 tax year, plus any 2015 tax 21 attributable to improvements made in 2014, other than improvements made to comply with governmental regulations or repairs. 22 If the first tax year the individual qualified the 23 24 residence homestead for the exemption provided by Section 11.13(c) for individuals 65 years of age or older or disabled was a tax year 25 26 before the 2022 tax year, the amount of the limitation on school

district taxes provided by this section is the amount of those taxes

imposed for the 2021 tax year plus any 2022 tax attributable to 1 improvements made in 2021, other than improvements made to comply 2 with governmental regulations or repairs [Notwithstanding the 3 other provisions of this section, if in the 2007 tax year an 4 5 individual qualifies for a limitation on tax increases provided by this section on the individual's residence homestead and the first 6 tax year the individual or the individual's spouse qualified for an 7 exemption under Section 11.13(c) for the same homestead was the 8 2006 tax year, the amount of the limitation provided by this section 9 on the homestead in the 2007 tax year is equal to the amount 10 11 computed by: (1) multiplying the amount of tax the school district 12 imposed on the homestead in the 2006 tax year by a fraction the 13 14 numerator of which is the tax rate of the district for the 2007 tax 15 year and the denominator of which is the tax rate of the district for the 2006 tax year; and 16 17 [(2) adding any tax imposed in the 2007 tax year attributable to improvements made in the 2006 tax year as provided 18 by Subsection (b) to the lesser of the amount computed under 19 Subdivision (1) or the amount of tax the district imposed on the 20 21 homestead in the 2006 tax year]. If the first tax year the individual qualified the 22 residence homestead for the exemption provided by Section 11.13(c) 23 24 for individuals 65 years of age or older or disabled was a tax year before the 2022 tax year and the homestead qualified for a 25

limitation on county, municipal, or junior college district taxes

under former Section 11.261, the amount of the limitation on

county, municipal, or junior college district taxes, as applicable, 1 provided by this section is the amount of the tax imposed by the 2 applicable taxing unit for the 2021 tax year, plus any 2022 tax attributable to improvements made in 2021, other than improvements 4 made to comply with governmental regulations or repairs 5 [Notwithstanding the other provisions of this section, if in the 6 2007 tax year an individual qualifies for a limitation on tax 7 8 increases provided by this section on the individual's residence homestead and the first tax year the individual or the individual's 9 spouse qualified for an exemption under Section 11.13(c) for the 10 same homestead was a tax year before the 2006 tax year, the amount 11 of the limitation provided by this section on the homestead in the 12 2007 tax year is equal to the amount computed by: 13 14 [(1) multiplying the amount of tax the school district imposed on the homestead in the 2005 tax year by a fraction the 15 numerator of which is the tax rate of the district for the 2006 tax 16 year and the denominator of which is the tax rate of the district 17 for the 2005 tax year; 18 [(2) adding any tax imposed in the 2006 tax year 19 attributable to improvements made in the 2005 tax year as provided 20 by Subsection (b) to the lesser of the amount computed under 21 Subdivision (1) or the amount of tax the district imposed on the 2.2 23 homestead in the 2005 tax year; [(3) multiplying the amount computed 24 25 Subdivision (2) by a fraction the numerator of which is the tax rate the district for the 2007 tax year and the denominator of which 26

the tax rate of the district for the 2006 tax year; and

- [(4) adding to the lesser of the amount computed under
  Subdivision (2) or (3) any tax imposed in the 2007 tax year
  attributable to improvements made in the 2006 tax year, as provided
  by Subsection (b)].
- (a-3) Except as provided by Subsection (a-2), for the purpose of calculating a limitation on tax increases by a taxing unit other than a school district under this section, an individual who qualified a residence homestead before January 1, 2022, for an exemption under Section 11.13(c) for individuals 65 years of age or older or disabled is considered to have qualified the homestead for that exemption on January 1, 2022 [(b), a limitation on tax increases provided by this section on a residence homestead computed under Subsection (a-1) or (a-2) continues to apply to the homestead in subsequent tax years until the limitation expires].

- (b) If an individual makes improvements to the individual's residence homestead, other than improvements required to comply with governmental requirements or repairs, a taxing unit [the school district] may increase the tax on the homestead in the first year the value of the homestead is increased on the appraisal roll because of the enhancement of value by the improvements. The amount of the tax increase is determined by applying the taxing unit's current tax rate to the difference in the assessed value of the homestead with the improvements and the assessed value it would have had without the improvements. A limitation under [imposed by] this section [then] applies to the increased amount of tax in subsequent tax years until more improvements, if any, are made.
  - (c) The limitation on tax increases required by this section

- 1 expires if on January 1:
- 2 (1) none of the owners of the structure who qualify for
- 3 the exemption under Section 11.13(c) for individuals 65 years of
- 4 age or older or disabled and who owned the structure when the
- 5 limitation first took effect is using the structure as a residence
- 6 homestead; or
- 7 (2) none of the owners of the structure qualifies for
- 8 the exemption <u>described by Subdivision (1)</u>.
- 9 (e) For each school district participating in an appraisal
- 10 district, the chief appraiser shall determine the portion of the
- 11 appraised value of residence homesteads of individuals on which
- 12 school district taxes are not imposed in a tax year because of the
- 13 limitation on tax increases imposed by this section. That portion
- 14 is calculated by determining the taxable value that, if multiplied
- 15 by the tax rate adopted by the school district for the tax year,
- 16 would produce an amount equal to the amount of tax that would have
- 17 been imposed by the school district on those residence homesteads
- 18 if the limitation on tax increases imposed by this section were not
- 19 in effect, but that was not imposed because of that limitation. The
- 20 chief appraiser shall determine that taxable value and certify it
- 21 to the comptroller as soon as practicable for each tax year.
- 22 (g) Except as provided by Subsection (b), if an individual
- 23 who receives a limitation on tax increases imposed by this section,
- 24 including a surviving spouse who receives a limitation under
- 25 Subsection (i), subsequently qualifies a different residence
- 26 homestead for the same exemption under Section 11.13, a taxing unit
- 27 [school district] may not impose ad valorem taxes on the

1 subsequently qualified homestead in a year in an amount that exceeds the amount of taxes the taxing unit [school district] would 2 3 have imposed on the subsequently qualified homestead in the first year in which the individual receives that same exemption for the 4 subsequently qualified homestead had the limitation on tax 5 increases imposed by this section not been in effect, multiplied by 6 a fraction the numerator of which is the total amount of [school 7 8 district] taxes imposed by a taxing unit of the same type on the former homestead in the last year in which the individual received 9 10 that same exemption for the former homestead and the denominator of which is the total amount of [school district] taxes that would have 11 12 been imposed by the taxing unit of the same type on the former homestead in the last year in which the individual received that 13 same exemption for the former homestead had the limitation on tax 14 15 increases imposed by this section not been in effect. A limitation under this subsection does not apply to a taxing unit if the former 16 17 homestead was not subject to taxation by a taxing unit of the same type in the last year in which the individual received the exemption 18 19 for the former homestead.

(h) An individual who receives a limitation on tax increases under this section, including a surviving spouse who receives a limitation under Subsection (i), and who subsequently qualifies a different residence homestead for an exemption under Section 11.13, or an agent of the individual, is entitled to receive from the chief appraiser of the appraisal district in which the former homestead was located a written certificate providing the information necessary to determine whether the individual may qualify for that

- 17 (i-1) A limitation on school district taxes under
- 18 Subsection (i) applicable to the residence homestead of the
- 19 surviving spouse of an individual who was disabled and who died
- 20 before January 1, 2020, is calculated as if the surviving spouse was
- 21 entitled to the limitation when the individual died.
- 22 (j) If an individual who qualifies for an exemption provided
- 23 by Section 11.13(c) for an individual 65 years of age or older dies
- 24 in the first year in which the individual qualified for the
- 25 exemption and the individual first qualified for the exemption
- 26 after the beginning of that year, except as provided by Subsection
- 27 (k), the amount to which the surviving spouse's [school district]

- 1 taxes imposed by a taxing unit are limited under Subsection (i) is
- 2 the amount of [school district] taxes imposed by the taxing unit on
- 3 the residence homestead in that year determined as if the
- 4 individual qualifying for the exemption had lived for the entire
- 5 year.
- 6 (k) If in the first tax year after the year in which an
- 7 individual dies in the circumstances described by Subsection (j)
- 8 the amount of [school district] taxes imposed by a taxing unit on
- 9 the residence homestead of the surviving spouse is less than the
- 10 amount of [school district] taxes imposed by the taxing unit in the
- 11 preceding year as limited by Subsection (j), in a subsequent tax
- 12 year the [surviving spouse's school district] taxes imposed by that
- 13 taxing unit on that residence homestead are limited to the amount of
- 14 taxes imposed by the district in that first tax year after the year
- 15 in which the individual dies.
- (o) Notwithstanding Subsections (a)  $[\frac{}{}, (a-3), ]$  and (b), an
- 17 improvement to property that would otherwise constitute an
- 18 improvement under Subsection (b) is not treated as an improvement
- 19 under that subsection if the improvement is a replacement structure
- 20 for a structure that was rendered uninhabitable or unusable by a
- 21 casualty or by wind or water damage. For purposes of appraising the
- 22 property in the tax year in which the structure would have
- 23 constituted an improvement under Subsection (b), the replacement
- 24 structure is considered to be an improvement under that subsection
- 25 only if:
- 26 (1) the square footage of the replacement structure
- 27 exceeds that of the replaced structure as that structure existed

- 1 before the casualty or damage occurred; or
- 2 (2) the exterior of the replacement structure is of
- 3 higher quality construction and composition than that of the
- 4 replaced structure.
- 5 SECTION 3. Sections 23.19(b) and (g), Tax Code, are amended
- 6 to read as follows:
- 7 (b) If an appraisal district receives a written request for
- 8 the appraisal of real property and improvements of a cooperative
- 9 housing corporation according to the separate interests of the
- 10 corporation's stockholders, the chief appraiser shall separately
- 11 appraise the interests described by Subsection (d) if the
- 12 conditions required by Subsections (e) and (f) have been met.
- 13 Separate appraisal under this section is for the purposes of
- 14 administration of tax exemptions, determination of applicable
- 15 limitations of taxes under Section 11.26 [or 11.261], and
- 16 apportionment by a cooperative housing corporation of property
- 17 taxes among its stockholders but is not the basis for determining
- 18 value on which a tax is imposed under this title. A stockholder
- 19 whose interest is separately appraised under this section may
- 20 protest and appeal the appraised value in the manner provided by
- 21 this title for protest and appeal of the appraised value of other
- 22 property.
- 23 (g) A tax bill or a separate statement accompanying the tax
- 24 bill to a cooperative housing corporation for which interests of
- 25 stockholders are separately appraised under this section must
- 26 state, in addition to the information required by Section 31.01,
- 27 the appraised value and taxable value of each interest separately

- 1 appraised. Each exemption claimed as provided by this title by a person entitled to the exemption shall also be deducted from the 2 total appraised value of the property of the corporation. - 10 SECTION 5. The following provisions of the Tax Code are

- SECTION 6. Section 11.26, Tax Code, as amended by this Act,
- 15 applies only to ad valorem taxes imposed for a tax year beginning on
- 16 or after the effective date of this Act.
- 17 SECTION 7. This Act takes effect January 1, 2022, but only
- 18 if the constitutional amendment proposed by the 87th Legislature,
- 19 Regular Session, 2021, establishing a limitation on the total
- 20 amount of ad valorem taxes that political subdivisions may impose
- 21 on the residence homesteads of individuals who are disabled or
- 22 elderly and their surviving spouses is approved by the voters. If
- 23 that constitutional amendment is not approved by the voters, this
- 24 Act has no effect.
