3	applicable to the reduction or termination of a defendant's period
4	of community supervision.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Article 42A.052(a), Code of Criminal Procedure,
7	is amended to read as follows:
8	(a) A judge who places a defendant on community supervision
9	may authorize the supervision officer supervising the defendant or
10	a magistrate appointed by the district courts in the county that
11	give preference to criminal cases to modify the conditions of
12	community supervision for the limited $\underline{\text{purpose}}$ [$\underline{\text{purpose}}$] of:
13	(1) transferring the defendant to different programs
14	within the community supervision continuum of programs and
15	sanctions <u>;</u>
16	(2) prioritizing the conditions ordered by the court
17	according to:
18	(A) the defendant's needs as determined by a risk
19	and needs assessment; and
20	(B) the defendant's progress under supervision;
21	<u>or</u>
22	(3) requiring a defendant who is not otherwise
23	required to submit to testing for a controlled substance as a
24	condition of community supervision under Article 42A.301(b)(13) to

- 1 submit to testing for a controlled substance on each occasion on
- 2 which the supervision officer has a reasonable suspicion that the
- 3 defendant is under the influence of a controlled substance.
- 4 SECTION 2. Article 42A.301(b), Code of Criminal Procedure,
- 5 is amended to read as follows:
- 6 (b) Conditions of community supervision may include
- 7 conditions requiring the defendant to:
- 8 (1) commit no offense against the laws of this state or
- 9 of any other state or of the United States;
- 10 (2) avoid injurious or vicious habits;
- 11 (3) avoid persons or places of disreputable or harmful
- 12 character to the extent indicated by the results of the assessment
- 13 conducted under Subsection (a) [, including any person, other than
- 14 a family member of the defendant, who is an active member of a
- 15 criminal street gang];
- 16 (4) report to the supervision officer as directed by
- 17 the judge or supervision officer and obey all rules and regulations
- 18 of the community supervision and corrections department;
- 19 (5) permit the supervision officer to visit the
- 20 defendant at the defendant's home or elsewhere;
- 21 (6) work faithfully at suitable employment to the
- 22 extent possible;
- 23 (7) remain within a specified place;
- 24 (8) pay in one or more amounts:
- 25 (A) the defendant's fine, if one is assessed; and
- 26 (B) all court costs, regardless of whether a fine
- 27 is assessed;

- 1 (9) support the defendant's dependents;
- 2 (10) participate, for a period specified by the judge,
- 3 in any community-based program, including a community service
- 4 project under Article 42A.304;
- 5 (11) if the judge determines that the defendant has
- 6 financial resources that enable the defendant to offset in part or
- 7 in whole the costs of the legal services provided to the defendant
- 8 in accordance with Article 1.051(c) or (d), including any expenses
- 9 and costs, reimburse the county in which the prosecution was
- 10 instituted for the costs of the legal services in an amount that the
- 11 judge finds the defendant is able to pay, except that the defendant
- 12 may not be ordered to pay an amount that exceeds:
- 13 (A) the actual costs, including any expenses and
- 14 costs, paid by the county for the legal services provided by an
- 15 appointed attorney; or
- 16 (B) if the defendant was represented by a public
- 17 defender's office, the actual amount, including any expenses and
- 18 costs, that would have otherwise been paid to an appointed attorney
- 19 had the county not had a public defender's office;
- 20 (12) if under custodial supervision in a community
- 21 corrections facility:
- 22 (A) remain under that supervision;
- 23 (B) obey all rules and regulations of the
- 24 facility; and
- (C) pay a percentage of the defendant's income to
- 26 the facility for room and board;
- 27 (13) submit to testing for alcohol or controlled

1 substances: 2 (A) during the 45-day period after the date of 3 the defendant's placement on community supervision; 4 (B) on each occasion on which the defendant 5 appears in court and the judge has a reasonable suspicion that the defendant is under the influence of a controlled substance; or 6 7 (C) at any time during the period of supervision 8 <u>if:</u> 9 (i) the defendant tested positive for a 10 controlled substance in a test conducted during the period described by Paragraph (A) or conducted under Paragraph (B) or 11 12 Article 42A.052(a)(3); 13 (ii) the judge determines, based on the 14 results of the assessment conducted under Subsection (a) or the 15 evaluation conducted under Subsection (c), if applicable, that testing is necessary to protect or restore the community or the 16 17 victim or to rehabilitate or reform the defendant; or (iii) the defendant's offense involved a 18 19 controlled substance or alcohol; (14) attend counseling sessions for substance abusers 20 or participate in substance abuse treatment services in a program 21 22 or facility approved or licensed by the Department of State Health 23 Services but only if: 24 (A) the judge determines, based on the results of the assessment conducted under Subsection (a) or the evaluation 25 26 conducted under Subsection (c), if applicable, that counseling or treatment is necessary to protect or restore the community or the 27

- 1 victim or to rehabilitate or reform the defendant; or
- 2 (B) the defendant's offense was related to
- 3 controlled substance or alcohol abuse;
- 4 (15) with the consent of the victim of a misdemeanor
- 5 offense or of any offense under Title 7, Penal Code, participate in
- 6 victim-defendant mediation;
- 7 (16) submit to electronic monitoring;
- 8 (17) reimburse the compensation to victims of crime
- 9 fund for any amounts paid from that fund to or on behalf of a victim,
- 10 as defined by Article 56B.003, of the offense or if no reimbursement
- 11 is required, make one payment to the compensation to victims of
- 12 crime fund in an amount not to exceed \$50 if the offense is a
- 13 misdemeanor or not to exceed \$100 if the offense is a felony;
- 14 (18) reimburse a law enforcement agency for the
- 15 analysis, storage, or disposal of raw materials, controlled
- 16 substances, chemical precursors, drug paraphernalia, or other
- 17 materials seized in connection with the offense;
- 18 (19) reimburse all or part of the reasonable and
- 19 necessary costs incurred by the victim for psychological counseling
- 20 made necessary by the offense or for counseling and education
- 21 relating to acquired immune deficiency syndrome or human
- 22 immunodeficiency virus made necessary by the offense;
- 23 (20) pay a fine in an amount not to exceed \$50 to a
- 24 crime stoppers organization, as defined by Section 414.001,
- 25 Government Code, and as certified by the Texas Crime Stoppers
- 26 Council;
- 27 (21) submit a DNA sample to the Department of Public

- 1 Safety under Subchapter G, Chapter 411, Government Code, for the
- 2 purpose of creating a DNA record of the defendant; and
- 3 (22) in any manner required by the judge, provide in
- 4 the county in which the offense was committed public notice of the
- 5 offense for which the defendant was placed on community
- 6 supervision.
- 7 SECTION 3. Article 42A.303(e), Code of Criminal Procedure,
- 8 is amended to read as follows:
- 9 (e) The Department of State Health Services or the community
- 10 supervision and corrections department supervising the defendant
- 11 shall develop the continuum of care treatment plan described by
- 12 Subsection (d)(1).
- SECTION 4. Articles 42A.403(d-1) and (e), Code of Criminal
- 14 Procedure, are amended to read as follows:
- 15 (d-1) The judge shall waive the educational program
- 16 requirement if the defendant successfully completes [equivalent]
- 17 education at a residential treatment facility under Article
- 18 42A.4045.
- 19 (e) The judge shall set out in the judgment, as applicable:
- 20 (1) the finding of good cause for waiver; or
- 21 (2) the finding that the defendant has successfully
- 22 completed [equivalent] education as provided by Article 42A.4045.
- SECTION 5. Articles 42A.404(b-1) and (c), Code of Criminal
- 24 Procedure, are amended to read as follows:
- 25 (b-1) The judge shall waive the educational program
- 26 requirement if the defendant successfully completes [equivalent]
- 27 education at a residential treatment facility under Article

- 1 42A.4045.
- 2 (c) The judge shall set out in the judgment, as applicable:
- 3 (1) the finding of good cause for waiver; or
- 4 (2) the finding that the defendant has successfully
- 5 completed [equivalent] education as provided by Article 42A.4045.
- 6 SECTION 6. Articles 42A.4045(a) and (b), Code of Criminal
- 7 Procedure, are amended to read as follows:
- 8 (a) A judge shall waive the educational requirement under
- 9 Article 42A.403 or 42A.404 for a defendant who is required to
- 10 receive treatment as a resident of a substance abuse treatment
- 11 facility as a condition of community supervision if the defendant
- 12 successfully completes [equivalent] education while the defendant
- 13 is confined to the residential treatment facility.
- 14 (b) The Department of State Health Services shall approve
- 15 [equivalent] education provided at substance abuse treatment
- 16 facilities.
- SECTION 7. Articles 42A.406(a) and (b-1), Code of Criminal
- 18 Procedure, are amended to read as follows:
- 19 (a) If a defendant is required as a condition of community
- 20 supervision to attend an educational program under Article 42A.403
- 21 or 42A.404, or if the court waives the educational program
- 22 requirement under Article 42A.403 or the defendant successfully
- 23 completes [equivalent] education under Article 42A.4045, the court
- 24 clerk shall immediately report that fact to the Department of
- 25 Public Safety, on a form prescribed by the department, for
- 26 inclusion in the defendant's driving record. If the court grants an
- 27 extension of time in which the defendant may complete the

- 1 educational program under Article 42A.403, the court clerk shall
- 2 immediately report that fact to the Department of Public Safety on a
- 3 form prescribed by the department. The clerk's report under this
- 4 subsection must include the beginning date of the defendant's
- 5 community supervision.
- 6 (b-1) Upon release from a residential treatment facility at
- 7 which the person successfully completed [equivalent] education
- 8 under Article 42A.4045, at the request of the court clerk, the
- 9 director of the residential treatment facility shall give notice to
- 10 the Department of Public Safety for inclusion in the person's
- 11 driving record.
- 12 SECTION 8. Article 42A.655, Code of Criminal Procedure, is
- 13 amended to read as follows:
- Art. 42A.655. ABILITY TO PAY. (a) Notwithstanding any
- other provision of this chapter, the [The] court shall inquire as to
- 16 whether the defendant has sufficient resources or income [consider
- 17 the defendant's ability] to pay before ordering the defendant to
- 18 make any payments under this chapter.
- (b) For a defendant who is ordered to make payments under
- 20 this chapter, the court shall reconsider whether the defendant has
- 21 <u>sufficient resources or income to pay:</u>
- 22 <u>(1) at any time the defendant's financial status or</u>
- 23 required payments change in such a way that the defendant's ability
- 24 to make a payment previously ordered by the court is substantially
- 25 hindered; and
- 26 (2) at any hearing held under Article 42A.751(d).
- 27 (c) If the court determines that the defendant does not have

- 1 sufficient resources or income to make any payment ordered by the
- 2 court, including a payment required under Article 42A.652, the
- 3 judge shall determine whether all or a portion of the payment should
- 4 be:
- 5 (1) required to be paid at a later date or in a
- 6 specified portion at designated intervals;
- 7 (2) waived completely or partially under Article
- 8 43.091 or 45.0491;
- 9 (3) discharged by performing community service under
- 10 Article 42A.304 or 45.049, as applicable; or
- 11 (4) satisfied through any combination of methods under
- 12 Subdivisions (1)-(3).
- 13 (d) If the court takes an action described by Subsection
- 14 (c), the court may, at any time during the defendant's period of
- 15 community supervision, reconsider that action.
- SECTION 9. Article 42A.701, Code of Criminal Procedure, is
- 17 amended by amending Subsection (b) and adding Subsections (b-1) and
- 18 (d-1) to read as follows:
- 19 (b) On completion of one-half of the original community
- 20 supervision period or two years of community supervision, whichever
- 21 is more, the judge shall review the defendant's record and consider
- 22 whether to reduce or terminate the period of community supervision,
- 23 unless the defendant:
- 24 (1) is delinquent in paying required [costs, fines,
- 25 fees, or restitution that the defendant has the ability to pay; or
- 26 (2) has not completed court-ordered counseling or
- 27 treatment.

- 1 (b-1) The supervision officer shall notify the court as soon as practicable after the date a defendant, who at the time of the 2 review required by Subsection (b) was delinquent in paying 3 restitution or had not completed court-ordered counseling or 4 5 treatment, completes the remaining court-ordered counseling or treatment and makes the delinquent restitution payments, as 6 applicable. On receipt of the notice the court shall review the 7 8 defendant's record and consider whether to reduce or terminate the period of community supervision. 9
- 10 (d-1) If the judge does not reduce or terminate the defendant's period of community supervision after a review 11 conducted under Subsection (b) or (b-1), the judge shall, as soon as 12 practicable after the 180th day after the date of the review but not 13 14 later than the 270th day after the date of the review and unless the 15 judge has already terminated the period of community supervision, review the defendant's record and again consider whether to reduce 16 17 or terminate the period of community supervision in accordance with Subsection (b). 18
- 19 SECTION 10. Articles 42A.702(a) and (d), Code of Criminal 20 Procedure, are amended to read as follows:
- 21 (a) This article applies only to a defendant who:
- (1) is granted community supervision, including deferred adjudication community supervision, for an offense punishable as a state jail felony or a felony of the third degree, other than an offense:
- 26 (A) included as a "reportable conviction or 27 adjudication" under Article 62.001(5);

- 1 (B) involving family violence as defined by 2 Section 71.004, Family Code;
- 3 (C) under Section 20.03 or 28.02, Penal Code; or
- 4 (D) under Chapter 49, Penal Code; and
- 5 (2) [is not delinquent in paying required costs,

6 fines, or fees; and

- 7 $\left[\frac{(3)}{3}\right]$ has fully satisfied any order to pay restitution 8 to a victim.
- 9 (d) A defendant is entitled to time credits toward the
- 10 completion of the defendant's period of community supervision for
- 11 the successful completion of treatment or rehabilitation programs
- 12 as follows:
- 13 (1) parenting class or parental responsibility
- 14 program: 30 days;
- 15 (2) anger management program: 30 days;
- 16 (3) life skills training program: 30 days;
- 17 (4) vocational, technical, or career education or
- 18 training program: 60 days; [and]
- 19 (5) alcohol or substance abuse counseling or
- 20 treatment: 90 days; and
- 21 (6) any other faith-based, volunteer, or
- 22 community-based program ordered or approved by the court: 30 days.
- 23 SECTION 11. (a) Except as provided by Subsection (b) of
- 24 this section, the change in law made by this Act to Chapter 42A,
- 25 Code of Criminal Procedure, applies to a person on community
- 26 supervision on or after the effective date of this Act, regardless
- 27 of whether the person was placed on community supervision before,

- 1 on, or after the effective date of this Act.
- 2 (b) Article 42A.702(d)(6), Code of Criminal Procedure, as
- 3 added by this Act, applies only to a person placed on community
- 4 supervision on or after the effective date of this Act.
- 5 SECTION 12. This Act takes effect September 1, 2021.
