5	SECTION 1. Article 59.06, Code of Criminal Procedure, is
6	amended by adding Subsection (u) to read as follows:
7	(u) As a specific exception to Subsection (c) that the funds
8	described by that subsection be used only for the official purposes
9	of the attorney representing the state or for law enforcement
10	purposes, to cover the costs of a contract with a municipal or
11	county program to provide services to domestic victims of
12	trafficking, the attorney representing the state or the head of a
13	law enforcement agency, as applicable, may use any portion of the
14	gross amount credited to the attorney's or agency's special fund
15	under Subsection (c) from the forfeiture of contraband that:
16	(1) is used in the commission of, or used to facilitate
17	or intended to be used to facilitate the commission of, an offense
18	under Chapter 20A, Penal Code; or
19	(2) consists of proceeds gained from the commission
20	of, or property acquired with proceeds gained from the commission
21	of, an offense under Chapter 20A, Penal Code.
22	SECTION 2. The change in law made by this Act in amending

- 1 proceeds or property received by a law enforcement agency or
- 2 attorney representing the state under Chapter 59, Code of Criminal

- 6 SECTION 3. This Act takes effect September 1, 2021.
