The change in law made by this Act in amending 22 23 Article 59.06, Code of Criminal Procedure, applies to the disposition or use, on or after the effective date of this Act, of 24

1 proceeds or property received by a law enforcement agency or 2 attorney representing the state under Chapter 59, Code of Criminal 3 Procedure, regardless of whether the receipt of the proceeds or 4 property occurred before, on, or after the effective date of this 5 Act.

6 SECTION 3. This Act takes effect September 1, 2021.
