## A BILL TO BE ENTITLED

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 13.015, Parks and Wildlife Code, is
- 6 amended by amending Subsection (a-2) and adding Subsection (a-3) to

- 8 (a-2) The department shall waive the park entrance fee for
- 9 an individual who is a first responder as defined by Section 42.012
- 10 and who:
- 11 (1) has completed at least 20 years of continuous
- 12 service as a first responder; or
- 13 (2) has a disability connected to service as a first
- 14 responder that consists of the loss of the use of a lower extremity
- or of a disability rating of 50 percent or more.
- 16 (a-3) The department may promote visits and enhance revenue
- 17 at parks, including amounts necessary for salaries, advertising,
- 18 consumable supplies and materials, promotional products, fees, and
- 19 related expenses.

(A) a firefighter certified by the Texas 1 2 Commission on Fire Protection or by the State Firefighters' and 3 Fire Marshals' Association of Texas; 4 (B) an individual certified as emergency medical 5 services personnel by the Department of State Health Services; 6 (C) a municipal police officer; 7 (D) a sheriff, deputy sheriff, or reserve deputy 8 sheriff; or 9 (E) a constable, deputy constable, or reserve 10 deputy constable. "Qualified disabled veteran" means a veteran with 11 (2) 12 a service connected disability, as defined by the United States Department of Veterans Affairs, consisting of the loss of the use of 13 14 a lower extremity or of a disability rating of 50 percent or more 15 and who is receiving compensation from the United States for the disability. 16 17 (d) The commission shall waive the fee or requirement for a resident who is a first responder who: 18 19 (1) has completed at least 20 years of continuous service as a first responder; or 20 21 (2) has a disability connected to service as a first
