Section 13.015, Parks and Wildlife Code, 5 is amended by amending Subsection (a-2) and adding Subsection (a-3) to 6 read as follows: 7 (a-2) The department shall waive the park entrance fee for 8 9 an individual who is a first responder as defined by Section 42.012 10 and who: 11 (1) has completed at least 20 years of continuous 12 service as a first responder; or 13 (2) has a disability connected to service as a first 14 responder that consists of the loss of the use of a lower extremity or of a disability rating of 50 percent or more. 15 16 (a-3) The department may promote visits and enhance revenue at parks, including amounts necessary for salaries, advertising, 17 consumable supplies and materials, promotional products, fees, and 18 related expenses. 19 SECTION 2. Section 42.012, Parks and Wildlife Code, 20 is 21 amended by amending Subsection (c) and adding Subsection (d) to 22 read as follows: 23 (c) In this section: 24 (1) "First responder" means a person who is:

17	(d) The commission shall waive the fee or license

23	or of a disability rating of 50 percent or more.
24	SECTION 3. Section 46.004(c), Parks and Wildlife Code, is

15	combination resident hunting and fishing license for a resident
16	who is a first responder as defined by Section 42.012 and who:
17	(1) has completed at least 20 years of continuous
18	service as a first responder; or
19	(2) has a disability connected to service as a first
20	responder that consists of the loss of the use of a lower extremity
21	or of a disability rating of 50 percent or more.
22	SECTION 5. This Act takes effect September 1, 2021.
