A BILL TO BE ENTITLED 1 AN ACT 2 relating to the deferral or abatement of the collection of ad valorem taxes on an appreciating residence homestead. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 SECTION 1. Sections 33.065(a), (f), and (g), Tax Code, are 5 amended to read as follows: 6 7 (a) An individual is entitled to defer collection of a tax or abate a suit to collect a delinquent tax imposed on the portion 8 9 of the appraised value of property the individual owns and occupies as the individual's residence homestead that exceeds the sum of: 10 11 (1)105 percent of the appraised value of the property 12 for the preceding year; and 13 (2) the market value of all new improvements to the 14 property. If the collection of [delinquent] taxes on the property 15 (f) was deferred in a prior tax year and the sum of the amounts 16 described by Subsections (a)(1) and (2) exceeds the appraised value 17 of the property for the current tax year, the amount of taxes the 18 collection of which may be deferred is reduced by the amount 19 calculated by multiplying the taxing unit's tax rate for the 20 current year by the amount by which that sum exceeds the appraised 21 value of the property. 22

(g) A tax lien remains on the property and interest
continues to accrue during the period collection of [delinquent]

taxes is deferred or abated under this section. The annual interest 1 rate during the deferral or abatement period is five [eight] 2 3 percent instead of the rate provided by Section 33.01. Interest and penalties that accrued or that were incurred or imposed under 4 Section 33.01 or 33.07 before the date the individual files the 5 deferral affidavit under Subsection (c) or the date the judgment 6 abating the suit is entered, as applicable, are preserved. 7 А 8 penalty is not incurred [on the delinquent taxes for which collection is deferred or abated] during a deferral or abatement 9 10 period. The additional penalty under Section 33.07 may be imposed and collected only if the [delinquent] taxes for which collection 11 12 is deferred or abated remain delinquent on or after the 91st day after the date the deferral or abatement period expires. A plea of 13 14 limitation, laches, or want of prosecution does not apply against 15 the taxing unit because of deferral or abatement of collection as 16 provided by this section.

17 SECTION 2. Section 33.065(g), Tax Code, as amended by this Act, applies only to interest that accrues during a deferral or 18 19 abatement period on or after the effective date of this Act, regardless of whether the deferral or abatement period began before 20 that date or begins on or after that date. Interest that accrued 21 during a deferral or abatement period before the effective date of 22 23 this Act is governed by the law in effect when the interest accrued, 24 and that law is continued in effect for that purpose.
