A BILL TO BE ENTITLED 1 AN ACT 2 relating to credit toward payment of a fine and costs for certain misdemeanants confined in jail or prison before sentencing. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. Article 45.014(e), Code of Criminal Procedure, as added by Chapter 1127 (S.B. 1913), Acts of the 85th Legislature, 6 7 Regular Session, 2017, is amended to read as follows: 8 (e) A justice or judge may not issue an arrest warrant for 9 the defendant's failure to appear at the initial court setting, including failure to appear as required by a citation issued under 10 Article 14.06(b), unless: 11 12 (1) the justice or judge provides by telephone or regular mail to the defendant notice that includes: 13 14 (A) a date and time, occurring within the 30-day period following the date that notice is provided, when the 15 16 defendant must appear before the justice or judge; 17 (B) the name and address of the court with jurisdiction in the case; 18 information regarding alternatives to the 19 (C) full payment of any fine or costs owed by the defendant, if the 20 21 defendant is unable to pay that amount; (D) a statement that the defendant may be 22 23 entitled to a credit toward any fine or costs owed by the defendant if the defendant was confined in jail or prison after the commission 24

1 of the offense for which the notice is given; and

2 (E) [(D)] an explanation of the consequences if 3 the defendant fails to appear before the justice or judge as 4 required by this article; and

5 (2) the defendant fails to appear before the justice6 or judge as required by this article.

SECTION 2. Article 45.041, Code of Criminal Procedure, is amended by amending Subsection (c) and adding Subsection (c-1) to read as follows:

10 (c) The justice or judge shall credit the defendant for time 11 served in jail as provided by Article 42.03. The credit <u>under this</u> 12 <u>subsection</u> shall be applied to the amount of the fine and costs at 13 the rate provided by Article 45.048.

14 (c-1) In addition to credit under Subsection (c), in 15 imposing a fine and costs in a case involving a misdemeanor punishable by a fine only, the justice or judge shall credit the 16 17 defendant for any time the defendant was confined in jail or prison while serving a sentence for another offense if that confinement 18 19 occurred after the commission of the misdemeanor. The credit under this subsection shall be applied to the amount of the fine and costs 20 at the rate of \$200 for each day of confinement. 21

22 SECTION 3. Article 45.014(e), Code of Criminal Procedure, 23 as added by Chapter 977 (H.B. 351), Acts of the 85th Legislature, 24 Regular Session, 2017, is repealed.

25 SECTION 4. Article 45.041(c-1), Code of Criminal Procedure, 26 as added by this Act, applies to a defendant who is sentenced for an 27 offense on or after the effective date of this Act, regardless of

whether the offense is committed before, on, or after the effective
date of this Act.

3 SECTION 5. This Act takes effect September 1, 2021.
