10	Sec. 12.201. DEFINITION. In this subchapter, "program"
11	means a dropout recovery competency-based educational pilot
12	program authorized under this subchapter.
13	Sec. 12.202. PROGRAM AUTHORIZATION. (a) For the purpose of
14	offering during the 2022-2023 school year a dropout recovery
15	competency-based educational pilot program to serve eligible
16	students described by Section 12.203, the commissioner, subject to
17	Subsection (b), may:
18	(1) on the basis of an application submitted, grant a
19	charter to an eligible entity for an open-enrollment charter school
20	under Subchapter D to provide the program;
21	(2) authorize an open-enrollment charter school to
22	provide the program; or
23	(3) authorize a campus or campus program that has been
24	granted a charter under Subchapter C to provide the program.

1	(b) To qualify for authorization under this subchapter, a
2	program must:
3	(1) serve students in grades 9 through 12 and have an
4	enrollment of which at least 50 percent of the students are 17 years
5	of age or older as of September 1 of the school year as reported for
6	the fall semester Public Education Information Management System
7	(PEIMS) submission; and
8	(2) meet the eligibility requirements for and register
9	under alternative education accountability procedures adopted by
10	the commissioner.

13	at least 14 years of age and under 26 years of age on September 1 of

2	(5) the student is currently on parole, probation,
3	deferred prosecution, deferred adjudication, or other conditional

5	(6) the student is currently in the custody or care of

8	year by a school official, officer of a juvenile court, or law
9	enforcement official;

ELIGIBILITY FOR DIPLOMA. (a) A student enrolled in a program under this subchapter may earn high school 9 course credits and receive a high school diploma if the student 10 successfully completes the curriculum requirements described under 11 12 Section 28.025. (b) The commissioner by rule shall establish 13 the requirements to demonstrate satisfactory completion of 14 the 15 program, including: 16 (1) successful completion of coursework to satisfy 17 curriculum requirements under the program; and (2) successful performance on an examination under 18 19 Section 28.023 to demonstrate mastery of the curriculum. Sec. 12.205. OPERATION OF PROGRAM. (a) 20 An entity authorized to operate a program under this subchapter shall create 21 an educational calendar and class schedule for the program's 22 operation that provides for flexibility in class scheduling and 23 24 student attendance. The commissioner shall approve reasonable exceptions to accommodate program scheduling and achieve the 25 26 program's purpose. 27 (b) An entity authorized to operate a program under this

H.B. No. 572 subchapter shall have an audit of the operations of the program, 1 including the financial operations, conducted at the entity's 2 3 expense. The audit must be conducted by an independent certified 4 public accountant. 5 (c) For purposes of conducting an audit under this section, the commissioner by rule shall establish requirements for verifying 6 7 course credits earned by program students. 8 Sec. 12.206. ACCOUNTABILITY. A program under this subchapter shall be evaluated under Section 39.0548 and as provided 9 10 by commissioner rule. Sec. 12.207. FUNDING. (a) An entity authorized to operate 11 12 a program under this subchapter is entitled to receive full state funding as provided by Section 12.106, provided that, for purposes 13 of this subchapter, the commissioner shall by rule determine a 14 15 method to calculate average daily attendance based on: (1) a student's successful completion of a number of 16 17 courses as determined by commissioner rule; and (2) a student's hours of contact time with the school. 18 19 (b) The method under Subsection (a) must provide for a proportionate reduction in funding if a student fails to 20 successfully complete the number of courses determined under 21 22 Subsection (a)(1). 23 (c) An entity authorized to operate a program under this 24 subchapter may receive additional funds appropriated by the legislature for: 25 26 (1) an intensive program of instruction to the same extent as a program under Section 28.0213; or 27

3	Sec. 12.208. PROGRAM REPORTING SYSTEM. (a) The
4	commissioner by rule shall develop:
5	(1) a system for each entity authorized to operate a
6	program under this subchapter to report information relating to the
7	program as directed by the commissioner; and
8	(2) to the extent practicable, a monthly funding
9	<u>schedule.</u>
10	(b) Before developing the system and schedule under
11	Subsection (a) and in an effort to best serve the interests and
12	needs of eligible students under this subchapter, the commissioner
13	shall solicit input from approved charter schools that currently
14	operate dropout recovery programs.

16	adopt rules necessary to implement and administer this subchapter.
17	(b) The commissioner may waive any requirement under this

current school year; has been expelled in accordance with Section (G) 37.007 during the preceding or current school year; (H) is currently on parole, probation, deferred prosecution, or other conditional release; was previously reported through the Public (I) Education Information Management System (PEIMS) to have dropped out of school; (J) is a student of limited English proficiency, as defined by Section 29.052; is in the custody or care of the Department of (K) Family and Protective Services or has, during the current school year, been referred to the department by a school official, officer of the juvenile court, or law enforcement official; (L) is homeless; (M) resided in the preceding school year or resides in the current school year in a residential placement facility in the district, including a detention facility, substance abuse treatment facility, emergency shelter, psychiatric hospital, halfway house, cottage home operation, specialized child-care home, or general residential operation; or (N) [(14)] has been incarcerated or has a parent or guardian who has been incarcerated, within the lifetime of the student, in a penal institution as defined by Section 1.07, Penal Code; or (2) regardless of the student's age, participates in an adult education program provided under a high school diploma and
