- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 843.209, Insurance Code, is amended to
- 6 read as follows:
- 7 Sec. 843.209. IDENTIFICATION CARD. (a) An identification
- 8 card or other similar document issued by a health maintenance
- 9 organization to an enrollee must:
- 10 (1) indicate that the health maintenance organization
- 11 is regulated under this code and subject to the provisions of
- 12 Subchapter J; [and]
- 13 (2) display:
- 14 (A) the first date on which the enrollee became
- 15 enrolled; or
- 16 (B) a toll-free number a physician or provider
- 17 may use to obtain that date; and
- 18 (3) display the acronym "HMO" in the location of the
- 19 health maintenance organization's choice.
- 20 (b) An identification card or other similar document that
- 21 bears the acronym "HMO" as required by Subsection (a) indicates
- 22 that health benefit coverage for health care services provided by a
- 23 participating physician or provider does not ensure the enrollee
- 24 has access to:

- 1 (1) health care services at a discounted rate if the
- 2 services are provided by a physician or provider who is not included
- 3 <u>in the health maintenance organization delivery network; or</u>
- 4 (2) other fee discounts available under the health
- 5 maintenance organization delivery network.
- 6 SECTION 2. Section 1301.162, Insurance Code, is amended to
- 7 read as follows:
- 8 Sec. 1301.162. IDENTIFICATION CARD. (a) An identification
- 9 card or other similar document issued by an insurer regulated by
- 10 this code and subject to this chapter to an individual insured must:
- 11 (1) display:
- (A) $\left[\frac{1}{1}\right]$ the first date on which the individual
- 13 became insured under the plan; or
- (B) $\left[\frac{(2)}{(2)}\right]$ a toll-free number a physician or
- 15 health care provider may use to obtain that date; and
- 16 (2) display the acronym "PPO" in the location of the
- 17 insurer's choice.
- 18 (b) An identification card or other similar document that
- 19 bears the acronym "PPO" as required by Subsection (a) indicates
- 20 that health benefit coverage for medical care or health care
- 21 services provided by a preferred provider does not ensure the
- 22 <u>insured has access to:</u>
- 23 <u>(1) medical care or health care services at a</u>
- 24 discounted rate if the services are provided by an out-of-network
- 25 provider; or
- 26 (2) other fee discounts available under the provider
- 27 network.

- 1 SECTION 3. Sections 843.209 and 1301.162, Insurance Code,
- 2 as amended by this Act, apply only to an identification card or
- 3 other similar document issued on or after January 1, 2022.
- SECTION 4. This Act takes effect September 1, 2021.
