2	relating to local option elections to legalize or prohibit the
3	operation of eight-liners; imposing fees; creating criminal
4	offenses; increasing criminal penalties.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Title 17, Election Code, is amended by adding
7	Chapter 502 to read as follows:
8	CHAPTER 502. LOCAL OPTION ELECTIONS ON OPERATION OF
9	EIGHT-LINERS
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 502.001. DEFINITION. In this chapter, "eight-liner"
12	has the meaning assigned by Section 47.01, Penal Code.
13	SUBCHAPTER B. MANNER OF CALLING ELECTION
14	Sec. 502.051. ELECTION BY PETITION. On proper petition by
15	the required number of voters of a county or of a justice precinct
16	or municipality in the county, the commissioners court of the
17	county shall order a local option election in the political
18	subdivision specified in the petition to legalize or prohibit the
19	operation of eight-liners in the political subdivision.
20	Sec. 502.052. QUALIFICATION FOR POLITICAL SUBDIVISION TO
21	HOLD ELECTION. A political subdivision must have been in existence
22	for at least 18 months before a local option election to legalize or
23	prohibit the operation of eight-liners in the political subdivision
24	may be held.

- 1 Sec. 502.053. APPLICATION FOR PETITION. (a) If 10 or more 2 qualified voters of any county or any justice precinct or 3 municipality within the county file with the county clerk a written application and provide proof of publication of notice in a 4 newspaper of general circulation in that political subdivision, the 5 county clerk shall issue to the applicants a petition to be 6 7 circulated among and signed by the qualified voters of the 8 political subdivision requesting that a local option election be called to determine whether to legalize or prohibit the operation 9 10 of eight-liners in the political subdivision.
- 11 (b) Not later than the fifth day after the date the petition 12 is issued, the county clerk shall notify the secretary of state of 13 the petition's issuance.

 LEGALIZE. (a) An application for a petition requesting an election

 to legalize the operation of eight-liners must include the heading:

 "Application for Local Option Election Petition to Legalize the

- (b) The application must contain the following statement of
 the issue to be voted on, immediately preceding the signatures of
 the applicants: "It is the purpose and intent of the applicants
 whose signatures appear on this application to legalize the
 operation of eight-liners in (name of political subdivision)."

 Sec. 502.055. CONTENTS OF APPLICATION FOR PETITION TO
- PROHIBIT. (a) An application for a petition requesting an election to prohibit the operation of eight-liners must include the heading:
- 27 "Application for Local Option Election Petition to Prohibit the

- 2 (b) The application must contain the following statement of
- 3 the issue to be voted on, immediately preceding the signatures of
- 4 the applicants: "It is the purpose and intent of the applicants
- 5 whose signatures appear on this application to prohibit the
- 6 operation of eight-liners in (name of political subdivision)."
- 7 <u>Sec. 502.056. PETITION REQUIREMENTS. A petition must</u>
- 8 include the date the petition is issued by the county clerk and be
- 9 serially numbered. Each page of the petition must bear the same
- 10 date and serial number and the actual seal of the county clerk
- 11 rather than a facsimile of that seal.
- 12 Sec. 502.057. HEADING AND STATEMENT ON PETITION TO
- 13 LEGALIZE. (a) Each page of the petition for a local option
- 14 election to legalize the operation of eight-liners must include the
- 15 <u>heading: "Petition for Local Option Election to Legalize the</u>
- 16 Operation of Eight-Liners."
- 17 (b) The petition must contain the following statement of the
- 18 <u>issue to be voted on, immediately preceding the signatures of the</u>
- 19 petitioners: "It is the purpose and intent of the petitioners whose
- 20 signatures appear on this petition to legalize the operation of
- 21 eight-liners in (name of political subdivision)."
- Sec. 502.058. HEADING AND STATEMENT ON PETITION TO
- 23 PROHIBIT. (a) Each page of the petition for a local option
- 24 election to prohibit the operation of eight-liners must include the
- 25 heading: "Petition for Local Option Election to Prohibit the
- 26 Operation of Eight-Liners."
- 27 (b) The petition must contain the following statement of the

- 1 issue to be voted on, immediately preceding the signatures of the
- 2 petitioners: "It is the purpose and intent of the petitioners whose
- 3 signatures appear on this petition to prohibit the operation of
- 4 eight-liners in (name of political subdivision)."
- 5 Sec. 502.059. OFFENSE: MISREPRESENTATION OF PETITION. (a)
- 6 A person commits an offense if the person misrepresents the purpose
- 7 or effect of a petition issued under this chapter.
- 8 (b) An offense under this section is a Class B misdemeanor.
- 9 Sec. 502.060. COPIES OF PETITION; RECORDS. (a) The county
- 10 clerk shall provide the number of copies of the petition required by
- 11 the applicants provided that number does not exceed one page for
- 12 every 10 registered voters of the county or of a justice precinct or
- 13 municipality in the county. Each copy must bear the date, number,
- 14 and seal on each page as required on the original petition.
- 15 (b) The county clerk shall keep a copy of each petition and a
- 16 record of the applicants for the petition.
- Sec. 502.061. VERIFICATION OF PETITION. (a) Except as
- 18 otherwise provided by Section 277.003, the voter registrar of the
- 19 county shall check the names of the signers of petitions and the
- 20 voting precincts in which the signers reside to determine whether
- 21 the signers were qualified voters of the county, justice precinct,
- 22 or municipality at the time the petition was issued. The registrar
- 23 shall certify to the commissioners court the number of qualified
- 24 voters signing the petition.
- 25 (b) A petition signature may not be counted unless:
- 26 (1) the signature is the actual signature of the
- 27 purported signer;

1	(2) the petition contains in addition to the
2	signature:
3	(A) the signer's printed name;
4	(B) the signer's date of birth;
5	(C) if the territory from which signatures must
6	be obtained is situated in more than one county, the county of
7	registration;
8	(D) the signer's residence address; and
9	(E) the date of signing; and
10	(3) the petition complies with any other applicable
11	requirements prescribed by law.
12	(c) The use of ditto marks or abbreviations does not
13	invalidate a signature if the required information is reasonably
14	ascertainable.
15	(d) The omission of the state from the signer's residence
16	address does not invalidate a signature unless the political
17	subdivision from which the signature is obtained is situated in
18	more than one state. The omission of the zip code from the address
19	does not invalidate a signature.
20	(e) The signature is the only entry on the petition that is
21	required to be in the signer's handwriting.
22	(f) A signer may withdraw the signer's signature by deleting
23	the signature from the petition or by filing with the voter
24	registrar an affidavit requesting that the signature be withdrawn
25	from the petition. A signer may not withdraw the signature from a
26	petition on or after the date the petition is received by the
27	registrar. A withdrawal affidavit filed by mail is considered to be

- 1 filed at the time of its receipt by the registrar. The withdrawal
- 2 of a signature nullifies the signature on the petition and places
- 3 the signer in the same position as if the signer had not signed the
- 4 petition.
- 5 Sec. 502.062. REQUIREMENTS TO ORDER ELECTION. (a) The
- 6 commissioners court, at its next regular session on or after the
- 7 30th day after the date a petition is filed, shall order a local
- 8 option election to be held on the issue set out in the petition that
- 9 complies with the requirements of Subsection (b).
- 10 (b) The petition must:
- 11 (1) be filed with the voter registrar not later than
- 12 the 60th day after the date the petition is issued; and
- 13 (2) bear the signatures of a number of qualified
- 14 voters of the political subdivision equal to at least 35 percent of
- 15 the registered voters of the subdivision who voted in the most
- 16 <u>recent gubernatorial election.</u>
- 17 (c) A voter whose name appears on the list of registered
- 18 voters with the notation "S," or a similar notation, shall be
- 19 excluded from the computation of the number of registered voters of
- 20 a particular territory.
- 21 Sec. 502.063. RECORD IN MINUTES. The commissioners court
- 22 shall enter in its minutes the date a petition is presented, the
- 23 names of the signers, and the action taken with respect to the
- 24 petition.
- Sec. 502.064. ISSUES TO APPEAR IN ORDER FOR ELECTION. (a)
- 26 The election order must state in its heading and text whether the
- 27 local option election to be held is for the purpose of legalizing or

- 1 prohibiting the operation of eight-liners as set out in the issue
- 2 recited in the application and petition.
- 3 (b) The order must state the issue to be voted on in the
- 4 election.
- 5 Sec. 502.065. BALLOT. The ballot in an election to legalize
- 6 or prohibit the operation of eight-liners shall be prepared to
- 7 permit voting for or against: "The legal operation of eight-liners
- 8 <u>in (name of political subdivision)."</u>
- 9 Sec. 502.066. EVIDENCE OF VALIDITY. The commissioners
- 10 court election order is prima facie evidence of compliance with all
- 11 provisions necessary to give the order validity or to give the
- 12 commissioners court jurisdiction to make the order valid.
- 13 Sec. 502.067. FREQUENCY OF ELECTIONS. A local option
- 14 election on a particular issue may not be held in a political
- 15 subdivision until after the first anniversary of the date of the
- 16 most recent local option election in that political subdivision on
- 17 that issue.
- 18 SUBCHAPTER C. HOLDING OF ELECTION
- 19 Sec. 502.101. APPLICABILITY OF ELECTION CODE. Except as
- 20 provided by this chapter, the officers holding a local option
- 21 election shall hold the election in the manner provided by this
- 22 code.
- Sec. 502.102. ELECTION PRECINCTS. (a) County election
- 24 precincts shall be used for a local option election to be held in an
- 25 entire county or in a justice precinct.
- 26 (b) Election precincts established by the governing body of
- 27 the municipality for its municipal elections shall be used for a

- 1 local option election to be held in a municipality. If the
- 2 governing body has not established precincts for its municipal
- 3 elections, the commissioners court of the county in which the
- 4 municipality is located shall prescribe the election precincts for
- 5 the local option election under the law governing establishment of
- 6 precincts for municipal elections.
- 7 <u>Sec. 502.103. ISSUE ON BALLOT. (a) The issue ordered to</u>
- 8 appear on the ballot for an election ordered by the commissioners
- 9 court must be the same as the issue applied for and set out in the
- 10 petition.
- 11 (b) The ballot must include the language required by Section
- 12 502.065.
- 13 Sec. 502.104. COUNTY PAYMENT OF ELECTION EXPENSES. The
- 14 county shall pay the expense of holding a local option election
- 15 <u>authorized by this chapter in the county or in a justice precinct or</u>
- 16 municipality in the county except that:
- 17 (1) if an election is to be held only within the
- 18 corporate limits of a municipality located wholly within the
- 19 county, the county may require the municipality to reimburse the
- 20 county for all or part of the expenses of holding the local option
- 21 <u>election;</u>
- (2) county payment of the expense of an election to
- 23 <u>legalize the operation of eight-liners is limited to the holding of</u>
- 24 one election in a political subdivision during a one-year period;
- 25 and
- 26 (3) county payment of the expense of an election to
- 27 prohibit the operation of eight-liners is limited to the holding of

- 1 one election in a political subdivision during a one-year period.
- 2 Sec. 502.105. DEPOSIT REQUIRED FOR CERTAIN ELECTIONS;
- 3 OFFENSE. (a) If a county is not required to pay the expense of a
- 4 local option election under Section 502.104, the county clerk shall
- 5 require the applicants for a petition for a local option election to
- 6 make a deposit before the issuance of the petition.
- 7 (b) The deposit must be in the form of a cashier's check in
- 8 an amount equal to 25 cents per voter listed on the current list of
- 9 registered voters residing in the county or in a justice precinct or
- 10 municipality in the county where the election is to be held.
- 11 (c) The money received shall be deposited in the county's
- 12 general fund. A refund may not be made to the applicants regardless
- 13 of whether the petition is returned to the county clerk or the
- 14 election is ordered.
- 15 (d) The county clerk may not issue a petition to the
- 16 applicants unless a deposit required by this chapter is made.
- 17 (e) A person who violates Subsection (d) commits an offense.
- 18 An offense under this subsection is a misdemeanor punishable by:
- 19 (1) a fine of not less than \$200 nor more than \$500;
- 20 (2) confinement in the county jail for not more than 30
- 21 <u>days; or</u>
- 22 (3) both the fine and confinement.
- 23 <u>Sec. 502.106. ELECTION IN CERTAIN MUNICIPALITIES.</u> (a)
- 24 This section applies only to an election to legalize or prohibit the
- 25 operation of eight-liners in a municipality located in more than
- 26 one county.
- 27 (b) An election to which this section applies shall be

- 1 conducted by the municipality instead of the counties. For the
- 2 purposes of an election conducted under this section, a reference
- 3 in this chapter to:
- 4 (1) the county is considered to refer to the
- 5 municipality;
- 6 (2) the commissioners court is considered to refer to
- 7 the governing body of the municipality;
- 8 (3) the county clerk or voter registrar is considered
- 9 to refer to the secretary of the municipality or, if the
- 10 municipality does not have a secretary, to the person performing
- 11 the functions of a secretary of the municipality; and
- 12 (4) the county judge is considered to refer to the
- 13 mayor of the municipality or, if the municipality does not have a
- 14 mayor, to the presiding officer of the governing body of the
- 15 municipality.
- 16 (c) The municipality shall pay the expense of the election.
- 17 (d) An action to contest the election under Section 502.155
- 18 may be brought in the district court of any county in which the
- 19 municipality is located.
- 20 SUBCHAPTER D. PROCEDURE FOLLOWING ELECTION
- 21 Sec. 502.151. DECLARATION OF RESULT. (a) On completing the
- 22 canvass of the election returns, the commissioners court shall
- 23 <u>issue an order declaring the election result</u>, and the clerk of the
- 24 commissioners court shall record the order as provided by law.
- 25 (b) In a legalization election, if a majority of the votes
- 26 cast favor legalizing the operation of eight-liners in the
- 27 political subdivision, the operation of eight-liners within the

- 1 boundaries of the political subdivision is legal on the entering of
- 2 the court's order. The legalization remains in effect until
- 3 changed by a subsequent local option election held under this
- 4 chapter.
- 5 (c) In a prohibitory election, if a majority of the votes
- 6 cast favor prohibiting the legal operation of eight-liners in the
- 7 political subdivision, the court's order must state that the
- 8 operation of eight-liners within the boundaries of the political
- 9 subdivision is prohibited effective on the 30th day after the date
- 10 the order is entered. The prohibition remains in effect until
- 11 changed by a subsequent local option election held under this
- 12 chapter.
- 13 (d) The local option status of a political subdivision does
- 14 not change as a result of the election if less than a majority of the
- 15 votes cast favor the issue.
- Sec. 502.152. ORDER PRIMA FACIE EVIDENCE. The order of the
- 17 commissioners court declaring an election result is prima facie
- 18 evidence that all provisions of law have been complied with in
- 19 giving notice of and holding the election, counting and returning
- 20 the votes, and declaring the result of the election.
- 21 Sec. 502.153. CERTIFICATION OF RESULT. Not later than the
- 22 third day after the date the result of a local option election has
- 23 been declared, the county clerk shall certify the result to the
- 24 secretary of state. The clerk may not charge a fee for this
- 25 service.
- Sec. 502.154. POSTING ORDER PROHIBITING OPERATION. (a) A
- 27 commissioners court order declaring the result of a local option

- 1 election and prohibiting the operation of eight-liners within the
- 2 boundaries of a political subdivision must be published by posting
- 3 the order at three public places in the political subdivision in
- 4 which the election was held.
- 5 (b) The county judge shall record the posting of the order
- 6 in the minutes of the commissioners court. The entry in the minutes
- 7 or a copy certified under the hand and seal of the county clerk is
- 8 prima facie evidence of the posting.
- 9 Sec. 502.155. ELECTION CONTEST. (a) The enforcement of
- 10 local option laws in the political subdivision in which an election
- 11 is being contested is not suspended during an election contest.
- 12 (b) The result of an election contest finally settles all
- 13 questions relating to the validity of that election. A person may
- 14 not call the legality of that election into question again in any
- 15 other suit or proceeding.
- (c) If an election contest is not timely instituted, it is
- 17 conclusively presumed that the election is valid and binding in all
- 18 respects on all courts.
- 19 SUBCHAPTER E. LOCAL OPTION STATUS; PRECINCT BOUNDARIES
- Sec. 502.201. LOCAL OPTION STATUS OF AREA. (a) In a
- 21 criminal prosecution, all trial courts of this state shall take
- 22 judicial notice of whether the operation of eight-liners is legal
- 23 <u>or prohibited in an area.</u>
- (b) In an information, complaint, or indictment, an
- 25 <u>allegation that the operation of eight-liners is prohibited in an</u>
- 26 area is sufficient, but a different status of the area may be urged
- 27 and proved as a defense.

- 1 Sec. 502.202. CHANGE OF STATUS. Except as provided in
- 2 Section 502.203, a political subdivision that has exercised or may
- 3 exercise the right of local option to legalize or prohibit the
- 4 operation of eight-liners retains the status adopted until that
- 5 status is changed by a subsequent local option election in the same
- 6 political subdivision.
- 7 Sec. 502.203. PREVAILING STATUS: RESOLUTION OF CONFLICTS.
- 8 To ensure that each voter has the maximum possible control over the
- 9 status of the operation of eight-liners in the area where the voter
- 10 <u>resides:</u>
- 11 (1) the status that resulted from or is the result of a
- 12 duly called election for a municipality prevails against the status
- 13 that resulted from or is the result of an election in the county in
- 14 which the municipality or any part of the municipality is located;
- 15 <u>and</u>
- 16 (2) the status that resulted from or is the result of
- 17 an election for a justice precinct prevails against the status that
- 18 resulted from or is the result of an election in a municipality in
- 19 which the justice precinct is wholly contained or in a county in
- 20 which the justice precinct is located.
- 21 Sec. 502.204. CHANGE IN PRECINCT BOUNDARIES. (a) When a
- 22 <u>local option status is in effect as the result of the vote in a</u>
- 23 justice precinct, the status shall remain in effect until the
- 24 status is changed as the result of a vote in the same territory that
- 25 constituted the precinct when the status was established. If the
- 26 boundaries of the justice precinct have changed since the status
- 27 was established, the commissioners court shall, for purposes of a

- 1 local option election, define the boundaries of the original
- 2 precinct. A local option election may be held within the territory
- 3 defined by the commissioners court as constituting the original
- 4 precinct.
- 5 <u>(b) Nothing in this section is intended to affect the</u>
- 6 operation of Section 502.203.
- 7 (c) Section 502.104, relating to the payment of local option
- 8 election expenses, applies to elections held in a territory that is
- 9 defined in accordance with Subsection (a) of this section.
- SECTION 2. Section 2153.002, Occupations Code, is amended
- 11 by amending Subdivisions (1), (5), (6), and (9) and adding
- 12 Subdivision (2-a) to read as follows:
- 13 "Coin-operated machine" means any kind of machine
- 14 or device operated by or with a coin or other United States
- 15 currency, metal slug, token, electronic card, or check, including a
- 16 music or skill or pleasure coin-operated machine. The term does not
- 17 <u>include an eight-liner.</u>
- 18 (2-a) "Eight-liner" has the meaning assigned by
- 19 Section 47.01, Penal Code.
- 20 (5) "Operator" means a person who exhibits or
- 21 displays, or permits to be exhibited or displayed, a coin-operated
- 22 machine or an eight-liner in this state in a place of business that
- 23 is not owned by the person.
- 24 (6) "Owner" means a person who owns a coin-operated
- 25 machine or an eight-liner in this state.
- 26 (9) "Skill or pleasure coin-operated machine" means
- 27 any kind of coin-operated machine that dispenses, or is used or is

- 1 capable of being used to dispense or afford, amusement, skill, or
- 2 pleasure or is operated for any purpose, other than for dispensing
- 3 only merchandise, music, or service. The term:
- 4 (A) includes a marble machine, marble table
- 5 machine, marble shooting machine, miniature racetrack machine,
- 6 miniature football machine, miniature golf machine, miniature
- 7 bowling machine, billiard or pool game, or machine or device that
- 8 dispenses merchandise or commodities or plays music in connection
- 9 with or in addition to dispensing skill or pleasure; and
- 10 (B) does not include an amusement machine
- 11 designed exclusively for a child or an eight-liner.
- 12 SECTION 3. Chapter 2153, Occupations Code, is amended by
- 13 adding Subchapter K to read as follows:
- 14 SUBCHAPTER K. FEE ON EIGHT-LINERS
- Sec. 2153.501. IMPOSITION OF FEE. (a) A fee is imposed on
- 16 <u>each eight-liner that an owner exhibits or displays, or permits to</u>
- 17 be exhibited or displayed, in this state.
- 18 (b) The amount of the fee is \$350 per year.
- 19 Sec. 2153.502. EXEMPTION. The fee imposed under this
- 20 subchapter does not apply to an owner of an eight-liner if the owner
- 21 possesses the eight-liner for resale only.
- Sec. 2153.503. PRORATED FEE. The fee on an eight-liner
- 23 first exhibited or displayed in this state after March 31 of any
- 24 year is one-fourth of the amount imposed under Section 2153.501 for
- 25 <u>each quarter or partial quarter of the calendar year remaining</u>
- 26 after the date the owner first exhibits or displays the
- 27 eight-liner.

1 Sec. 2153.504. COLLECTION. (a) The comptroller shall 2 collect the fee. 3 (b) In collecting the fee, the comptroller may: 4 (1) collect the fee on a quarterly basis; (2) 5 establish procedures for quarterly collection of the fee; and 6 7 (3) establish dates on which the fee payment is due. 8 An owner required to pay a fee under this section shall pay the fee to the comptroller by cashier's check, money order, or 9 10 any other method authorized by the comptroller. Sec. 2153.505. ALLOCATION OF REVENUE. (a) Notwithstanding 11 12 Section 2153.058, the comptroller shall: (1) deposit 30 percent of each fee collected under 13 14 this subchapter to the credit of the general revenue fund; and 15 (2) remit 70 percent of the fee collected under this 16 subchapter to: 17 (A) the municipality for an eight-liner located 18 in the municipality; or 19 (B) the county for an eight-liner located outside 20 a municipality. 21 (b) The comptroller shall remit fee revenue to a 22 municipality or county under this section as soon as feasible after 23 collecting the fee. 24 Sec. 2153.506. REFUND OR CREDIT PROHIBITED. comptroller may not refund or assign credit for the fee imposed 25

under this subchapter to an owner who ceases to exhibit or display

an eight-liner before the end of the calendar year for which the fee

- 2 Sec. 2153.507. FEE PERMIT. (a) The comptroller shall issue
- 3 <u>a fee permit to an owner who pays the fee.</u>
- 4 (b) The comptroller may issue a duplicate fee permit to an
- 5 owner if the owner's fee permit is lost, stolen, or destroyed. The
- 6 fee for a duplicate permit is \$5.
- 7 (c) A fee permit shall be securely attached to the
- 8 eight-liner for which the permit is issued in a manner that requires
- 9 the continued application of steam and water to remove the permit.
- Sec. 2153.508. DISCIPLINARY AUTHORITY. The comptroller
- 11 may:
- 12 (1) conduct an investigation of a violation of this
- 13 subchapter or a ruled adopted under this subchapter; and
- 14 (2) impose sanctions in accordance with Subchapter G
- 15 and penalties in accordance with Subchapter H on a person who
- 16 violates this subchapter or a rule adopted under this subchapter as
- 17 if the person held a license or registration certificate issued
- 18 under this chapter.
- 19 Sec. 2153.509. APPLICABILITY OF TAX CODE. Subtitle B,
- 20 Title 2, Tax Code, applies to the administration, collection, and
- 21 enforcement of taxes, penalties, and interest under this
- 22 subchapter.
- 23 SECTION 4. Section 234.131, Local Government Code, is
- 24 amended by amending Subdivisions (1), (2), and (3) and adding
- 25 Subdivision (1-a) to read as follows:
- 26 (1) "Amusement redemption machine" means a bona fide
- 27 amusement device as defined by Section 47.01, Penal Code, operated
