5	SECTION 1. Subchapter E, Chapter 508, Government Code, is
6	amended by adding Section 508.1471 to read as follows:
7	Sec. 508.1471. RELEASE TO MANDATORY SUPERVISION OF CERTAIN
8	INMATES CONFINED IN COUNTY JAIL. (a) This section applies only to
9	an inmate who, at the time the inmate is sentenced to a term of
10	imprisonment in the department, is:
11	(1) confined in a county jail; and
12	(2) eligible for immediate release to mandatory
13	supervision.
14	(b) Before an inmate is released from a county jail to
15	mandatory supervision, the department shall provide notice to a
16	victim, guardian of a victim, or close relative of a deceased victim
17	that the inmate is eligible for release to mandatory supervision.
18	The notice must be sent to the address provided in the victim impact
19	statement or submitted under Section 508.117(b) and must state that
20	the victim, guardian, or close relative may submit, not later than
21	the 14th day after the date of the notice, a written statement to
22	the parole panel considering the inmate's release regarding:
23	(1) the offense;
24	(2) the inmate; and

1 (3) the effect of the offense on the victim, guardian, 2 or close relative. (c) Notwithstanding any other law, the parole panel may 3 4 interview a victim, guardian of a victim, or close relative of a deceased victim regarding the release of the inmate to mandatory 5 supervision. 6 (d) In this section, "victim," "guardian of a victim," and 7 "close relative of a deceased victim" have the meanings assigned by 8 Section 508.117. 9 SECTION 2. The change in law made by this Act applies to a 10 defendant who is sentenced for an offense on or after the effective 11 date of this Act, regardless of whether the offense is committed 12 before, on, or after that date. 13
