- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. This Act may be cited as Jace's Law.
- 6 SECTION 2. Section 29.153(b), Education Code, is amended to
- 7 read as follows:
- 8 (b) A child is eligible for enrollment in a prekindergarten
- 9 class under this section if the child is at least three years of age
- 10 and:
- 11 (1) is unable to speak and comprehend the English
- 12 language;
- 13 (2) is educationally disadvantaged;
- 14 (3) is homeless, regardless of the residence of the
- 15 child, of either parent of the child, or of the child's guardian or
- 16 other person having lawful control of the child;
- 17 (4) is the child of an active duty member of the armed
- 18 forces of the United States, including the state military forces or
- 19 a reserve component of the armed forces, who is ordered to active
- 20 duty by proper authority;
- 21 (5) is the child of a member of the armed forces of the
- 22 United States, including the state military forces or a reserve
- 23 component of the armed forces, who was injured or killed while
- 24 serving on active duty;

- 1 (6) is or ever has been in:
- 2 (A) the conservatorship of the Department of
- 3 Family and Protective Services following an adversary hearing held
- 4 as provided by Section 262.201, Family Code; or
- 5 (B) foster care in another state or territory, if
- 6 the child resides in this state; or
- 7 (7) is the child of a person eligible for the Star of
- 8 Texas Award as:
- 9 (A) a peace officer under Section 3106.002,
- 10 Government Code;
- 11 (B) a firefighter under Section 3106.003,
- 12 Government Code; or
- 13 (C) an emergency medical first responder under
- 14 Section 3106.004, Government Code.
- SECTION 3. This Act applies beginning with the 2021-2022
- 16 school year.
- 17 SECTION 4. This Act takes effect immediately if it receives
- 18 a vote of two-thirds of all the members elected to each house, as
- 19 provided by Section 39, Article III, Texas Constitution. If this
- 20 Act does not receive the vote necessary for immediate effect, this
- 21 Act takes effect September 1, 2021.
