A voter eligible for early voting by mail under this chapter shall 1 receive a runoff election ballot at the same time and in the same 2 3 manner as the voter's general election ballot. 4 (b) The secretary of state shall prescribe procedures to 5 provide for a runoff election ballot issued to a voter under this chapter to use a preferential voting system. The system must allow 6 7 a voter to rank each candidate through a numerical designation from the candidate the voter favors most to the candidate the voter 8 favors least. 9 (c) If a runoff election for any office voted by the voter 10 occurs, the carrier envelope containing the voter's runoff election 11 12 ballot shall be opened and the ballot shall be counted. The voter's vote in the election is assigned to the runoff candidate whom the 13 14 voter assigned the highest favorable ranking on the runoff election 15 ballot under Subsection (b). 16 (d) The secretary of state shall create detailed 17 instructions on the use of a preferential voting system and provide the instructions to each county clerk.
