4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle B, Title 2, Health and Safety Code, is
6	amended by adding Chapter 53 to read as follows:
7	CHAPTER 53. BONE MARROW DONOR RECRUITMENT PROGRAM
8	Sec. 53.001. ESTABLISHMENT OF PROGRAM. (a) The department
9	shall establish a bone marrow donor recruitment program to educate
10	residents of this state about:
11	(1) the need for bone marrow donors, including the
12	particular need for donors from minority populations;
13	(2) the requirements for registering with the
14	federally authorized bone marrow donor registry established and
15	maintained as required by 42 U.S.C. Section 274k as a potential bone
16	marrow donor, including procedures for determining an individual's
17	tissue type;
18	(3) the medical procedures an individual must undergo
19	to donate bone marrow or other sources of blood stem cells; and
20	(4) the availability of information about bone marrow
21	donation in health care facilities, blood banks, and driver's
22	license offices.
23	(b) The department, in consultation with the federally
24	authorized hone marrow donor registry established and maintained as

required by 42 U.S.C. Section 274k and the registry's interested 1 contracted network partners, shall develop written and electronic 2 informational materials, including links to Internet websites and 3 machine-readable codes, regarding: 4 5 (1) bone marrow donation; and 6 (2) the process of registering with the federally 7 authorized bone marrow donor registry. (c) The federally authorized bone marrow donor registry, in 8 collaboration with the registry's interested contracted network 9 partners, may develop and provide the informational materials 10 described by Subsection (b) to the department. 11 12 (d) The department and the Department of Public Safety shall post the information described by Subsection (b) on each agency's 13 14 respective Internet websites. 15 (e) Appropriate health care facilities, blood banks, and driver's license offices may access the informational materials 16 17 described by Subsection (b) on the Internet websites of the department and the Department of Public Safety and print the 18 19 materials to place in their facilities, banks, or offices to provide to residents of this state. 20 21

SECTION 2. As soon as practicable after the effective date of this Act, the Department of State Health Services shall establish the program and obtain the informational materials as required by Section 53.001, Health and Safety Code, as added by this Act.
