A BILL TO BE ENTITLED 1 AN ACT 2 relating to covered benefits under the child health plan. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 62.151, Health and Safety Code, is 4 5 amended by amending Subsection (c) and adding Subsections (g) and (h) to read as follows: 6 7 (c) In modifying the plan, the executive commissioner, except as provided by Subsection (g), shall ensure that primary and 8 9 preventive health benefits do not include reproductive services, other than prenatal care and care related to diseases, illnesses, 10 11 or abnormalities related to the reproductive system. 12 (g) Subject to Subsection (h), the child health plan must provide as covered benefits prescription contraceptive drugs, 13 14 supplies, or devices approved by the United States Food and Drug Administration. The child health plan may not provide coverage for 15 16 abortifacients or any other drug or device that terminates a 17 pregnancy. (h) The child health plan may provide as covered benefits 18 prescription contraceptive drugs, supplies, or devices for an 19 enrolled child younger than 18 years of age for the purpose of 20 primary and preventive reproductive health care only if the 21 prescribing or dispensing health care provider receives written 22 23 consent from the enrolled child's parent, guardian, or managing conservator, or from the enrolled child or other adult if 24

1 <u>authorized under Sections 32.001 or 32.003</u>, Family Code, for the 2 <u>prescription or dispensing of the contraceptive drug</u>, supply, or 3 <u>device</u>.

SECTION 2. If before implementing any provision of this Act a state agency determines that a waiver or authorization from a federal agency is necessary for implementation of that provision, the agency affected by the provision shall request the waiver or authorization and may delay implementing that provision until the waiver or authorization is granted.

10 SECTION 3. This Act takes effect immediately if it receives 11 a vote of two-thirds of all the members elected to each house, as 12 provided by Section 39, Article III, Texas Constitution. If this 13 Act does not receive the vote necessary for immediate effect, this 14 Act takes effect September 1, 2021.
