A BILL TO BE ENTITLED 1 AN ACT 2 relating to placement on community supervision of a defendant convicted of certain felony possession offenses under the Texas 3 Controlled Substances Act; changing eligibility for and conditions 4 5 of community supervision. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 6 SECTION 1. Article 42A.053, Code of Criminal Procedure, is 7 amended by adding Subsection (h) to read as follows: 8 9 (h) Notwithstanding any other provision of this article, for an offense for which the suspension of the imposition of the 10 sentence occurs automatically under Article 42A.582, the maximum 11 12 period of community supervision is three years and the minimum period of community supervision is 90 days. 13 14 SECTION 2. Article 42A.056, Code of Criminal Procedure, is amended to read as follows: 15 Art. 42A.056. LIMITATION ON JURY-RECOMMENDED 16 COMMUNITY SUPERVISION. A defendant is not eligible for community supervision 17 under Article 42A.055 if the defendant: 18 (1) is sentenced to a term of imprisonment that 19 20 exceeds 10 years; 21 (2) is convicted of <u>an offense</u> [a state jail felony] 22 for which suspension of the imposition of the sentence occurs 23 automatically under Article 42A.551 or 42A.582; (3) is adjudged guilty of an offense under Section 24

1 19.02, Penal Code;

2 (4) is convicted of an offense under Section 21.11,
3 22.011, or 22.021, Penal Code, if the victim of the offense was
4 younger than 14 years of age at the time the offense was committed;

5 (5) is convicted of an offense under Section 20.04,6 Penal Code, if:

7 (A) the victim of the offense was younger than 148 years of age at the time the offense was committed; and

9 (B) the actor committed the offense with the 10 intent to violate or abuse the victim sexually;

11 (6) is convicted of an offense under Section 20A.02,
12 20A.03, 43.04, 43.05, or 43.25, Penal Code; or

PLACEMENT ON COMMUNITY SUPERVISION; EXECUTION OF SENTENCE. (a) Except as otherwise provided by 25 26 Subsection (b), on conviction of an offense described by Article 42A.581, the judge shall suspend the imposition of the sentence and 27

2 (b) The judge may order the sentence to be executed if the 3 defendant has been previously convicted three or more times of an offense described by Article 42A.581, regardless of whether the 4 5 previous verdict was set aside or the defendant was permitted to withdraw the defendant's plea in the manner provided by Article 6 7 42A.701. 8 Art. 42A.583. CONDITIONS OF COMMUNITY SUPERVISION. (a) Notwithstanding Article 42A.301 and subject to Subsection (b), the 9 10 judge may impose only the following conditions on a defendant placed on community supervision under this subchapter: 11 12 (1) substance abuse treatment conditions that are consistent with standards adopted by the Texas Board of Criminal 13 14 Justice under Section 509.015, Government Code; and 15 (2) conditions imposed under Articles 42A.301(a) and 16 (b) that are consistent with the results of: 17 (A) a risk and needs assessment conducted under Article 42A.301(a); or 18 19 (B) an evaluation conducted under Article 20 42A.301(c). 21 (b) A judge may not impose substance abuse treatment conditions under this article if the results of the evaluation 22 conducted under Article 42A.301(c) indicate that the defendant is 23 24 not in need of treatment to address a drug or alcohol dependency. Art. 42A.584. DISMISSAL. (a) After successful completion 25 26 of a term of community supervision imposed under this subchapter, 27 including completion of any required course of treatment in a drug

of this Act, the defendant, if adjudged guilty, shall be assessed the punishment under Subchapter L-1, Chapter 42A, Code of Criminal Procedure, as added by this Act, if the offense is an offense described by Article 42A.581, Code of Criminal Procedure, as added by this Act, and the defendant meets the eligibility requirements under that subchapter and other law and so elects by written motion filed with the trial court before the sentencing hearing begins.

8 (b) If the defendant does not make the election under 9 Subsection (a) of this section, punishment is governed by the law in 10 effect on the date the offense was committed, and the former law is 11 continued in effect for that purpose.

SECTION 8. This Act takes effect September 1, 2021.
