- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 191.009(a), Local Government Code, is 7 amended to read as follows:
- 8 (a) A county clerk may accept electronic documents and other
- 9 instruments by electronic filing and record the electronic
- 10 documents and other instruments electronically if:
- 11 (1) the electronic documents or instruments do not
- 12 convey title to or an interest in real property; and
- 13 (2) the filing or recording complies with the rules
- 14 adopted by the Texas State Library and Archives Commission under
- 15 Chapter 195.
- SECTION 2. Section 195.002(b), Local Government Code, is
- 17 amended to read as follows:
- 18 (b) The rules must provide for:
- 19 (1) the electronic filing with and recording by the
- 20 county clerk of:
- 21 (A) real property records, other than records
- 22 conveying title to or an interest in real property; and
- 23 (B) except for records maintained under Section
- 24 192.006, other instruments filed with and recorded by the county

- 1 clerk as determined by the commission;
- 2 (2) the means by which an electronic document or other
- 3 instrument may be electronically transmitted to a county clerk for
- 4 filing;
- 5 (3) the means by which a county clerk may
- 6 electronically record an electronic document or other instrument
- 7 filed electronically;
- 8 (4) requiring that the means adopted under Subdivision
- 9 (2) or (3) be generally available, nonproprietary technology; and
- 10 (5) security standards to prevent the filing and
- 11 recording of fraudulent electronic documents or other instruments
- 12 or alteration of electronic documents or other instruments that
- 13 were previously filed and recorded electronically.
- 14 SECTION 3. Chapter 15, Property Code, is amended by adding
- 15 Section 15.0025 to read as follows:
- Sec. 15.0025. APPLICABILITY. This chapter does not apply
- 17 to a document that conveys title to or an interest in real property.
- SECTION 4. (a) Section 191.009(a), Local Government Code,
- 19 as amended by this Act, and Section 15.0025, Property Code, as added
- 20 by this Act, apply only to a document filed for recording on or
- 21 after January 1, 2022.
- 22 (b) Not later than November 1, 2021, the Texas State Library
- 23 and Archives Commission shall adopt rules necessary to implement
- 24 Section 195.002(b), Local Government Code, as amended by this Act,
- and Section 15.0025, Property Code, as added by this Act.
- SECTION 5. This Act takes effect September 1, 2021.
