## A BILL TO BE ENTITLED

AN ACT

- 2 relating to the electronic filing with and the recording by county
- 3 clerks of records conveying or purporting to convey title to or an
- 4 interest in real property.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 191.009(a), Local Government Code, is
- 7 amended to read as follows:
- 8 (a) A county clerk may accept electronic documents and other
- 9 instruments by electronic filing and record the electronic
- 10 documents and other instruments electronically if:
- 11 (1) the electronic documents or instruments do not
- 12 convey or purport to convey title to or an interest in real
- 13 property; and

- 14 (2) the filing or recording complies with the rules
- 15 adopted by the Texas State Library and Archives Commission under
- 16 Chapter 195.
- 17 SECTION 2. Section 195.002(b), Local Government Code, is
- 18 amended to read as follows:
- 19 (b) The rules must provide for:
- 20 (1) the electronic filing with and recording by the
- 21 county clerk of:
- 22 (A) real property records, other than records
- 23 conveying or purporting to convey title to or an interest in real
- 24 property; and

- 1 (B) except for records maintained under Section
- 2 192.006, other instruments filed with and recorded by the county
- 3 clerk as determined by the commission;
- 4 (2) the means by which an electronic document or other
- 5 instrument may be electronically transmitted to a county clerk for
- 6 filing;
- 7 (3) the means by which a county clerk may
- 8 electronically record an electronic document or other instrument
- 9 filed electronically;
- 10 (4) requiring that the means adopted under Subdivision
- 11 (2) or (3) be generally available, nonproprietary technology; and
- 12 (5) security standards to prevent the filing and
- 13 recording of fraudulent electronic documents or other instruments
- 14 or alteration of electronic documents or other instruments that
- 15 were previously filed and recorded electronically.
- 16 SECTION 3. Chapter 15, Property Code, is amended by adding
- 17 Section 15.0025 to read as follows:
- 18 Sec. 15.0025. APPLICABILITY. This chapter does not apply
- 19 to a document that conveys or purports to convey title to or an
- 20 interest in real property.
- SECTION 4. (a) Section 191.009(a), Local Government Code,
- 22 as amended by this Act, and Section 15.0025, Property Code, as added
- 23 by this Act, apply only to a document filed for recording on or
- 24 after January 1, 2022.
- 25 (b) Not later than November 1, 2021, the Texas State Library
- 26 and Archives Commission shall adopt rules necessary to implement
- 27 Section 195.002(b), Local Government Code, as amended by this Act,

- 1 and Section 15.0025, Property Code, as added by this Act.
- 2 SECTION 5. This Act takes effect September 1, 2021.
