A BILL TO BE ENTITLED

AN ACT

- 2 relating to the inclusion of suicide prevention information on
- 3 certain student identification cards issued by a public school or
- 4 public institution of higher education.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Subchapter G, Chapter 38, Education Code, is
- 7 amended by adding Section 38.353 to read as follows:
- 8 Sec. 38.353. SUICIDE PREVENTION INFORMATION REQUIRED ON
- 9 CERTAIN STUDENT IDENTIFICATION CARDS. Each student identification
- 10 card issued by a public school to a student in grade six or higher:
- 11 (1) must have printed on the card the contact
- 12 <u>information for:</u>
- 13 (A) the National Suicide Prevention Lifeline;
- 14 and

- 15 (B) the Crisis Text Line; and
- 16 (2) may have printed on the card the contact
- 17 information for a local suicide prevention hotline, if available.
- 18 SECTION 2. Subchapter Z, Chapter 51, Education Code, is
- 19 amended by adding Section 51.91941 to read as follows:
- 20 Sec. 51.91941. SUICIDE PREVENTION INFORMATION REQUIRED ON
- 21 STUDENT IDENTIFICATION CARD. (a) In this section, "institution of
- 22 higher education" has the meaning assigned by Section 61.003.
- 23 (b) Each student identification card issued by an
- 24 institution of higher education:

- 1 (1) must have printed on the card the contact
- 2 information for:
- 3 (A) the National Suicide Prevention Lifeline;
- 4 and
- 5 (B) the Crisis Text Line; and
- 6 (2) may have printed on the card the contact
- 7 <u>information for:</u>
- 8 (A) the campus police department or security for
- 9 the campus at which the student to whom the card is issued regularly
- 10 attends classes or, if the campus does not have a campus police
- 11 department or security, a local nonemergency police contact;
- 12 (B) the campus health clinic for the campus at
- 13 which the student to whom the card is issued regularly attends
- 14 classes or, if the campus does not have a health clinic, a local
- 15 health clinic; and
- 16 <u>(C) a local suicide prevention hotline, if</u>
- 17 available.
- SECTION 3. Sections 38.353 and 51.91941, Education Code, as
- 19 added by this Act, apply only to a student identification card
- 20 issued on or after the effective date of this Act.
- 21 SECTION 4. This Act takes effect immediately if it receives
- 22 a vote of two-thirds of all the members elected to each house, as
- 23 provided by Section 39, Article III, Texas Constitution. If this
- 24 Act does not receive the vote necessary for immediate effect, this
- 25 Act takes effect September 1, 2021.
