## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the expiration date of driver's licenses and renewal
3	driver's licenses issued to noncitizens.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter M, Chapter 521, Transportation Code,
6	is amended by adding Section 521.2712 to read as follows:
7	Sec. 521.2712. EXPIRATION OF NONCITIZEN LICENSE AND
8	RENEWAL. (a) Except as provided by Subsection (b), each original
9	driver's license issued to an applicant who is not a citizen and
10	each renewal of those licenses expires on the earliest of:
11	(1) the first anniversary of the date of issuance or
12	renewal, as applicable;
13	(2) the expiration date of the applicant's or license
14	holder's lawful presence in the United States as determined by the
15	appropriate United States agency in compliance with federal law, if
16	there is a definite expiration date for the applicant's or license
17	holder's authorized stay in the United States; or
18	(3) another date applicable under this subchapter,
19	including the date of a court order under Section 521.271(a)(4).
20	(b) Each original provisional or learner license issued to a
21	person who is not a citizen and each renewal of those licenses

expires on the earliest of:

(1) the first anniversary of the date of issuance or

- 7 SECTION 2. Sections 521.271(a) and (b), Transportation
- 8 Code, are amended to read as follows:

- 11 license, provisional license, learner license, or occupational
- 12 driver's license [issued to an applicant who is a citizen,
- 13 national, or legal permanent resident of the United States or a
- 14 refugee or asylee lawfully admitted into the United States] expires
- 15 as follows:
- (1) [except as provided by Section 521.2711,] a
- 17 driver's license expires on the first birthday of the license
- 18 holder occurring after the eighth anniversary of the date of the

- 20 (2) a provisional license expires on the 18th birthday
- 21 of the license holder;
- 22 (3) a learner license expires on the 18th birthday of

- 24 (4) an occupational driver's license expires on the

- 26 (5) unless an earlier date is otherwise provided, a

- 4 (b) Except as otherwise provided by this subchapter,
- 5 including Sections [Section] 521.2711 and 521.2712, a driver's
- 6 license that is renewed expires on the earlier of:
- 7 (1) the eighth anniversary of the expiration date
- 8 before renewal if the applicant is a citizen, national, or legal
- 9 permanent resident of the United States or a refugee or asylee
- 10 lawfully admitted into the United States;
- 11 [(1-a) for an applicant not described by Subdivision

- 3 SECTION 4. The following provisions of the Transportation
- 4 Code are repealed:
- 5 (1) Sections 521.271(a-2), (a-3), and (a-4); and
- 6 (2) Section 521.2711(c).
- 7 SECTION 5. The changes in law made by this Act apply only to
- 8 a driver's license issued or renewed on or after June 1, 2022. A
- 9 driver's license issued or renewed before June 1, 2022, is governed
- 10 by the law in effect immediately before the effective date of this
- 11 Act, and the former law is continued in effect for that purpose.
- 12 SECTION 6. This Act takes effect September 1, 2021.
