6	SECTION 1. Subchapter D, Chapter 33, Education Code, is
7	amended by adding Section 33.0832 to read as follows:
8	Sec. 33.0832. PARTICIPATION IN UNIVERSITY INTERSCHOLASTIC
9	LEAGUE ACTIVITIES BY STUDENTS RECEIVING OUTPATIENT MENTAL HEALTH
10	SERVICES. (a) This section applies to a student who:
11	(1) receives outpatient mental health services from a
12	mental health facility, as defined by Section 571.003, Health and
13	Safety Code; and
14	(2) is enrolled in a school district or
15	open-enrollment charter school or otherwise receives public
16	education services from a district or school.
17	(b) The University Interscholastic League shall ensure that
18	league rules do not exclude from eligibility for participation in a
19	league activity a student to whom this section applies based solely
20	on the criteria described in Subsection (a)(1).
21	(c) A school district or open-enrollment charter school may
22	not adopt or enforce policies that restrict participation in
23	University Interscholastic League activities by a student to whom

1	(1) the criteria described in Subsection (a)(1); or
2	(2) the student's absence during instructional time
3	while receiving outpatient mental health services as described by
4	Subsection (a)(1).
5	(d) This section does not exempt a student to whom this
6	section applies from any eligibility requirement for participation
7	in University Interscholastic League activities other than an
8	eligibility requirement based solely on the criteria described in
9	Subsection (a)(1).
10	SECTION 2. As soon as practicable after the effective date
11	of this Act:
12	(1) the University Interscholastic League shall
13	propose or amend rules as necessary to comply with Section 33.0832,
14	Education Code, as added by this Act; and
15	(2) a school district or open-enrollment charter
16	school shall propose or amend policies as necessary to comply with
17	Section 33.0832, Education Code, as added by this Act.
18	SECTION 3. This Act takes effect immediately if it receives
19	a vote of two-thirds of all the members elected to each house, as
