H.B. No. 1082

A BILL TO BE ENTITLED

1 AN ACT  
2 relating to the availability of personal information of an elected  
3 public officer.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 552.117(a), Government Code, as  
6 reenacted and amended by Chapters 367 (H.B. 1351), 633 (S.B. 1494),  
7 1146 (H.B. 2910), 1213 (S.B. 662), and 1245 (H.B. 2446), Acts of the  
8 86th Legislature, Regular Session, 2019, is reenacted and amended  
9 to read as follows:

10 (a) Information is excepted from the requirements of  
11 Section 552.021 if it is information that relates to the home  
12 address, home telephone number, emergency contact information, or  
13 social security number of the following person or that reveals  
14 whether the person has family members:

15 (1) a current or former official or employee of a  
16 governmental body, except as otherwise provided by Section 552.024;

17 (2) a peace officer as defined by Article 2.12, Code of  
18 Criminal Procedure, or a security officer commissioned under  
19 Section 51.212, Education Code, regardless of whether the officer  
20 complies with Section 552.024 or 552.1175, as applicable;

21 (3) a current or former employee of the Texas  
22 Department of Criminal Justice or of the predecessor in function of  
23 the department or any division of the department, regardless of  
24 whether the current or former employee complies with Section

1 552.1175;

2 (4) a peace officer as defined by Article 2.12, Code of  
3 Criminal Procedure, or other law, a reserve law enforcement  
4 officer, a commissioned deputy game warden, or a corrections  
5 officer in a municipal, county, or state penal institution in this  
6 state who was killed in the line of duty, regardless of whether the  
7 deceased complied with Section 552.024 or 552.1175;

8 (5) a commissioned security officer as defined by  
9 Section 1702.002, Occupations Code, regardless of whether the  
10 officer complies with Section 552.024 or 552.1175, as applicable;

11 (6) an officer or employee of a community supervision  
12 and corrections department established under Chapter 76 who  
13 performs a duty described by Section 76.004(b), regardless of  
14 whether the officer or employee complies with Section 552.024 or  
15 552.1175;

16 (7) a current or former employee of the office of the  
17 attorney general who is or was assigned to a division of that office  
18 the duties of which involve law enforcement, regardless of whether  
19 the current or former employee complies with Section 552.024 or  
20 552.1175;

21 (8) a current or former employee of the Texas Juvenile  
22 Justice Department or of the predecessors in function of the  
23 department, regardless of whether the current or former employee  
24 complies with Section 552.024 or 552.1175;

25 (9) a current or former juvenile probation or  
26 supervision officer certified by the Texas Juvenile Justice  
27 Department, or the predecessors in function of the department,

1 under Title 12, Human Resources Code, regardless of whether the  
2 current or former officer complies with Section 552.024 or  
3 552.1175;

4 (10) a current or former employee of a juvenile  
5 justice program or facility, as those terms are defined by Section  
6 261.405, Family Code, regardless of whether the current or former  
7 employee complies with Section 552.024 or 552.1175;

8 (11) a current or former member of the United States  
9 Army, Navy, Air Force, Coast Guard, or Marine Corps, an auxiliary  
10 service of one of those branches of the armed forces, or the Texas  
11 military forces, as that term is defined by Section 437.001;

12 (12) a current or former district attorney, criminal  
13 district attorney, or county or municipal attorney whose  
14 jurisdiction includes any criminal law or child protective services  
15 matters, regardless of whether the current or former attorney  
16 complies with Section 552.024 or 552.1175;

17 (13) a current or former employee of a district  
18 attorney, criminal district attorney, or county or municipal  
19 attorney whose jurisdiction includes any criminal law or child  
20 protective services matters, regardless of whether the current or  
21 former employee complies with Section 552.024 or 552.1175;

22 (14) a current or former employee of the Texas Civil  
23 Commitment Office or of the predecessor in function of the office or  
24 a division of the office, regardless of whether the current or  
25 former employee complies with Section 552.024 or 552.1175; [~~or~~]

26 (15) a current or former federal judge or state judge,  
27 as those terms are defined by Section 1.005, Election Code, or a

1 spouse of a current or former federal judge or state judge;

2 (16) a current or former child protective services  
3 caseworker, adult protective services caseworker, or investigator  
4 for the Department of Family and Protective Services, regardless of  
5 whether the caseworker or investigator complies with Section  
6 552.024 or 552.1175, or a current or former employee of a department  
7 contractor performing child protective services caseworker, adult  
8 protective services caseworker, or investigator functions for the  
9 contractor on behalf of the department; ~~or~~

10 (17) an elected public [~~(16) a state~~] officer [~~elected~~  
11 ~~statewide or a member of the legislature~~], regardless of whether  
12 the officer [~~or member~~] complies with Section 552.024 or 552.1175;

13 (18) [~~(16)~~] a current or former United States attorney  
14 or assistant United States attorney and the spouse or child of the  
15 attorney; or

16 (19) [~~(16)~~] a firefighter or volunteer firefighter or  
17 emergency medical services personnel as defined by Section 773.003,  
18 Health and Safety Code, regardless of whether the firefighter or  
19 volunteer firefighter or emergency medical services personnel  
20 comply with Section 552.024 or 552.1175, as applicable.

21 SECTION 2. Section 552.1175(a), Government Code, as amended  
22 by Chapters 367 (H.B. 1351), 633 (S.B. 1494), 1146 (H.B. 2910), 1213  
23 (S.B. 662), and 1245 (H.B. 2446), Acts of the 86th Legislature,  
24 Regular Session, 2019, is reenacted and amended to read as follows:

25 (a) This section applies only to:

26 (1) peace officers as defined by Article 2.12, Code of  
27 Criminal Procedure, or special investigators as described by

1 Article 2.122, Code of Criminal Procedure;

2 (2) county jailers as defined by Section 1701.001,  
3 Occupations Code;

4 (3) current or former employees of the Texas  
5 Department of Criminal Justice or of the predecessor in function of  
6 the department or any division of the department;

7 (4) commissioned security officers as defined by  
8 Section 1702.002, Occupations Code;

9 (5) a current or former district attorney, criminal  
10 district attorney, or county or municipal attorney whose  
11 jurisdiction includes any criminal law or child protective services  
12 matters;

13 (5-a) a current or former employee of a district  
14 attorney, criminal district attorney, or county or municipal  
15 attorney whose jurisdiction includes any criminal law or child  
16 protective services matters;

17 (6) officers and employees of a community supervision  
18 and corrections department established under Chapter 76 who perform  
19 a duty described by Section 76.004(b);

20 (7) criminal investigators of the United States as  
21 described by Article 2.122(a), Code of Criminal Procedure;

22 (8) police officers and inspectors of the United  
23 States Federal Protective Service;

24 (9) current and former employees of the office of the  
25 attorney general who are or were assigned to a division of that  
26 office the duties of which involve law enforcement;

27 (10) current or former juvenile probation and

1 detention officers certified by the Texas Juvenile Justice  
2 Department, or the predecessors in function of the department,  
3 under Title 12, Human Resources Code;

4 (11) current or former employees of a juvenile justice  
5 program or facility, as those terms are defined by Section 261.405,  
6 Family Code;

7 (12) current or former employees of the Texas Juvenile  
8 Justice Department or the predecessors in function of the  
9 department;

10 (13) federal judges and state judges as defined by  
11 Section 1.005, Election Code;

12 (14) current or former employees of the Texas Civil  
13 Commitment Office or of the predecessor in function of the office or  
14 a division of the office; ~~and~~

15 (15) a current or former member of the United States  
16 Army, Navy, Air Force, Coast Guard, or Marine Corps, an auxiliary  
17 service of one of those branches of the armed forces, or the Texas  
18 military forces, as that term is defined by Section 437.001;

5           SECTION 3. Section 25.025(a), Tax Code, as amended by  
6 Chapters 467 (H.B. 4170), 469 (H.B. 4173), 633 (S.B. 1494), 1213  
7 (S.B. 662), and 1245 (H.B. 2446), Acts of the 86th Legislature,  
8 Regular Session, 2019, is reenacted and amended to read as follows:

9           (a) This section applies only to:

10           (1) a current or former peace officer as defined by  
11 Article 2.12, Code of Criminal Procedure, and the spouse or  
12 surviving spouse of the peace officer;

13           (2) the adult child of a current peace officer as  
14 defined by Article 2.12, Code of Criminal Procedure;

15           (3) a county jailer as defined by Section 1701.001,  
16 Occupations Code;

17           (4) an employee of the Texas Department of Criminal  
18 Justice;

19           (5) a commissioned security officer as defined by  
20 Section 1702.002, Occupations Code;

21           (6) an individual who shows that the individual, the  
22 individual's child, or another person in the individual's household  
23 is a victim of family violence as defined by Section 71.004, Family  
24 Code, by providing:

25           (A) a copy of a protective order issued under  
26 Chapter 85, Family Code, or a magistrate's order for emergency  
27 protection issued under Article 17.292, Code of Criminal Procedure;

2 (B) other independent documentary evidence  
3 necessary to show that the individual, the individual's child, or  
4 another person in the individual's household is a victim of family  
5 violence;

6 (7) an individual who shows that the individual, the  
7 individual's child, or another person in the individual's household  
8 is a victim of sexual assault or abuse, stalking, or trafficking of  
9 persons by providing:

10 (A) a copy of a protective order issued under  
11 Subchapter A or B, Chapter 7B, Code of Criminal Procedure, or a  
12 magistrate's order for emergency protection issued under Article  
13 17.292, Code of Criminal Procedure; or

14 (B) other independent documentary evidence  
15 necessary to show that the individual, the individual's child, or  
16 another person in the individual's household is a victim of sexual  
17 assault or abuse, stalking, or trafficking of persons;

18 (8) a participant in the address confidentiality  
19 program administered by the attorney general under Subchapter B,  
20 Chapter 58, Code of Criminal Procedure, who provides proof of  
21 certification under Article 58.059, Code of Criminal Procedure;

22 (9) a federal judge, a state judge, or the spouse of a  
23 federal judge or state judge;

24 (10) a current or former district attorney, criminal  
25 district attorney, or county or municipal attorney whose  
26 jurisdiction includes any criminal law or child protective services  
27 matters;



1           (11) a current or former employee of a district  
2 attorney, criminal district attorney, or county or municipal  
3 attorney whose jurisdiction includes any criminal law or child  
4 protective services matters;

5           (12) an officer or employee of a community supervision  
6 and corrections department established under Chapter 76,  
7 Government Code, who performs a duty described by Section 76.004(b)  
8 of that code;

9           (13) a criminal investigator of the United States as  
10 described by Article 2.122(a), Code of Criminal Procedure;

11           (14) a police officer or inspector of the United  
12 States Federal Protective Service;

13           (15) a current or former United States attorney or  
14 assistant United States attorney and the spouse and child of the  
15 attorney;

16           (16) a current or former employee of the office of the  
17 attorney general who is or was assigned to a division of that office  
18 the duties of which involve law enforcement;

19           (17) a medical examiner or person who performs  
20 forensic analysis or testing who is employed by this state or one or  
21 more political subdivisions of this state;

22           (18) a current or former member of the United States  
23 armed forces who has served in an area that the president of the  
24 United States by executive order designates for purposes of 26  
25 U.S.C. Section 112 as an area in which armed forces of the United  
26 States are or have engaged in combat;

27           (19) a current or former employee of the Texas

1 Juvenile Justice Department or of the predecessors in function of  
2 the department;

3 (20) a current or former juvenile probation or  
4 supervision officer certified by the Texas Juvenile Justice  
5 Department, or the predecessors in function of the department,  
6 under Title 12, Human Resources Code;

7 (21) a current or former employee of a juvenile  
8 justice program or facility, as those terms are defined by Section  
9 [261.405](#), Family Code;

10 (22) a current or former employee of the Texas Civil  
11 Commitment Office or the predecessor in function of the office or a  
12 division of the office; ~~and~~

13 (23) a current or former employee of a federal judge or  
14 state judge;

15 (24) a current or former child protective services  
16 caseworker, adult protective services caseworker, or investigator  
17 for the Department of Family and Protective Services or a current or  
18 former employee of a department contractor performing child  
19 protective services caseworker, adult protective services  
20 caseworker, or investigator functions for the contractor on behalf  
21 of the department; ~~and~~

22 (25) an elected public ~~[(24) a state]~~ officer; and  
23 ~~[elected statewide or a member of the legislature]~~

24 (26) [(24)] a firefighter or volunteer firefighter or  
25 emergency medical services personnel as defined by Section [773.003](#),  
26 Health and Safety Code.

27 SECTION 4. The changes in law made by this Act to Sections

1 552.117 and 552.1175, Government Code, and Section 25.025, Tax  
2 Code, apply only to a request for information that is received by a  
3 governmental body or an officer on or after the effective date of  
4 this Act. A request for information that was received before the  
5 effective date of this Act is governed by the law in effect on the  
6 date the request was received, and the former law is continued in  
7 effect for that purpose.

8 SECTION 5. To the extent of any conflict, this Act prevails  
9 over another Act of the 87th Legislature, Regular Session, 2021,  
10 relating to nonsubstantive additions to and corrections in enacted  
11 codes.

12 SECTION 6. This Act takes effect immediately if it receives  
13 a vote of two-thirds of all the members elected to each house, as  
14 provided by Section 39, Article III, Texas Constitution. If this  
15 Act does not receive the vote necessary for immediate effect, this  
16 Act takes effect September 1, 2021.
