## A BILL TO BE ENTITLED

1	AN ACT
2	relating to persons permitted to be in a polling place or a place
3	where ballots are being counted.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 61.001, Election Code, is amended by
6	amending Subsection (a) and adding Subsection (a-1) to read as
7	follows:
8	(a) Except as permitted by this code and as described by
9	Subsection (a-1), a person may not be in the polling place from the
10	time the presiding judge arrives there on election day to make the
11	preliminary arrangements until the precinct returns have been
12	certified and the election records have been assembled for
13	distribution following the election.
14	(a-1) Under this code, a person may be lawfully present in a
15	polling place during the time described by Subsection (a) if the
16	<pre>person is:</pre>
17	(1) an election judge or clerk;
18	(2) a watcher;
19	(3) a state or federal inspector;
20	(4) a person admitted to vote;
21	(5) a child under 18 years of age who is accompanying a
22	<pre>parent who has been admitted to vote;</pre>
23	(6) a person providing assistance to a voter under
24	Section 61.032 or 64.032;

- 1 (7) a special peace officer appointed by the presiding
- 2 judge under Section 32.075;
- 3 (8) the county chair of a political party conducting a
- 4 primary election, as authorized by Section 172.1113;
- 5 (9) a voting system technician, as authorized by
- 6 Section 125.010; or
- 7 (10) a person whose presence has been authorized by
- 8 the presiding judge in accordance with this code.
- 9 SECTION 2. Section 87.026, Election Code, is amended to
- 10 read as follows:
- 11 Sec. 87.026. BYSTANDERS EXCLUDED. (a) Except as permitted
- 12 by this code and as described by Subsection (b), a person may not be
- 13 in the meeting place of an early voting ballot board during the time
- 14 of the board's operations.
- (b) Under this code, a person may be lawfully present in the
- 16 meeting place of an early voting ballot board during the time of the
- 17 board's operations if the person is:
- 18 (1) a presiding judge or member of the board;
- 19 (2) a watcher;
- 20 (3) a voting system technician, as authorized by
- 21 <u>Section 125.010; or</u>
- 22 (4) a person whose presence has been authorized by the
- 23 presiding judge in accordance with this code.
- SECTION 3. Subchapter A, Chapter 127, Election Code, is
- 25 amended by adding Section 127.008 to read as follows:
- Sec. 127.008. BYSTANDERS EXCLUDED. (a) Except as permitted
- 27 by this code and as described by Subsection (b), a person may not be

- 1 <u>in a central counting station while ballots are being counted.</u>
- 2 (b) Under this code, a person may be lawfully present in the
- 3 central counting station while ballots are being counted if the
- 4 person is:
- 5 (1) a counting station manager, tabulation
- 6 supervisor, assistant to the tabulation supervisor, presiding
- 7 judge, or clerk;
- 8 (2) a watcher;
- 9 (3) a voting system technician, as authorized by
- 10 Section 125.010; or
- 11 (4) a person whose presence has been authorized by the
- 12 counting station manager in accordance with this code.
- SECTION 4. This Act takes effect immediately if it receives
- 14 a vote of two-thirds of all the members elected to each house, as
- 15 provided by Section 39, Article III, Texas Constitution. If this
- 16 Act does not receive the vote necessary for immediate effect, this
- 17 Act takes effect September 1, 2021.
