6 (C) bigamy under Section 25.01, Penal Code, if 7 the investigation of the offense shows that the person, other than 8 the legal spouse of the defendant, whom the defendant marries or 9 purports to marry or with whom the defendant lives under the 10 appearance of being married is younger than 18 years of age at the 11 time the offense is committed; or

12 (7) two years from the date the offense was 13 discovered: sexual assault punishable as a state jail felony under 14 Section 22.011(f)(2), Penal Code; or

15 (8) three years from the date of the commission of the16 offense: all other felonies.

SECTION 2. Article 12.01, Code of Criminal Procedure, as amended by this Act, does not apply to an offense if the prosecution of that offense becomes barred by limitation before the effective date of this Act. The prosecution of that offense remains barred as if this Act had not taken effect.
