(a) Sections 301.021, 301.023, 301.024, and 301.025 do [Subchapter B 8 9 does] not apply to: (1) the sale or rental of a single-family house sold or 10 11 rented by the owner if: 12 (A) the owner does not: (i) own more than 13 three single-family houses at any one time; or 14 (ii) own any interest in, nor is there owned 15 or reserved on the person's behalf, under any express or voluntary 16 agreement, title to or any right to any part of the proceeds from 17 the sale or rental of more than three single-family houses at any 18 one time; and 19 (B) the house is sold or rented without: 20 21 (i) the use of the sales or rental 22 facilities or services of a broker, agent, or salesperson licensed 23 under Chapter 1101, Occupations Code, or of an employee or agent of a licensed broker, agent, or salesperson, or the facilities or 24

1 services of any person in the business of selling or renting a
2 dwelling [the owner of a dwelling designed or intended for
3 occupancy by five or more families]; or

4 (ii) the publication, posting, or mailing 5 of a notice, statement, or advertisement prohibited by Section 6 301.022; or

7 (2) the sale or rental of the rooms or units in a 8 dwelling containing living quarters occupied by or intended to be 9 occupied by not more than four families living independently of 10 each other, if the owner maintains and occupies one of the living 11 quarters as the owner's residence.

(b) The exemption in Subsection (a)(1) applies only to one sale [or rental] in a 24-month period if the owner was not the most recent resident of the house at the time of the sale [or rental].

(c) Subsection (a) does not prohibit the use of attorneys,
 escrow agents, abstractors, title companies, and other
 professional assistants necessary to transfer title.

18 (d) For purposes of Subsection (a), a person is in the 19 business of selling or renting a dwelling if:

20 <u>(1) the person has, within the preceding year,</u> 21 participated as the seller or landlord in three or more 22 transactions involving the sale or rental of a dwelling or any 23 <u>interest in a dwelling;</u>

24 (2) the person has, within the preceding year, 25 participated in two or more transactions, other than transactions 26 involving the person's own dwelling, as an agent providing sales or 27 rental facilities or services involving the sale or rental of a

1 dwelling or any interest in a dwelling; or

- 2 (3) the person is the owner of a dwelling designed or
- 3 intended for occupancy by, or that is occupied by, five or more
- 4 families.
- 5 SECTION 2. This Act takes effect September 1, 2021.
