- 2 relating to a state employment preference for certain individuals
- 3 who reside with veterans with a disability.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 657.002, Government Code, is amended to
- 6 read as follows:
- 7 Sec. 657.002. INDIVIDUALS QUALIFIED FOR VETERAN'S
- 8 EMPLOYMENT PREFERENCE. The following individuals qualify for a
- 9 veteran's employment preference:
- 10 (1) a veteran, including a veteran with a disability;
- 11 (2) a veteran's surviving spouse who has not
- 12 remarried; [and]
- 13 (3) an orphan of a veteran if the veteran was killed
- 14 while on active duty; and
- 15 (4) an individual who resides in a household with a
- 16 veteran if the individual is the primary source of income for the
- 17 household and the veteran:
- 18 (A) has a total disability rating based either on
- 19 having a service-connected disability with a disability rating of
- 20 100 percent or on individual unemployability; and
- 21 (B) is receiving Supplemental Security Income
- 22 (SSI) benefits under 42 U.S.C. Section 1381 et seq. or Social
- 23 Security Disability Insurance (SSDI) benefits under 42 U.S.C.
- 24 Section 401 et seq.

- 1 SECTION 2. Section 657.003(b), Government Code, is amended
- 2 to read as follows:
- 3 (b) A state agency shall provide to an individual entitled
- 4 to a veteran's employment preference for employment or appointment
- 5 over other applicants for the same position who do not have a
- 6 greater qualification a veteran's employment preference, in the
- 7 following order of priority:
- 8 (1) a veteran with a disability;
- 9 (2) a veteran;
- 10 (3) a veteran's surviving spouse who has not
- 11 remarried; [and]
- 12 (4) an orphan of a veteran if the veteran was killed
- 13 while on active duty; and
- 14 (5) an individual who resides with a veteran with a
- 15 disability as described by Section 657.002(4) if the individual is
- 16 the primary source of income for the veteran's household.
- SECTION 3. Section 657.005(b), Government Code, is amended
- 18 to read as follows:
- 19 (b) An applicant who is either a veteran with a disability
- 20 as described by Section 657.002(4) or an individual who resides
- 21 with a veteran with a disability as described by Section 657.002(4)
- 22 <u>if the individual is the primary source of income for the veteran's</u>
- 23 <u>household</u> shall furnish the official records to the individual
- 24 whose duty is to fill the position.
- 25 SECTION 4. The changes in law made by this Act apply only to
- 26 an open position with a state agency for which the state agency
- 27 begins accepting applications on or after the effective date of

- 1 this Act. An open position with a state agency for which the state
- 2 agency begins accepting applications before the effective date of
- 3 this Act is governed by the law in effect on the date the state
- 4 agency began accepting applications, and the former law is
- 5 continued in effect for that purpose.
- 6 SECTION 5. This Act takes effect September 1, 2021.
