7	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
8	SECTION 1. Subchapter K, Chapter 2306, Government Code, is
9	amended by adding Section 2306.2582 to read as follows:
10	Sec. 2306.2582. HOMELESS "TEXT-TO-DONATE" PILOT PROGRAM.
11	(a) The department may implement and administer a pilot program to
12	solicit donations made by text message for the benefit of local
13	programs that provide services to homeless individuals and families
14	in municipalities with a population of 285,000 or more. If
15	<pre>implemented, the program shall:</pre>
16	(1) facilitate the process by which a person may use
17	text messaging to make a private donation to help homeless
18	individuals and families;
19	(2) encourage private donations to be made for the
20	benefit of local programs that prevent and eliminate homelessness;
21	<u>and</u>
22	(3) fund local programs that provide emergency housing

(b) The department may adopt rules to govern the

and transportation to homeless individuals and families.

1	implementation and administration of the program, including rules
2	that:
3	(1) provide for the designation of a
4	telecommunications carrier and text messaging service used for the
5	program;
6	(2) facilitate the acquisition of a statewide phone
7	number and donation code;
8	(3) provide the ability for an individual to make a
9	donation by text message in an amount chosen by the individual, to
10	charge the donation to the individual's phone bill or credit card,
11	and to select the municipality that will benefit from the donation;
12	(4) protect the confidentiality of donor information;
13	(5) establish a fund in the department to receive and
14	disburse money under the program;
15	(6) facilitate the coordination with municipalities
16	for the disbursement of money received under the program;
17	(7) establish qualifications for local organizations
18	to request and receive donations made through the program; and
19	(8) facilitate the promotion of the program to the
20	general public including the placement of signage in areas of a
21	municipality that may be impacted by large populations of homeless
22	persons.
23	(c) Of the money donated under the program, the department
24	<pre>shall allocate:</pre>
25	(1) not less than 65 percent for costs associated with
26	housing homeless individuals and families;

(2) not less than 20 percent for transportation costs;

- 1 (3) not less than five percent for the promotion of the
- 2 program; and
- 3 (4) not more than 10 percent for overhead and
- 4 administrative costs.
- 5 (d) The department may assign personnel to coordinate the
- 6 administration and implementation of the program.
- 7 SECTION 2. This Act takes effect September 1, 2021.
