## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the sale of certain food by food service
3	establishments.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 437, Health and Safety Code, is amended
6	by adding Section 437.026 to read as follows:
7	Sec. 437.026. SALE OF CERTAIN FOOD BY FOOD SERVICE
8	ESTABLISHMENT. (a) Except as provided by Subsection (b), a food
9	service establishment that holds a permit under this chapter may
10	sell directly to an individual consumer food, other than prepared
11	food, that:
12	(1) is in its original condition or original packaging
13	as received by the establishment;
14	(2) is labeled, which may include a handwritten label,
15	with the name and source of the food and the date the food is sold;
16	(3) for meat or poultry, bears an official mark of
17	inspection from the department or the United States Department of
18	<u>Agriculture;</u>
19	(4) for a meat product or poultry product, is obtained
20	from a source that is appropriately inspected and bears an official
21	mark of inspection described by Subdivision (3);
22	(5) for a time and temperature control for safety food
23	as defined by Section 437.0196, does not exceed the shelf life
24	displayed on the food's packaging; and

1	(6) for food requiring refrigeration other than
2	produce, is:
3	(A) maintained at or below 41 degrees Fahrenheit
4	until the establishment sells or donates the food; and
5	(B) protected from contamination.
6	(b) A food service establishment described by Subsection
7	(a) may not sell directly to an individual consumer food that is:
8	(1) in a package exhibiting damage or that is not
9	labeled with the manufacturer's original labeling; or
10	(2) distressed because the food:
11	(A) has been subjected to fire, flooding,
12	excessive heat, smoke, radiation, or another environmental
13	<pre>contamination;</pre>
14	(B) is not held at the correct temperature for
15	the food type; or
16	(C) is stored for a prolonged period.
17	SECTION 2. As soon as practicable after the effective date
18	of this Act, the executive commissioner of the Health and Human
19	Services Commission shall adopt rules to implement Section 437.026,
20	Health and Safety Code, as added by this Act.
21	SECTION 3. Section 437.026, Health and Safety Code, as
22	added by this Act, applies only to the sale of food by a food service
23	establishment that occurs on or after the effective date of this
24	Act. The sale of food by a food service establishment that occurs
25	before the effective date of this Act is governed by the law in
26	effect on the date the sale occurred, and the former law is
27	continued in effect for that purpose.

1 SECTION 4. This Act takes effect September 1, 2021.
